- 4. We are helping our first call pastors lean into their leadership and nurture their God-given gifts as they discover the joys and opportunities of their first call experiences. This includes helping them out financially as they seek to reduce their educational debt that they bring into that first call.

Finally, I want to thank you for electing me as your bishop. Thus far, I have felt the full support of this synod as I visit congregations from week to week. The days of the election itself, along with the installation in September, have both been two of the most meaningful and life changing experiences of my life and your support is a significant part of it I have fully enjoyed visiting each congregation and look forward to seeing yours over the course of my six year tenure. Yes, I realize it will take four years to get to them all, but the way the time has been flying, it won't be long!

Please know that your synod staff are here for you and want to accompany you on your journey of faith. We will continue to pray for us all in our lives together to make sure that our relationship with you is supported and upheld in prayer, in both the joys and struggles of ministry. We want our relationships to be intentional and strong so that you never feel isolated in this work. We are grateful for your partnership in the gospel!

# Congregational Meeting Minutes Trinity Lutheran Church Annual Meeting February 4, 2024

**Call To Order:** President Kevin Brown called the meeting to order at 10:40 am. The meeting was held in the church worship center. A quorum was reached with more than 76 voting members present.

**Opening Prayer:** Pastor Patrick Patterson provided an opening prayer.

**Approval of Minutes:** President Kevin Brown presented the minutes from the February 5, 2023 Annual Meeting. A motion was made, seconded, and approved to accept the minutes as presented.

**Financial Report for 2023:** Treasurer Craig Olsen reported that Trinity ended 2023 with \$24,932 income over expenses. Due to the change in the fiscal year, this surplus will carry over into 2024. The year end will be closed on June 30, 2024. A motion was made, seconded, and approved to accept the 2023 Financial Report.

**Proposed 2024 Budget:** Treasurer Craig Olsen presented two budgets. The first budget is from 1/1/2024 through the end of the new fiscal year, 6/30/2024. This six-month budget is essentially flat. Staff salaries would increase 3.8% but that increase is offset by cost savings, including combining Director of Youth with the Director of Children and Family. The second budget covers 7/1/24 - 6/30/25 and does not include any increases. A motion was made, seconded, and approved to accept both budgets as presented.

**Election of the 2024 Congregation Council:** President Kevin Brown presented the following names from the Nominating Committee for three-year terms: Lynn Buske, Robin Drout, Mary Schoenknecht, Jacqueline Strayer, Michelle Zumwalt. Robin Drout and Michelle Zumwalt would be returning to the council after their one-year term filling vacancies. Mary Schoenknecht and Jacqueline Strayer would be returning to the council after their first three-year term. Lynn Buske is starting her first three-year term. There were no additional nominees from the floor. A motion was made, seconded, and approved to accept these five members to the Congregation Council.

**Election to the 2024 Nominating Committee:** President Brown presented two candidates for the nominating committee: Tony Benedict and Kristi Trunkel. Marti Hofer, Kristin Walukas, and Tom Sandager were nominated from the floor. No other nominees were presented. A motion was made, seconded, and approved to accept these five people for the Nominating Committee. One more member will be needed when the nominating committee begins their work in May 2025.

**Election to the Endowment Trust Board of Trustees:** President Brown presented three candidates for three-year terms on the Endowment Trust Board: Jeff Hartman, Peggy Larson, and Kris Pressler. Jeff Hartman and Peggy Larson will be returning to the Endowment Trust Board for their second three-year term. Kris Pressler would be starting her first three-year term. No other nominees were presented. A motion was made, seconded, and approved to accept these three candidates to the Endowment Trust Board.

**Election to the Personnel Committee:** President Brown presented one candidate for a three-year term on the Personnel Committee: David Tackman. David Tackmann will be returning to the Personnel Committee for a second three-year term. No other nominees were presented. A motion was made, seconded, and approved to accept David Tackman to the Personnel Committee.

#### **Reports from Pastors:**

Pastor Patrick Patterson read "Oscar Romero's Prayer" by Ken Untener to remind us to step back and look at the long view of what we are working to do as a church. He noted that he has been at Trinity Lutheran for almost five years. So much has happened as we have grown together before, during and after Covid. We are working on our Vision Plan, emphasizing the need to come together in small groups. We are also exploring the possibility of opening a day care at Trinity. There is also a small task force looking at the future of the rental homes that adjoin the Trinity property.

Pastor Tom Westcott compared the Trinity congregation to seed planting, where we are growing together in the Vision process. He is working with the Live and Listen committees. The Live committee has scheduled fun events to help connect members outside of worship. The Listen committee helps direct worship and education. He also noted that Heather Day is now the head of Youth Ministry as well as Children and Families.

**New Business:** There was no new business on the agenda to discuss.

A congregation member asked about whether the Scholarship Singers for the Senior Choir could possibly be included in the budget as they have added so much to the choirs. Also, it would be nice to schedule the senior choir to sing occasionally at the 9:45 service and for the children's choirs to sing at the 8:15 service.

Heather Day noted that it has been ten years since the congregation voted to become a Reconciling in Christ congregation.

Closing Prayer: Pastor Tom led a closing prayer.

Adjournment: President Kevin Brown adjourned the annual meeting at 11:10 am.

# Special Congregational Meeting Minutes Adoption of Revised Constitution November 10, 2024

**Call to order:** Kevin Brown, President of the Congregation, called the meeting to order at 10:30 am.

**Affirmation of Quorum:** 48 church members were present, eight more than needed for a quorum.

**Opening Prayer:** Pastor Tom Wescott provided an opening prayer.

**Purpose of Special Congregational Meeting:** President Kevin Brown announced that the purpose of the meeting was to adopt the revised constitution and to amend the date of the annual meeting.

Robin Drout, a member of the Trinity Church Council, discussed the proposed changes to the constitution. The Northwest Synod of Wisconsin has proposed two rounds of constitutional language changes for area churches since Trinity Lutheran last updated their constitution in 2018. Most of the language changes are minor. The most substantive change proposed is the definition of the word "Ex Officio." Trinity has used this word to mean a committee member, often the senior pastor, who can give input (voice) but does not have a vote. The Synod proposed to define the word "Ex Officio" to mean voice *and* vote. At this time, Trinity is affirming our current definition as voice but not vote. A copy of the red-lined constitution is attached to these minutes to document the other minor changes.

In addition, Trinity is changing from a calendar year for administrative and budgeting purposes to a July 1 – June 30 fiscal year. In the current By-Laws of the constitution, the Annual Meeting is scheduled for a January or February date, so this congregational meeting will vote to change the Annual Meeting date to July or August.

No other business may be conducted during this Special Congregational Meeting.

Motion to change the By-Laws to reflect the new fiscal year and change the Annual Meeting to July or August: Motion made by Christine Brown, seconded by Becky Drout. No discussion. Approved by unanimous voice vote.

Motion made to amend the constitution language and affirm the term Ex Officio: Motion made by Michelle Zumwalt, seconded by Phyllis Grohn.

Clarifying question: What will the term Ex Officio mean with the constitution vote? It continues to mean that an Ex Officio member has a voice but not a vote.

No other discussion. Approved by unanimous voice vote.

Note: The By-Laws change (Annual Meeting change) will happen immediately. The Constitution changes will need to be ratified at the next Annual Meeting in July or August 2025.

Closing Prayer: Pastor Patrick Patterson provided a closing prayer.

**Motion to adjourn:** Motion made by Arla Prestin, seconded by Jacque Strayer. **Adjournment:** President Kevin Brown adjourned the meeting at 10:42 am.

# Special Congregational Meeting Minutes Loan for Rental Property Repairs June 15, 2025

Call to Order: Kevin Brown, Congregation President, called the meeting to order at 10:55 am

**Affirmation of Quorum:** 57 congregation members were present, 17 more than needed for a quorum.

**Opening Prayer:** Pastor Tom Westcott provided an opening prayer.

**Presentation:** The purpose of the meeting is to vote on a proposal to take out a loan to fund necessary repairs to the church's rental property at 1402 E. Lexington Blvd. Pastor Tom presented information of the property and the proposed repairs.

**The Property:** The property was purchased by the church in 2000. The purpose was to rent and utilize the land if the church needed to expand. The most recent renters lived in the home for 22 years. They vacated the property in early June to move closer to family.

**Recent Activity:** In 2024 a subcommittee of the Council reviewed our ownership of this property and recommended that we continue to rent the property and keep it for potential future use. The rent we were charging for this home was under market value and we have been slowly increasing the rent to move it closer to market value. Recently the upstairs bathroom was repaired and remodeled.

Why Now: There are needed repairs to the property that are best accomplished while there are no renters to displace. The updates to the property will allow us to continue to have a positive reputation with renters. The property is in a desirable neighborhood (Manz).

**Specific Needs:** Photos of the needed repairs were shown. They included the kitchen, lower bathroom, carpet and paint, and front steps.

**Financial Picture:** The dedicated account for the rental property has a current balance of \$14,600. All rent money goes into this account. No annual budget (general fund) money is budgeted for this property. The rental property is intended to pay for itself.

**Loan Option:** We are still in the process of gathering estimates and bids for the needed work, but have several preliminary estimates. A loan of up to \$50,000 from Nicolet Bank is proposed. Interest rate is anticipated to be 6.5%. Amortized over 7 years, a monthly loan payment of \$744.78 would be required. Collateral for the loan would be a CD account the church currently holds at Nicolet Bank.

**How We Pay Off the Loan:** Previous rent for the property was \$984 per month. This was scheduled to be increased to \$1200 without any updates to the property. The intent is to have the loan amount absorbed by the new renter. Therefore, a new rent amount of \$1700 to \$1800 per month is anticipated. With the Eau Claire rental market for a four bedroom house being approximately \$1127 to \$2500, this would place our rental at about the midpoint of this range.

**Discussion:** The meeting was opened up to questions and discussion:

**Question:** What specific estimates have been obtained for the work? Answer: Pastor Tom indicated that we have some preliminary estimates, but are still obtaining detailed estimates. The \$50,000 loan requested is a not to exceed amount. It is likely that the Council will authorize its existing rental property subcommittee to review and approve the specific work and costs.

**Question:** Why not just sell the house? Answer: Pastor Tom referred to the recommendation made by the Council's rental property subcommittee to continue to hold this property and then re-evaluate this decision in a few years. Discussion of a sale is outside the announced scope of this special meeting.

**Vote:** A motion was made by Jim Urness, seconded by Mark Hofer, to take a loan up to \$50,000 from Nicolet Bank for the purposes of renovating the rental house. The vote on the motion was 50 yes, 7 no. Therefore, the necessary two-thirds approval was received.

**Closing Prayer:** Pastor Tom provided a closing prayer.

**Adjournment:** The meeting was adjourned at 11:15 a.m.

#### **Lead Pastor**

God said, "Go out and stand on the mountain before the LORD, for the LORD is about to pass by." Now there was a great wind, so strong that it was splitting mountains and breaking rocks in pieces before the LORD, but the LORD was not in the wind; and after the wind an earth-quake, but the LORD was not in the earthquake; <sup>12</sup> and after the earthquake a fire, but the LORD was not in the fire; and after the fire a sound of sheer silence. <sup>13</sup> When Elijah heard it, he wrapped his face in his mantle and went out and stood at the entrance of the cave. Then there came a voice to him that said. "What are you doing here, Elijah?" 1 Kings 19:11-14

Sometimes it's in the sheer silence that we encounter God most clearly. That was certainly true for Elijah, and I know that is typically the case for me as well. My sabbatical this summer will likely provide numerous opportunities for me to experience God's presence in deep and meaningful ways. I hope to return in August with a renewed sense of call here at Trinity.

This has been quite a year for us as we live into the realities of our first official "fiscal year" period of July 1, 2024 to June 30, 2025. We began that period with some financial challenges only to rebound as the months went on. With April results in, we are still in a positive financial position but have a couple of historically leaner months still to end the year. Thank you! While our congregation has been fortunate to outlast the national trends for a program-sized church for some time, it is prudent for us to practice some added fiscal restraints as the economy goes through some fits and starts. One way is to move forward with a part-time front office assistant and distribute some of the other administrative tasks that were part of a full-time office position previously.

After several years of relative stability within our staff, we now have several staff transitions. Cindy, who was with Trinity for 35 years, Heather, who served families for over 12 years, Dr. Frank who led our worship and music for six years, and in the fall, Marlee, who is the last of the original Noah's Ark teachers. Dear ones who we have known and loved as part of this shared mission will not be with us going forward. While change can sometimes be scary and disruptive, we trust that the Holy Spirit will guide us as we move forward into God's preferred future through Trinity.

All these financial and personnel changes can have the disorienting effect of the great wind, earthquake and fire experienced by the prophet in the wilderness. In fact, there may be days when we feel as though we are on our own wilderness journey. It is especially important in those times to seek God's voice and presence in the sheer silence. Making intentional time individually and as a congregation for that deep listening is so vital for our encounter with the Divine. I pray that we may know that presence, that grace and that love that comes to us from this amazing God we worship here each week.

#### Children's Ministry

- Sunday School and Wednesday faith formation for an additional group of 5<sup>th</sup>-6<sup>th</sup> graders continued to have positive attendance thanks to our dedicated volunteers.
- We continue to distribute Bibles, hold baptism conversations, communion instruction workshops, and more.
- This late spring and throughout the summer we have experimented with a "Pray Ground."
   The intention has been for families to have an alternative space within the worship center to sit for littles ones to keep active as the nursery is not staffed during the summer months.
   I am excited to see what new life it can breathe into our worship space during the traditional program year!

#### Youth Ministry

- Confirmation included youth in grades 7–8 and continued to focus on Scripture, Lutheran theology, and real-world faith questions. Our small group leaders walked faithfully along-side students and formed amazing relationships.
- The High School Youth Group was revitalized under Heather's leadership, offering space for prayer, play, and meaningful conversation. Katie has already started to build relationships with these youth and we look for continued growth.
- High Schoolers went to St. Louis on a service learning trip during the month of June. They
  came back with a reinvigorated sense of service for the Eau Claire community and want to
  integrate that into our high school ministry more intentionally.

#### Family and Intergenerational Ministry

- In the late winter we held a parenting class/seminar at The Brewing Projekt where we discussed the intersection of parenting and technology, mental health, and faith. This provided a great connection for folks at all stages of parenting and grandparenting and even generated another small group to dive deeper into topics.

# Noah's Ark Preschool and Early Childhood Enrichment

#### **Preschool Enrollment and Classes:**

The following classes were offered for the 2024-2025 school year:

MWF am classes for children 3-5 years old by September 1

TTh am classes for children 3 years old by September 1

M-Th pm class for children 3-5 years old by September 1

MW pm class for children 4-5 years old by September 1

Our enrollment for the school year has been strong with most classes at full enrollment numbers. All our three-year-old spots were full. We had a total of five spots open for older kids between the MWF, M-Th, and MW classes. It is often difficult to enroll four-year-olds due to the school districts offering free 4K classes.

#### **Teachers, Families, and Children:**

We continued to be blessed with teachers who are dedicated to serving our children and families! We did not have any staff changes for the 2024-2025 school year. This is the Noah's Ark Staff and the classes they have taught this year:

Kim Dewey: MWF am and TTh am classes

Mallory Harden: TTh am class and MW pm classes

Monica Bauer: M-Th pm class

Marlee Knickerbocker: MWF am class

In September 2024 I informed Pastor Tom and Pastor Patrick that it is my intent to retire at the end of September 2025. With this change we began to consider someone to take over my director's position. After consideration it was decided that Kim Dewey has the qualifications and would be a great fit for the position. While she will not begin this role until August 1, it was good to have her be a part of planning for the upcoming school year.

At the conclusion of the school year both Mallory and Monica submitted their resignations. Both teachers had changes in the needs of their families which necessitated a change for them. We have appreciated their time and service and wish them well in their future endeavors. New teachers have been hired to begin in the fall including Kelly Bruxvoort, Nicole Kaeding, and Katie Pribnow.

We once again had wonderful families to partner with this year! It is a blessing to get to know them and to watch them develop friendships with each other.

As always, the children are why we do what we do! It is amazing to get to know each child who comes through our doors and watch them grow, learn, create, play, discover, have fun, develop friendships, and become peacemakers together. At the end of the school year, we want them to know in their hearts that they are "a child of God forever!"

#### Noah's Ark Committee:

The Noah's Ark committee has worked to support us throughout the year. The committee meets monthly during in-school months. They worked hard to help me coordinate and facilitate our annual fundraisers. They continue to be passionate and supportive of our programming. They work to promote our preschool within the community. Thank you to each one of our committee members for their time and contributions. Please refer to the committee report for member names and more information.

#### **Fundraising:**

Our fundraisers this year included the Fall Taco Fiesta (including a basket silent auction), the Shrove Tuesday Pancake Supper Fundraiser, a Noah's Ark Chipotle Night, and the Down-to-Earth Flower fundraiser. All fundraisers were advertised and promoted to current families, alumni families, and the congregation. The suppers rely on preschool and

congregation members to cook, serve, and clean up from the event. We are fortunate to have former preschool parents who own and/or work at Indianhead Foodservice. They generously donate all the food for our suppers! These suppers provided \$8,666 in fundraising income. In addition, our Down-to-Earth Flower Fundraiser in the spring brought in \$1509 which is set aside in a fund to help support updates and repairs for our playground equipment. Thank you to all who helped support our fundraising efforts this year!

#### Child Care Counts Stabilization Program - WI Department of Children and Families

The Department of Children and Families has allocated funds for the Child Care Counts: Stabilization Payment Program to help support Wisconsin's early care and education community. This funding came in response to the COVID-19 public health emergency. Noah's Ark is eligible to apply for this funding. This year has been the fifth and final round of this program. Each month Noah's Ark is in session there is a monthly application process. In the 2024-2025 school year this program brought in approximately \$19,900.00. These funds have been applied to salary payments for our staff.

#### **Early Childhood Enrichment Program:**

The ECE program has continued to offer the Wednesday morning Music and Movement parent/child class for children aged 1 ½-3 and the Come and Play classes for children aged 2-3 years. Come and Play classes are held on Tuesdays and Thursdays. Families have the option to enroll their child for one or both days. Gina Toutant has led the Music and Movement class. Gina and Natasha Durnick were co-teachers for the Come and Play classes. These classes were fully enrolled for the Fall and Winter/Spring sessions. Open Gym also welcomed families into our space during the winter months. This is a drop in opportunity for young children and their parents to play together with appropriate equipment in our Trinity room. Our ECE and Noah's Ark teachers rotated leading the Open Gym program providing an opportunity for families to be introduced to all our staff. The ECE classes are a great introduction to our Noah's Ark program and provide opportunities for us to welcome people to Trinity. At the end of the school year Natasha Durnick regretfully submitted her resignation due to the needs of her busy family. We appreciate her four years of dedication to this program! She has agreed to be available for substitute teaching as she is able next year. Kelly Bruxvoort has been hired to fill this Come & Play position in the fall.

#### The highlight of 2024-2025 School Year...

As always, the highlight of our year is the children and families we work with! Seeing these children be loved, love one another, and continue to grow to be God's peacemakers is the blessing of our time together. As Noah's Ark moves into the next era with new leadership, I pray that Trinity will continue to support this ministry, provide them time to grow, and keep them in your prayers! It has been a blessing to be a part of Noah's Ark Preschool and the Early Childhood Enrichment program for these many years! Thank you to the congregation of Trinity for your support!

# **Food Pantry Annual Report**

#### **EVENTS/COMMUNITY**

An important part of Food Pantry is establishing partnerships with the community members and businesses. These relationships not only provide resources, but help promote our ministry with those outside of Trinity. Here is a highlight of some of these relationships. Guest volunteers have stepped in to work and learn about what the food pantry provides to our guests:

- Several outside organizations volunteered to help work at pantry.
  - \*Associated Bank (Eau Claire) has chosen Trinity Food Pantry as part of their community give back. We are in our third year of having them work pantries for us.
  - \*Memorial High School Honor Society students
  - \*Homeschool Co-op (Circle Group)
  - \*Regis High School
- Robbins Elementary hosted their third annual food drive for us and donated nearly one ton
  of food.
- Several local businesses hosted food drives and chose Trinity Food Pantry to donate these
  items to. They included Eau Claire County (Explore Eau Claire), Papa Murphy's, Diamond
  School of Dance, SCS Property Management-Eau Claire, Noah's Ark Pre-school, Angel
  Breakfast, SunShine Care, Inc., Personal Care Agency in Eau Claire, Stucky Chiropractic,
  Harmony Wellness, Epicor, Nestle USA
- Trinity Members, the community and First Presbyterian Church provided over 1500 pounds of fresh fruits and vegetables for our guests.
- Vacation Bible School and Summer Stretch kids spent time working and learning about what a food pantry is, helping with set-up and directly serving our guests.
- Several local businesses made monetary donations. They include Northwestern Bank, Stucky Chiropractic, WWIB-Chippewa Falls
- Food and Relationship sharing partnerships were established with Community Table, Ruby's Pantry (Lutheran Church of the Good Shepherd), Fill More Food Pantry (Chapel Heights Methodist Church), Our Redeemer Lutheran Church, and First Presbyterian Church.

#### **FOOD RESCUE**

Pick-ups are made each week to seven local businesses to pick-up useable food items that are no longer needed at their locations. Rescuing this food is a great way for us to distribute food to our guests that would otherwise be disposed of.

Aldi Inc. donated 17,000 pounds of food with 21% of this being raw meats.

HyVee donated 39,000 pounds of food. They also donated an additional 740 pounds that was collected from their customers purchasing pre-made food bags.

Our five Kwik Trip partners (Patton St, Golf Rd, Brackett Ave, River Prairie-Altoona, and Stop n Go on Birch St) donated 19,000 pounds. These partners also collected nearly \$1,200 through their coin canister collections.

#### **GRANTS**

Three grants totaling just shy of \$18,000 were received this year from Trinity Lutheran Church Endowment Trust, Spirit Lutheran Foundation, and Emergency Food and Shelter Program National (EFSP).

#### SPACE IMPROVEMENTS

With the addition of the new choir room, the pantry has been able to expand adding a new food storage area with a sink. A lighted open sign was added to our window facing Clairemont Ave to help guests see we are open.

#### SPECIAL EVENTS

- Trinity Lutheran Church partnered with CESA 10 Foster Grandparent Program (FGP). This program pairs seniors with students to serve as role models, mentors, tutors, and friends. Grandparents are income qualified adults who are at least 55 years old. Trinity provided 670 pounds of food to these Grandparents.
- Food Pantry volunteers participated in the annual Trunk or Treat event.
- Volunteers distributed over 4,300 pounds of Thanksgiving food items to the guests.
- Distribution of special treats and greeting cards were distributed to our guests for all major holidays.
- Reverse Advent and Reverse Lent calendars brought in over 1500 pounds of food and our Annual Spice Drive provided 270 spices.
- The Luke 3:11 Project set-up in the main parking lot twice this winter to distribute winter clothing items to the Food Pantry guests.

Dear Trinity Members,

We had a very successful year settling into what appears to a norm for us after our larger than expected increases in 2023.

Our dedicated account balance remained steady throughout the year because of your generous donations, grants received, and a decreased food expense of 28% from 2023 (thanks to Feed My People subsidizing free produce, free milk, and reduced costs).

Our volunteers worked through many challenges this year including injuries, illnesses, surgeries, deaths (including three of our own Jenna, Susan, and Jane). Volunteers always stepped up when needed to continue to serve the guests attending our pantries. I personally thank ALL these volunteers for everything they do for our pantry.

With the uncertainty of the impact that federal funding cuts to our costs and the community need, your continued monetary donations are very important in this new year. Thank-you!

#### **Parish Nurse**

**Psalm 46:10 Be still and know I am God.** When I am overwhelmed by the responsibilities I have said yes to, when I am so worried over the daily news; this is my go-to Bible verse. It centers and grounds me. And reminds me God's got this. I need to be quiet and listen.

#### Living among God's faithful people:

- Monthly blood pressure screenings: Take place on the second Sunday of each month or
  privately as requested. I had a few more individual meetings with members this year who
  had blood pressure concerns.
- Red Cross Blood Drives: We sponsor 5 blood drives yearly. From June 2024 through June 2025 195 units of blood were donated. That number of units has the potential to help 585 people. A huge thank you to everyone who donates blood.
- Prayer aids' ministry: Prayer shawls, palm crosses, prayer beads, and pocket prayer shawls are available to all in need of the comfort of prayer. A special thank you to our group of knitters, Dennis Aasen (crosses), and Suzanne Brinkmeyer (beads) for their generous donation of time and talent. These items bring such comfort to the people who receive them.
- Medical resource person: I am here to provide members with health care advice, community resources, end of life concerns, caregiving support, and more.
- Monthly newsletter: I include articles on "topics of the month" along with other informational health materials.
- Advent and Lenten Saturday Morning Bible study: Lead both groups using materials from "Salt Project". They were well attended by exceptional people.
- Lenten Lunches: Soup lunch meal provided on Wednesdays following the noon Lenten service. Thank you to all the volunteers who helped make this possible, ad to those eating and enjoying being social.
- Lefse Making: A group of talented people volunteered their talent and time the weekend before Thanksgiving to make a lot of lefse! The lefse was sold as a fund raiser.
- Member contact: Individual member contact has increased involving a variety of needs from answering medical questions to being a safe person to listen to concerns.
- Men with Cancer group: They continue to meet quarterly. This is open to any man who has had, newly diagnosed, or currently in treatment for cancer.
- Work closely with Pat Garber (Visitation Director) in staying updated on members who are
  hospitalized, in rehab, hospice, or homebound. I am currently assisting in the process of
  getting photos into the new church directory for those members homebound or in facilities.
- Birthday Card ministry: This ministry has grown and brings such joy to our super agers!
   Marilyn Thompson and her helpers make both birthday and seasonal cards for all our members 87 years old or more. That is 68 members. Being a member of Trinity is good for your health.
- Membership in Evangelical Lutheran Faith Community Nurse Association: This is a group of Parish Nurse from across the Midwest area of America who meet monthly to share ideas and information. The leadership also provides CEUs throughout the year. This year I connected with a Mayo patient from Northwest Iowa who had heart surgery in Eau Claire.
- Chippewa Valley Area Parish Nurses: We meet 3 times a year to share ideas and what
  each of our churches is doing. We currently are looking to partner with a group in Chippewa Falls to establish a Nurse Honor Guard for funerals of nurses to include Eau Claire and
  Menomonie.
- Continuing Education: I participate in 3-4 classes per year.

#### Serving all people following the example of Jesus

Bereavement Ministry: In 2024-25, 49 family members received bereavement letters throughout the year offering spiritual, emotional support, and guidance while grieving the loss of a loved one. Special mailings went out at Christmas.

Healing and Blessing services: Healing services were part of the regular service during the fifth Sundays of those months. There are many people carrying burdens that we are unaware of.

Caregiver Ministry: Emphasis on support and resources for caregivers of the congregation. Currently offering extra help to a family whose mother is facing serious health concerns. Care boxes and devotionals are available for caregivers.

Thank you for supporting Health Ministries and giving me the opportunity to serve this congregation.

## **Visitation Ministry Director**

Being called to live with humility, gentleness, and patience while bearing one another in love is a hallmark of visitation ministry. This is done in an effort to maintain unity in our faith and support a bond of peace (Ephesians 4:2-3). A key component of visitation is personal provision of Holy Communion. An additional important aspect is its focus on personal contact, which provides spiritual companionship, connects to a faith community, and counteracts loneliness (often experienced with mobility limitations).

Members who are homebound or live in a residential facility (assisted living, long-term care, etc.) are served by the visitation ministry. Though there is natural fluctuation in the number served, about 50+ members are visited. Visits typically occur on a monthly basis by the same visitor each time, thus allowing development of a trusting relationship. (Also, it should be noted that many visited members utilize technology to watch/listen to live-stream and past services, which they greatly appreciate.)

Besides myself, staff members who provide visitation contacts include Pastor Patrick Patterson, Pastor Tom Westcott, and Parish Nurse Vicki Dueringer. In addition, a team of volunteer visitors faithfully serve in this ministry. During 2024-25, there were 15 volunteers: Roxie Berg (new), Carla Brandrup, Faye Deich, Kathy Gjesfjeld, Phyllis Grohn, Greg Helgeson (new), Pat Kress, Dawn Marcott, Helen Mateski, Karen Metzgar, Sheri Petersen (new), Judy Pielhop, Bob Schoenknecht, and Mary Schoenknecht. Jack Olson provided much supportive assistance as well. These volunteers deserve recognition and hearty thanks for their service!

I continue to be blessed and inspired in this ministry - by the members visited as well as the visitation team who bring God's presence into the lives of members who have little other regular direct contact with Trinity as a community of believers.

#### **Archives Committee**

Members of the Trinity Archives Committee included: Lynn Gullicksrud, Sheila Running, Sue Brumberg Schaefer, and Mary Schoenknecht.

Purpose: The archives committee of a congregation is primarily concerned with collecting and appraising, preserving and protecting, arranging and describing and making accessible original historical documents and records of the congregation. From the Archives of the ELCA. The committee met as necessary to do the following tasks:

Update the Historical Timeline of Trinity Lutheran Congregation for the years 2023 and 2024 and add significant data to previous years. This timeline is to be posted on the Trinity Website.

Add the 2024 and 2025 Confirmation Class pictures to the panel display in the lobby. As requested by the lead pastor, individual pictures of the current council members were added to the panel display in the lobby.

Remove Deacon Lidixe Montoya's staff picture from the lobby display to the Archive's display case near the Trinity Library. Her employment as a current staff member ended in September 2024. A nameplate and years of service was ordered to add to the framed picture in the permanent display case.

To start a discussion of how to preserve the video interviews with previous pastors, charter members, and others. All the interviews were transferred to a DVD format.

Committee members met with people who are interested in the history of the church for projects.

- A UWEC student requested information about the Hmong Resettlement Program sponsored by the US Federal Government and supported by Trinity Congregation in April 1976. The student wrote an article for the University's View newspaper.
- A Trinity member needed information about the early history of the church for his Eagle Scout project.

# **Caring For Creation**

Committee members:

Roger Brian, Kathy Nelson, Marilyn Johnson, and Chair, Pat Mertens Gary Rambo leads the Trinity Woods Project

The committee continues to promote earth stewardship through display tables, a recycling cabinet for batteries, electronics, old phones, and eye glasses. The eye glasses are given to the Eau Claire Lion's Club.

The food pantry is using the Earthbound Compost service and overall, it is working out well. There are times that compostable materials are added to the bin for other church activities. The committee's goal is to expand composting for all church activities. The cost needs consideration as well as the logistics of how to implement it in the church community.

The Reforestation of the Trinity Woods is a big focus this year.

In early Fall, the committee and a few other volunteers gathered trailer loads of brush, which included invasives (buckthorn, honey suckle, and dead ash) to the brush site. In early winter, a forester was hired to clear the land of the invasives including a lot of buckthorn which has taken over the forest. The funds were taken from our designated funds. This spring we planted white oak seedlings, small Eastern Hemlock, Serviceberry, and Highbush Cranberry which are all native to our area. Some plants were donated and some were paid for though our account. The plants came from the Eau Claire County Conservation.

The plants are caged and cared for by watering, and weeding. Roger Brain has made wonderful tree identification signs that are tied to the trees. Gary Rambo has been treating buckthorn and removing dead ash. Pat Mertens has cared for the native garden at the entry to the woods. A Reb Bud tree and some native garden plants have been added recently.

Youth Groups have used the fire pit as a social gathering on Wednesday evenings and it is getting used more often.

Gary Rambo is working with one of our church members, Eli Calvin, who is earning his Eagle Scout through a project at the Trinity Woods. The scoutshave purchased materials to make two Leopold benches which they will assemble and place at the fire pit area. Gary precut the wood for the scouts. The 10 or so Scouts will spread wood chips on a woods walking trail that Gary designed. The scouts will donate 4-6 hours of work at the woods. Kyle and Linda Berg made and donated two Leopold benches for the fire pit area. They have donated time at the woods and are available to help with future projects.

Pat Mertens Inquired about having a Celebration of Earth banner made by a member of the Sewing for Mission group. Arlene Knops designed and made a beautiful banner which hangs beneath the clock in the coffee area. She is not a member of Trinity and gave it a gift to the church.

The Caring for Creation Committee participated in the 2025 Vacation Bible School with action outdoor activities that relate to having compassion for each other and all living things on planet Earth. The themes were shelter, air, and water and they engaged in outdoor activities related to how we can be better stewards in how we live. They helped plant small pine trees and native plants, and watered them. They hung a bird house as a shelter. They composted items from their snack break. The youth learned about the monarch butterfly, and how we can protect them from becoming extinct. Kathy Nelson provided monarchs for the youth to release into the sky. Hopefully the youth will have a deeper understanding of ways we can take care of each other and God's creation.

# **Library Committee**

Members of the Trinity Library Committee were as follows: Suzanne Becker (April 2025-present), Gloria Crossman, Mary Dixon, Mary Doering, Joanne Dow, Vicki Dueringer, Mary Elworthy, Monika Fiedler, Sonnie Jacobson, Marilyn Johnson, Barbara Lee, Lidixe Montoya (January 2024-September 2024), Amber Moltzau (April 2025-present), Ann Nelson, Mary Schoenknecht, Dee Schorr, Dawn Stienessen (January 2025-present), and Helen Wurtzel. Ann Nelson served as chairman.

Regular meetings were held the second Monday of the month in January through May and September through December to discuss the various facets of library business, special events, and promotions. Workdays were scheduled for the fourth Monday of the month or as needed to complete such tasks as processing new books, filing catalog cards, and sending out overdue notices. Members took turns serving as librarian of the month and sharing devotions at the meetings. They recorded statistical information on all items checked out, checked in returned items and re-shelved them. Monthly articles were prepared for publication in the Tidings. A bulletin board in the nursery hallway was updated to help display new books and promotions.

#### Tasks and Special Events:

- Joanne Dow and Mary Dixon served as the committee catalogers with the assistance of Cindy Beck. Amber Moltzau and Suzanne Becker became catalogers when they joined the library committee.
- Sunday Faith Formation classes were invited to the library in February 2024 and March 2025 for Dr. Seuss Sunday to check out books. Committee members were on hand to assist.
- The annual inventory and culling of the collection were completed in March and April 2024 and February and March 2025.
- Trinity's Earth Day Celebrations were held both years in April, and a display of Caring for Our Earth books were moved to the lobby near other displays from the Trinity Green Team. Copies of the book list, Caring for Our Earth, were made available.
- In June 2024 Mary Dixon applied for and received a \$250 Community Impact Card from Thrivent to purchase books for children and youth with a theme of kindness 22 new books were added to the collection. She applied for another \$250 Community Impact Card to boost the collection of popular graphic novels.

- Summer Story Time was offered on Sunday mornings. It was held on six Sunday mornings in June and July 2024 and four Sundays in June 2025. Committee members were on hand to read to young children, help them check out books, and hand out prizes.
- Playground Play Time on Thursday mornings met six times in the summer of 2024 a cart of books for children to read and check out was taken to the playground by a committee member. This program was set up for June and July 2025 with library volunteers and will be reported at the September 2025 regular meeting of the committee.
- Copies of the book selections for Trinity's Page Turners Book Club were purchased, identified with a special label, and placed in the library for circulation.
- Don and Sheri Peterson completed the much-anticipated Tree Display in October 2024. They designed, built, painted, and installed it for an unused space on the south wall of the library. It was affectionately named the Tree Display and is a focal point as one enters the space a great place to display books!
- The library participated in the annual Trunk or Treat event in October 2024 sponsored by the Trinity CYF Ministry.
- The library was decorated for Christmas 2024, and the extensive collection of Christmas books was put on display. Sunday morning Faith Formation classes were invited to the library to check-out books. Committee members were on hand to assist and hand out prizes.
- Members participated in several book buying trips to the local Books a Million store, Dotter's Book Store, and Northwind Bookstore in Spooner. All three stores applied a 20% discount on the purchases.

Records show 1279 items were checked out in 2024. New books were purchased throughout the year, listed in the newsletter, and placed into circulation after cataloging in the library computer system. Donated items that met the Trinity Library criteria were added to the inventory. At the close of 2024, inventory records showed the Trinity Library had a collection of over 3,000 books and DVDs.

Income of \$1,800 was received from the Trinity Lutheran Church General Fund during the year and half fiscal period with additional funds received from memorials and donations. These funds were used to purchase new library books and media, supplies, and promotional materials.

- Held a fireside about the Green Bandana Project for JONAH on mental health.

# Women' Giving Circle

The Women's Giving Circle (WGC) operates as a fund of the Trinity Lutheran Church Endowment Trust Fund. We are a group of individuals who have established a donor advised fund with the endowment Trust fund. Our mission is to demonstrate God's love by positively impacting people's lives through collective philanthropy and awarding of financial gifts.

We began 2024 with a membership of 43 and an opening balance of \$86,961. As a board, we plan a spring event to hear from a few grant recipients plus encourage membership. Our fall meeting serves to enjoy brunch and time for fellowship. We also present our grant requests to our entire membership and vote on those grants we choose to award. On April14, 2024 we held our spring event in the fireside room following both services. Two of our grant recipients (Western Dairyland and Menomonie's Red House of Hope) spoke and shared how the grants they received were so welcome and used to help carry out their missions. We were pleased to have about 15 women present at each session.

New fiscal year, July 1, 2024, to June 30, 2025

A meeting of our board was held on September 25 to discuss changes regarding the fiscal year, plus planning for our October membership meeting. Current membership was 43. Our annual fall meeting was held on October 27, 2024. Nineteen members were in attendance. We enjoyed brunch. Valarie Fedie, treasurer of the Endowment Trust, was present to share fiscal year changes that would affect the WGC. These include changing our fiscal year to match that of Trinity, changing our grant cycle to July 1 to August 31, updating our bylaws to match the fiscal year changes, and setting our board members' terms to match the fiscal year. These changes were all voted on and approved. Our treasurer reported an opening balance of \$86,961. The Endowment Trust advised us that we had \$8,792 available to grant. We received seven grant requests totaling \$11,700. The following grants were approved:
