 - Answer: We have a good landscaping program so it would probably be maintained by them. If it becomes an issue we could include it in the rest o the church's landscaping program.

- Question: There are 3 expandable to 4 units, is it designed to start smaller and scale up?
 - Answer: We wouldn't want to start less than two, due to costs, three makes more sense. The congregation can vote on it and see their interest if there is enough interest we can start with two units or three.

 - Answer: We are on schedule, we pay the principle and interest each payment. We reduced our principle by 120 thousand and owe still 1.2million. We do get some additional gifts to the mortgage and we apply those as they come in.
