PRESBYTERY OF LAKE HURON

Stated Meeting – September 20, 2022

The Presbytery of Lake Huron was called to order with prayer by the Moderator, the Rev. Glenn Grant, at 9:30 a.m., on Tuesday, September 20, 2022, and was held via Zoom and in-person at First Presbyterian Church, Bay City, Michigan.

The Trustees recommend and presbytery approved:

1. Following congregational approval on January 30, 2022, grant First Presbyterian Church of Vassar permission to sell the property located at 123 Madison Street, Bay Vassar, Michigan 48768 (legal description: Lots 3 & 4, Block 3, Ebenezer Morse's addition to the village of Vassar (now city), according to the Plat thereof recorded in Liber 1, Page 259 of Deeds, Tuscola County Records, except the North 20 feet of Lot 4; also the east 33 feet of Lots 11 and 12, of said Block 3, except a strip of land 20 feet in width and 33 feet in length in the Northeast corner of said Lot 11, being subject to any easements, reservations, restrictions, or rights of way, whether implied, visible or of record.) Tax code: 051-500-423-0300-00. The purchase price will be \$200,000.

African American Religious Autobiographies Bibliography for the Presbytery of Lake Huron September meeting:

Frederick Douglass: Narrative of the Life of Frederick Douglass, An American Slave; Ida B. Wells: Crusade for Justice (Ms. Wells and issues related to lynchings) Benjamin Mays: Born to Rebel (Dr. Mays brought Morehouse College into prominence; spiritual leader/friend Martin Luther King, Jr.)

Howard Thurman: With Head and Heart (Dr. Thurman brought spiritual leadership to Howard University, dean of Marsh Chapel of Boston University, co-founder of the interdenominational Fellowship Church in San Francisco)

W.E.B. Dubois: The Soul of Black Folk (Dr, Dubois wrote 14 essays describing the life, ambitions, struggles of African Americans late 19th century into the 20th century.) Martin Luther King, Jr: Where Do We Go from Here (Dr. King wrote and published this book in 1968.)

James Cone: Said I wasn't Gonna Tell Nobody and The Cross and the Lynching Tree (Dr. Cone is renowned as a theologian, and his work is Black Theology,)




