PRESBYTERY OF LAKE HURON
Stated Meeting – December 2, 2025

The Presbytery of Lake Huron was called to order with prayer by the Moderator, Beth Asperger, at 9:30 a.m., on Tuesday, December 2, 2025 at Flushing Presbyterian Church, Flushing, Michigan.

ATTACHMENT B – Motion to Establish a Listening Team

Acknowledging the work of the 2022–2023 consultation team of COMMP, the presbytery shall designate its findings to the Council of the Presbytery, which shall then be tasked with proposing a detailed action plan to resolve the identified issues. It would be appropriate for the Council to consult the Listening and Discovery Committee, in their considerations to produce an action plan to address the issues of the Presbytery.

Upon a proposed action plan, the Presbytery Council shall send a letter to the Clerk of each Member Church of the Lake Huron Presbytery, with adequate time for all churches to compose a critique or affirmation for the Presbytery Council's consideration. It would be appropriate to call each MC's Clerk directly to establish this communication. The Council may choose to hold town-hall type meetings in each region to receive collaboration from each region's Member Churches. The Presbytery Council shall present its proposal no later than the June 2027 Presbytery meeting.
