# **Discussion Guide**

Discussion Guides accompany the weekly message.

#### **Opening Activity:**

Invite each person to share a time when someone showed them unexpected mercy or kindness when they didn't deserve it. How did it impact them?

Read: Nehemiah 5:1-19

### **Discussion Questions:**

- 1. How does Scripture define the "fear of God" differently than how our culture defines fear? (Exodus 20:20; Proverbs 9:10; Isaiah 40:12-15)
- 2. Nehemiah confronted the wealthy Jews for exploiting the poor. Why does the *fear of God* move us toward mercy instead of manipulation? (Leviticus 25:35-38; Micah 6:8)
- 3. Nehemiah reminded the nobles that he refused the governor's food allowance "because I feared God" (Nehemiah 5:15). What does this teach us about spiritual leadership today? (John 13:14-15; 1 Peter 5:2-3)
- 4. Why is mercy such a critical mark of revival in people of God? How does understanding God's mercy toward us change the way we treat others? (Ephesians 2:4-5; Matthew 5:7)
- 5. Which of Nehemiah's examples speaks to you most right now: deepening reverence for God, showing mercy to others, or living with daily moral responsibility? Why? (Psalm 8:3-4; Colossians 3:12-14)
- 6. When you think about the mercy God has shown you (Ephesians 2:4-5), how does that impact the way you treat people who have wronged you or made life harder for you? Can you share a moment where you've experienced that shift in perspective?
- 7. Exodus 20:20 says the fear of God "will keep you from sinning." What's one area of your life right now where a healthy fear of God could help you make better decisions? How can your group encourage you in that?
- 8. Nehemiah confronted leaders who were manipulating their own people for personal gain (Nehemiah 5:7-9). Without naming names, can you recall a time when you've been tempted to manipulate a situation for your own advantage? How can reverence for God shift that instinct into mercy?
- 9. Nehemiah reminded the nobles that their treatment of the poor reflected their fear—or lack of fear—of God (Leviticus 25:35-38). How do your financial, relational, or workplace choices reveal your reverence for God? Where might God be calling you to live with more integrity?
- 10. Nehemiah said, "Because I feared God, I did not act that way" (Nehemiah 5:15). What's one tangible way you could model that kind of moral responsibility this week—at home, at work, or in your friendships—so that others see God's mercy through your actions?

#### **Challenge for the Week:**

Identify one person in your life this week to intentionally show mercy to—someone you could easily overlook, avoid, or even hold a grudge against. Write their name down and share it with someone in your group (or a trusted friend) who will hold you accountable. At your next gathering, check in with one another about how you lived this out.

## **Prayer Focus:**

- Pray that we would cultivate a holy reverence and awe for God that overflows into mercy.
- Pray for forgiveness where we've manipulated or taken advantage of others.
  Pray for courage to live with moral responsibility in every area of our lives.
