This loan will be forgiven if all staff are retained and are continued to be paid their average wage. Line of Credit	The Council would like to secure a line of credit so that we have the ultimate flexibility as we face an uncertain future. According to our Constitution and Bylaws, Congregation approval would be needed if we want to move forward with this.	Tom Splittgerber made a motion that recommends that as soon as Stefanie has completed the CARES Act application, she should investigate a \$600,000 line of credit and present that to the Council, which would then need to go to the Congregation for approval, along with defining the terms on which it would be used.
