Qualifying ACH Payroll Direct Deposits include paychecks, Social Security payments and pension payments. If PFCU is unable to confirm the deposit is a recurring payroll deposit, PFCU reserves the right to withhold the payment. In order to qualify for a \$50.00 Bill Payer Bonus, in addition to the general account requirements, new member must sign up for PFCU's Online Bill Payer through Teller Net. Bills totaling at least \$100.00 must be paid through the Online Bill Payer system within ninety (90) days of account opening. Scheduled or pending bills do not qualify. In order to qualify for a \$100.00 New Auto Loan Bonus, in addition to the general account requirements, a new, used or refinanced automobile loan must be financed with PFCU in an amount of at least \$7,500.00. Refinancing of an existing PFCU auto loan is excluded. In addition, the loan must be booked and remain outstanding and not in default for ninety (90) days after account opening.
