

NOTICE OF TELEPHONIC PUBLIC INPUT HEARINGS

PPL Electric Utilities Corporation – 2025 Base Rate Case

Docket Nos. R-2025-3057164, et al.

The Pennsylvania Public Utility Commission (Commission) has scheduled in-person and telephonic public input hearings to accept customer comment on the request of PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) to increase its annual jurisdictional distribution operating revenues by approximately \$356.3 million. Customers of PPL Electric are invited to provide their comments or testimony regarding the Company’s request for the public record. Beginning at 1:00 PM and 6:00 PM on Monday, December 15, 2025, customers will testify in the order in which they signed up. **Please pre-register for the telephonic public input hearings by 4:00 PM on December 11, 2025.** Although pre-registration for the telephonic public input hearings is encouraged and not required, the failure to pre-register for a telephonic public input hearing could result in you not being called to testify by the administrative law judges. Pre-registration is not required for the in-person public input hearings.
