CPE Monitor is a collaborative service from the Accreditation Council for Pharmacy Education (ACPE) and the National Association of Boards of Pharmacy (NABP). CPE Monitor authenticates, stores, and streamlines data reporting and compliance verification for participating boards of pharmacy. Attendees who complete the requirements for earning continuing education contact hours may view and print their records from the CPE Monitor site.

Pharmacists may obtain a unique identification number from NABP (<https://nabp.pharmacy/>). This number is used to upload continuing education units to the NABP database. After CPE units are processed by ACPE and NABP, participants will be able to download and print their comprehensive CPE transcript from the CPE Monitor website.
