I understand at the end of orientation I will be given my gate card and membership card and only then will I have range use privileges. New member applications are approved by the Board of Directors bi-monthly the second Monday of the month. (January, March, May, July, September, and November). Upon approval, I understand I will be emailed the Tuesday immediately after the approving board meeting of my orientation time I must attend that immediate Saturday. (Note: Initial email may go to your junk/spam folder.) I understand included in my fees today is a one-time non-refundable \$25.00 application fee. I understand if my membership is denied I will receive back the dues paid less the \$25.00 application fee. I understand if I do not attend my scheduled orientation there will be no partial refund of my membership rates as Blue Water Sportsman's Association held this orientation in good faith as agreed in this contract. A partial refund will only be given in the extreme situation Blue Water Sportsman's Association was unable to hold the orientation on the scheduled Saturday after the approval meeting as agreed. I understand I must attend an orientation at Blue Water Sportsman's Association within 6 months of my approval date (i.e. 3 orientation cycles) or no refund of any payment will be given or carried to a new application as Blue Water Sportsman's Association held them in good faith as agreed with this contract and with several notices of your approval and scheduled orientation dates and times.
