_____ I will place paper targets on the plywood backers, and I will not hang any steel targets off the plywood backers.

_____ I will not shoot shotgun shot into the plywood backers.

_____ I will only shoot steel targets that are rated for my firearm. I will only use firearm rated targets.

_____ I will not use binary explosives, fireworks, tracers, incendiary, or tracers on the grounds at any time.
