ELIGIBILITY REQUIREMENTS

Any individual, firm or corporation producing stone products for any purpose is eligible to become a producer member.

PRODUCER MEMBERSHIP DUES

Basis of Dues - Tonnage of stone, limestone, dolomitic limestone and dolomite sold in any form and only that portion sold for all purposes from mining operations in Missouri during the preceding calendar year (see Tonnage Report form).

INSTRUCTIONS FOR COMPLETING THE TONNAGE REPORT FORM

(See example for reference)

- Step 1: Provide your company's name, address, etc. and your name. Please review the "Membership Fee" and "Membership Dues" notations at the top of the form.
- Step 2: If your company had more than 4 million tons sold in Missouri for the previous year, you should go to Line 1C and enter \$15,000 in the space provided. You do not need to provide a tonnage sold figure. Then go to Line 2 and 3 on the form. If your company had less than 4 million tons of sales go to Step 3 below.
- Step 3: Complete Line 1A on the form for the first 500,000 tons sold (or whatever portion is applicable). If your company's sales were 500,000 tons or less, then go to Line 2 and 3 on the form after completing Line 1A. You must provide a tonnage sold figure even if you are paying minimum dues.
- Step 4: Complete Line 1B on the form for the next 500,000 tons sold (or whatever portion is applicable). If your company's sales were 1,000,000 tons or less, then go to Line 2 and 3 on the form after completing Line 1B.
- Step 5: Complete Line 1C (if not already completed from Step 2) for whatever portion of the next 3,000,000 tons sold that is applicable. Ignore sales of more than 4,000,000 tons since you have reached the maximum dues assessment at that level.
- Step 6: Add the values on Lines 1A, 1B, 1C, and Line 2 on the form to arrive at a subtotal.
- Step 7: Complete Line 3 by calculating 2% of your dues only if full payment will be made by **January 31**. Deduct this from the subtotal (if applicable) to establish your company's total dues. You may pay dues quarterly (see Step 8 below), but the 2% deduction will not apply.
- Step 8: Indicate whether payment is enclosed or if you prefer to pay quarterly.
If you choose to pay quarterly, please enclose the first quarter dues.
You will be billed for the remaining payments.
- Step 9: Please note the box that describes the portion of MLPA dues that are tax deductible as an ordinary and necessary business expense.
