### Information We Collect

We collect the following types of information:

#### General Account Information

As is true of most other websites, we collect certain information automatically and stores it in log files. The information may include internet protocol (IP) addresses, the region or general location where your computer or device is accessing the internet, browser type, operating system and other usage information about the use of our website, including a history of the pages you view. We use this information to help us design our site to better suit our users' needs. We may also use your IP address to help diagnose problems with our server and to administer our website, analyze trends, track visitor movements, and gather broad demographic information that assists us in identifying visitor preferences.

In addition, when you communicate with us through the site's contact form, we require that you share your first name and email. You can also communicate with the Company through email, and share posts through the Intel Community. You are solely responsible for whatever personal information you share with the Company through the contact form or any other public post, and we will use the information only for lawful purposes, like internal marketing, performance of our contractual obligations, legitimate commercial interests, and compliance with our legal obligations.

### When and how we share information with others

Information about your purchases of Syllogi products and services are maintained in association with your membership or profile account. The personal information that the Company collects from you is stored in one or more databases hosted by third parties. These third parties do not use or have access to your personal information for any purpose other than cloud storage, retrieval and fulfillment of their contractual obligations with Syllogi.

## **Purchases, Billing and other Third-Party Information**

Syllogi has partnered with various ecommerce and other fulfillment platforms, as more fully set forth above in the Other Applicable Privacy Policies section, to enable you to safely and securely make payments for products and services purchased through this Site. We never directly receive or handle any of your credit card or other payment information, and we do not share your PII with any third parties.

## **SHARING OR DISCLOSING INFORMATION**

Information about our customers is an important part of our business. We do not otherwise reveal your personal data to non-Company persons or businesses for their independent use unless: (1) you request or authorize it; (2) it's in connection with Syllogi-hosted and co-sponsored conferences; (3) the information is provided to comply with the law (for example, to comply with a search warrant, subpoena, or court order), enforce an agreement we have with you, or to protect our rights, property or safety, or the rights, property or safety of our employees or others; (4) the information is provided to our agents, vendors or service providers who perform functions on our behalf; (5) to address emergencies or acts of God; or (6) to address disputes, claims, or to persons demonstrating legal authority to act on your behalf. We may also gather aggregated data about our members and Site visitors and disclose the results of such aggregated (but not personally identifiable) information to our partners, service providers, advertisers, and/or other third parties for marketing or promotional purposes.

## **COOKIES, PAGES VIEWED AND COMPUTER INFORMATION**

Syllogi may set and access cookies on your receiving device. We use cookies to improve your user experience on the site, if you configure your browser to ignore cookies it may affect the site's functionality. The site uses session cookies, which are erased when you close your browser and do not collect information from your computer. These cookies typically store information in the form of a session identification that does not personally identify you. The site also uses persistent cookies, which are stored on your hard drive until they expire (i.e. based on a set expiration date) or until you delete them. These cookies are used to collect information about you, such as your Web surfing behavior or preferences for a particular site. In addition, every time you view a page on the site, your browser sends some information about the requested page, such as the address of the page, and the language and format in which you would prefer to receive it, as well as information about your computer, such as its Internet protocol (IP) address, and the type and version of your browser and operating system. ## **Transferring personal data from the EU to the US**

The Company has its headquarters in the United States. We endeavor to apply suitable safeguards to protect the privacy and security of your personal data and to use it only consistent with your relationship with the us and the practices described in this privacy policy. The Company also enters into data processing agreements and model clauses with its vendors whenever feasible and appropriate. ## **Security of your information**
