

Glaucoma: Enough Pearls to Make a Necklace Greg Caldwell, OD

An overview of glaucoma; risk factors (development and progression), disc hemorrhages, the impact of pharmaceutical agents, target IOP, surgical updates and important goals of therapy will be discussed. The course will emphasize clinical pearls for the primary care optometric physician and will provide clinicians with guidance around pitfalls. Case presentations will be the chief format used during this course.

Cases of current methods of treating ocular emergencies. Cases include the ocular adnexa and lacrimal system, mechanical and infectious involvement of the anterior segment, and urgent glaucomas.

1:00pm-2:40 pm (TQ) Laser Therapy for the Anterior Segment COPE # Pending Rim Makhlouf, OD

The scope of practice of optometrists is expanding in an increasing number of states, which now includes laser therapy for the anterior segment. This course discusses laser peripheral iridotomy (LPI), posterior capsulotomy, argon laser trabeculoplasty (ALT), selective laser trabeculoplasty (SLT), and argon laser peripheral iridoplasty (ALPI), in addition to the basics of laser physics and laser-tissue interactions. Patient selection, peri-operative care, procedures, complications, and expected outcomes will be covered.

What's New in Retinal Vascular Disease? Sherrol Reynolds, OD

A Grand Round Approach to Anterior & Posterior Segment Disease Marc Myers, OD & Andrew Gurwood, OD

Challenging cases involving anterior and posterior segment structures will be presented. Modern diagnostic and disease management strategies are discussed.

Rheumatology, Thyroid Dysfunction & the Eye Greg Caldwell, OD

This course reviews the close association between the eye, rheumatology and thyroid dysfunction. This course will provide an overview of the clinical aspects of herpetic eye disease including herpes simplex and herpes zoster. The diagnostic challenge of herpetic eye disease, current treatment trends and clinical pearls will be emphasized through case presentations.

This course will provide a review of the recent laws (Chapter 463) and rules (64B13) regarding the practice of optometry in the State of Florida. In addition, recent changes within the Department of Health or Chapter 456 will be highlighted. Additionally, the Unlicensed Practice of Optometry or ULA will be discussed.
