ARBO's 2025 Annual Meeting was Minnesota Nice!

The 2025 Annual Meeting was attended by 106 individuals, which included 66 delegates from 35 member boards. There were 40 other attendees, comprising guests, invited speakers and ARBO Board members.

Dr. Jeffery Yunker, President, called the meeting to order in the morning on Sunday, June 22, 2025. Dr. Eric Bailey, Chair of the Minnesota Board of Optometry, welcomed the delegates to Minnesota. Dr. Yunker then recognized the ARBO Board of Directors and noted some of their accomplishments over the past year. Dr. Yunker then introduced ARBO's Executive Director, Ms. Lisa Fennell, who introduced the staff and reported some of their accomplishments over the past year.

Ms. Margaret Whelan, Secretary-Treasurer, reported that ARBO had an audit of the 2024 financial statements and everything was found to be in order. The delegates then approved the minutes of the 2024 Annual Meeting. Next, Dr. Mariah Smith, Chair, gave the Nominating Committee report. Dr. Smith announced that two four-year terms on the ARBO Board of Directors were open: one 4-year term for the position of Dr. Jeffery Yunker, who is not eligible for re-election, and one 4-year term for the position of Dr. Gerard Lozada, who has completed a partial term and is eligible for re-election. Dr. Smith presented the Nominating Committee's slate of nominees for each position: For Board of Director Position 1: Dr. Carey Patrick and Dr. Lillian Wang; For Board of Director Position 2: Dr. Gerard Lozada.

Next, Dale Atkinson, Esq., gave a presentation on the history of optometry regulation and the role of government in professional regulation. Dr. William Rafferty, Chair, gave a report on the research done by the Tele-

health Task Force. He noted that telehealth is a tool, and it does not change the scope of practice or the optometrist's responsibility. Recommendations from the task force included creating a telehealth policy and/or guidance document to assist the public and licensees with navigating telemedicine; requiring an established patient-provider relationship for telemedicine; and requiring optometrists to have an in-state physical practice location. Resources were provided which will also be posted in the member section of ARBO's website.

After a break for lunch, Ms. Kate Regnier, Executive Vice President of the Accreditation Council for Continuing Medical Education, presented on the importance of continuing professional development for healthcare professionals. She noted that ACCME collaborates with many other professions, including optometry, to offer consistent, universally adopted CE/CME accreditation standards. Next, Dr. Julie Tyler, Chair, and Ms. Sierra Powell, ARBO's Manager of Accreditation Services, gave a report on the activities of the COPE Governing Council.

This was followed by Dr. Carey Patrick, Chair of the National Board Exam Review Committee, who reviewed the committee's annual report and recommendations regarding the NBEO exams. Next, Dr. Jill Bryant, NBEO Executive Director; Brett Foley, PhD, NBEO Director of Psychometrics and Research; Dr. Nadia Sachinski, NBEO Associate Director of Part I ABS and ACOMO; and Dr. Patrick O'Neill and Dr. Daniel Taylor, NBEO Board members, participated in a panel discussion about the NBEO Examinations that was moderated by Dr. Michael Ohlson, NBEO President.

ARBO Annual Meeting Recap (*continued*)

Later in the afternoon, the delegates discussed issues of interest in their jurisdiction. The afternoon ended with Dr. Yunker calling for nominations from the floor for each open position on the Board of Directors. Each nominee was given a few minutes to address the delegates, and the meeting was recessed for the day.

Dr. Yunker reconvened the meeting in the morning on Monday, June 23, 2025. Dr. Michelle Cooper, Chair of the Bylaws and Resolutions Committee, reported that one resolution was received this year for the delegates' consideration. She reviewed the resolution to Include ARBO on Member Board Meeting Agendas. Next, Dr. Terri Haley, Vice-President and Chair of the Finance Committee, presented the proposed 2026 Budget. This was followed by an interactive session with Dale Atkinson, Esq. on Optometry Board structure and governance, and improving the effectiveness of Boards.

After that, Dr. Eric Bailey, Dr. Lillian Wang, Co-Chairs, and Ms. Brittany Howard, ARBO's Program Specialist, gave the attendees a report on the activities of the *OE TRACKER* Committee including a demonstration of the *OE TRACKER* mobile app. This was followed by Dr. Richard Castillo, Founding Dean of the University of North Carolina College of Optometric Medicine, who presented research on predictors of Optometry Board Exam performance.

Next, Dr. Jill Bryant, NBEO Executive Director; Brett Foley, PhD, NBEO Director of Psychometrics and Research; Dr. Jamie Althoff, NBEO Associate Director of Part II PAM/TMOD & LSPE and Amanda Wolkowitz, PhD, Director of Psychometrics, Data Recognitions Corporation, participated in a panel session to answer questions submitted by ARBO's members regarding the NBEO Exams. The morning concluded with a panel of Optometry Board Attorneys moderated by Dale Atkinson, Esq. Megan Borchert, JD, Assistant Attorney General in South Dakota; Rhonda Edwards, JD, Assistant Attorney General in Maryland; and Alexandra Mountain, JD, Assistant Attorney General in Minnesota, discussed legal issues in their states and answered questions from the delegates.

After lunch, Kim Navarre, MS, LMFT, Program Director, and Sheila Specker, MD, Medical Consultant, gave a presentation on the Minnesota Health Professional Services Program which promotes early intervention, diagnosis and treatment for health professionals and provides monitoring services for regulatory Boards. Next, Lindsey Franklin, JD, Legislative Liaison for the Minnesota Health Professionals Regulatory Boards discussed the legislative process and presented strategies for Regulatory Boards to engage with legislators.

The afternoon concluded with two workshops for the attendees. Dale Atkinson, Esq. discussed statutory interpretation of laws, trends in regulation, and top regulatory cases. A concurrent session was held by NBEO discussing

their planned IT upgrades and how they are improving the administration and score reporting of the exams.

Dr. Jeffery Yunker reconvened the meeting on Tuesday, June 24th. The delegates approved the 2026 budget and the resolution that had been presented. (full resolution on p. 6) Dr. Yunker then presided over the election for the Board of Directors. Dr. Lillian Wang was elected for Board of Directors Position 1 and Dr. Gerard Lozada was elected for Board of Directors Position 2.

Next, Dale Atkinson, Esq. moderated a panel that included Dr. Brian Beattie, President, North Dakota State Board of Optometry; Dr. Jill Bryant, NBEO Executive Director; Ajay Gohil, JD, Assistant Attorney General, District of Columbia; and Gregory Pruden, Executive Officer, California State Board of Optometry. The panelists responded to questions from the delegates giving their unique perspectives based on their different regulatory roles. After a short break, Dr. Jeffery Yunker reported that the Board of Directors had elected the following officers for the 2025-2026 administrative year: President: Dr. Terri Haley, Vice President: Margaret Whelan, Secretary-Treasurer: Dr. Glenn Kawaguchi.

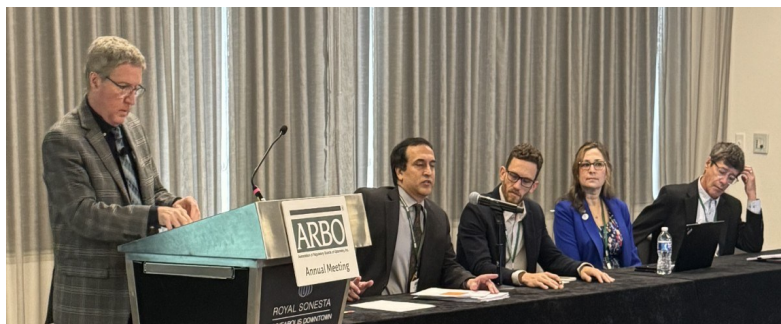
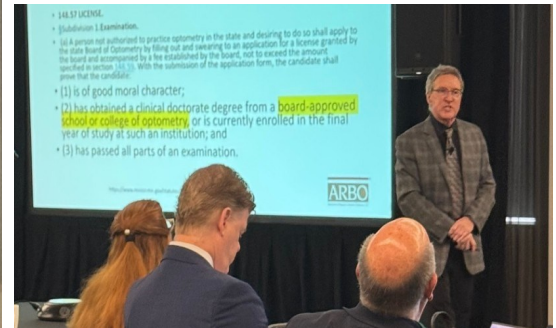

This was followed by a report on the activities of the ACOE by Dr. Timothy Petito, Chair; Dr. Julie DeKinder, Vice Chair, and Ms. Stephanie Puljak, ACOE Director.

Next, Dr. Yunker presented an award to Dr. Donovan Crouch to thank him for his many years of service to the profession of optometry. Then all ARBO past Presidents in attendance lined up to pass the gavel: Dr. Donovan Crouch (2001-2002), Dr. Robert Easton, Jr. (2006-2007), Dr. William Rafferty (2009-2010), Dr. Roger Pabst (2014-2015), Dr. Susy Yu (2015-2016), Dr. James Campbell (2019-2020), Dr. Patrick O'Neill (2020-2021), Dr. Coby Ramsey (2021-2023), Dr. Jeffery Yunker (2023-2025), Dr. Terri Haley (2025-2026).

After the passing of the gavel, newly elected President Dr. Terri Haley gave some remarks to the delegates about her plans for the next year. Dr. Yunker then thanked the delegates for coming to the meeting and the meeting was adjourned.

Annual Meeting Approved Resolution

2025 Approved Resolution Include ARBO on Member Board Meeting Agendas

WHEREAS, the Association of Regulatory Boards of Optometry (ARBO) is a 501(c)(3) not-for-profit organization recognized as exempt from federal taxation; and

WHEREAS, this tax status is based upon the purpose of ARBO providing programs and services that promote uniformity and lessen burdens on government while enhancing the effectiveness and efficiencies of optometry regulatory boards; and

WHEREAS, ARBO is a membership organization whose members (Member Boards) comprise the state, provincial, and international government boards legislatively delegated with the authority to regulate the profession of optometry in the interest of public protection; and

WHEREAS, ARBO continually strives to communicate with its Member Boards to develop and maintain their knowledge of the organization, encourage their use of offered programs and services, and seek suggestions for new programs and services within the mission of ARBO; and

WHEREAS, Member Boards publicly meet on a regular basis, during which time there is opportunity for Member Board members and staff to learn about and receive updates from ARBO; and

WHEREAS, placement of ARBO on each scheduled Member Board meeting agenda would benefit Member Boards by increasing their knowledge of ARBO and allow them to contribute ideas to ARBO for enhancing and developing programs and services for the Member Boards; and

WHEREAS ARBO Member Boards are ARBO and are encouraged to be knowledgeable about and participate in their organization.

THEREFORE, BE IT RESOLVED, that the Member Boards of ARBO will explore inclusion of ARBO on each meeting agenda to inform members, staff, and other constituents about ARBO, its programs and services, and to encourage meaningful participation in all benefits of membership; and

THEREFORE, BE IT FURTHER RESOLVED, that Member Boards inform ARBO by October 1, 2025, of the status of inclusion on Member Board meeting agendas, or if not able to include ARBO on meeting agendas, the reason why;

THEREFORE, BE IT FURTHER RESOLVED, that ARBO develop a plan for providing Member Boards with materials for use at Member Board meetings and any other support needed.

New Feature Added to the OE TRACKER Mobile App

ARBO recently added a new feature to the *OE TRACKER* mobile app to make it even more user-friendly. Now users can email, print, or save a copy of their CE course history right from the mobile app. To use the new feature, open your app and log in to your *OE TRACKER* account. Then, go to "History" at the bottom of your screen and touch the down arrow in the top right corner of your screen. Choose whether you want to print your course history, email it, or save it into a file. You can easily change the date range of your course history by touching the calendar icon in the top right corner of your screen.

The *OE TRACKER* mobile app is available for iPhones/iPads and Android phones and tablets. Simply go to the app store or to Google play and search for *OE TRACKER*. The app is free to download and is a valuable tool for optometrists to use to record and track their continuing education courses. Optometrists can also check the CE requirements for license renewal in every state and province where they are licensed and view their progress towards meeting those requirements.

CE Auditing Service for Member Boards



ARBO has a benefit for member licensing boards that you may not be aware of, CE auditing services using *OE TRACKER*. Member boards have been able to utilize various auditing reports generated from *OE TRACKER* for many years. Now, ARBO has gone a step further and will complete the audit for you. This comes after several member boards have shown an interest in doing more extensive audits, but have expressed concerns about internal resources and the amount of time it takes to complete an audit.

Included in ARBO's auditing services are a verification of state/provincial CE requirements and review of the CE hours earned by each licensee/registrant to determine if the requirements for license renewal

have been met. ARBO is also able to send deficiency notices to licensees/registrants that are not in compliance, if desired. Member boards who have utilized ARBO's auditing services include the Tennessee Board of Optometry, Louisiana State Board of Optometry, and Wyoming Board of Optometry.

Fees for ARBO's auditing service will vary depending on your jurisdiction's CE requirements, number of licensees/registrants and percentage being audited.

National Board of Examiners in Optometry Opens New Optometry Testing Center

The National Center of Clinical Testing in Optometry welcomes optometry candidates from across North America as they take licensure exams.

CHARLOTTE, NC – The [National Board of Examiners in Optometry \(NBEO\)](#), responsible for developing and administering nationwide optometry licensure exams, opened their new National Center of Clinical Testing in Optometry with a ribbon-cutting ceremony Thursday, September 5, 2025.

- Every optometry candidate in the United States must pass NBEO's exams to receive licensure to enter into clinical practice. The new National Center of Clinical Testing in Optometry will host candidates for several licensure exams, including NBEO's Part III Patient Encounters and Performance Skills (PEPS®) exam in which candidates demonstrate their case analysis and critical thinking ability in a simulated-live patient encounter. The new center includes:
