Dear Mr. Derek Adams,

You are well aware of the conclusion during the Special Meeting we had on August 05, 2016 regarding your living status here in the Native Village of Emmonak. Your allegations against you are too serious to be ignored which resulted in passing of the resolution which was handed to you after the meeting adjourned. May I remind you that, prior to our meeting, similar resolutions were passed by the Tribal Councils of the Native Village of Nuam Iqua and the Native Village of Alakanuk.

Resolution 16-17, "A Resolution of the Emmonak Tribal Council Banishing Derek William Daren Adams from the Native Village of Emmonak." did pass by votes of four (4) yes, and one (1) against.

As difficult as the decision was for the Emmonak Tribal Council to make, we did practice our sovereign governing rights to protect our members and other residents residing in our village from any danger that may befall on them.

INDIVIDUAL FROM ENTERING INTO THE PREMISES OF THE VILLAGE OF  
ALAKANUK.**

**WHEREAS**, the Alakanuk Traditional Council (COUNCIL) is a federally recognized Tribal Governing body for the Native Village of Alakanuk, Alaska; and

**WHEREAS**, the COUNCIL represents the interests of the tribal members of Alakanuk, Alaska; and

**WHEREAS**, the COUNCIL possess inherent rights to protect the peace, health, safety and general welfare of the Alakanuk tribal members and to protect the future generations of the people of Alakanuk; and

**WHEREAS**, the COUNCIL has received concerns regarding an individual that was banned from Nunam Iqua, due to severity of the crime; and

**WHEREAS**, as a result, the COUNCIL take action to banish Derrick Adams, whom is residing here in Alakanuk, immediately upon accepting this banishment notice; and

**WHEREAS**, the individual will not be allowed to enter the premises of Alakanuk village boundary for any reason, and is permanent in nature.

**NOW THEREFORE BE IT RESOLVED** that the Alakanuk Traditional Council does support this resolution in banning Derrick Adams from entering the premises of Alakanuk village boundary indefinitely.

### RESOLUTION 16-13

#### **A RESOLUTION OF THE NUNAM IQUA TRADITIONAL COUNCIL BANISHING AN INDIVIDUAL FROM ENTERING INTO THE PREMISES OF THE VILLAGE OF NUNAM IQUA**

**WHEREAS**, the Nunam Iqua Traditional Council (NITC) is a federally recognized Tribal Governing body for the Native Village of Nunam Iqua; and

**WHEREAS**, the NITC represents the best interests of the tribal members of Nunam Iqua; and

**WHEREAS**, the NITC possess inherent rights to protect the peace, health, safety and general welfare of the Nunam Iqua members and to protect the future generations of the people of Nunam Iqua; and

**WHEREAS**, the NITC has received a number of concerns regarding serious criminal activity of Derek William Daren Adams, an individual from this village; and

**WHEREAS**, Derek William Daren Adams currently has multiple protective orders against him by tribal members of Nunam Iqua; and

**WHEREAS**, the NITC has received a number of concerns that Derek William Daren Adams has threatened family members and tribal members of Nunam Iqua; and

**NOW THEREFORE BE IT RESOLVED THAT**, the NITC take action on banishment of Derek William Daren Adams of "address unknown", immediately upon accepting this banishment notice; and

**BE IT FURTHER RESOLVED**, the individual will not be allowed to enter the premises of Nunam Iqua village boundary for any reason, and is effective for ten (10) years from the date of this approved resolution.


**BE IT FURTHER RESOLVED THAT** the Nunam Iqua Traditional Council supports this resolution in banning Derek William Daren Adams from entering the premises of Nunam Iqua village boundary for ten (10) years. Determination will be made whether all requirements set by the Nunam Iqua Traditional Council are met before being allowed to return. These requirements are: 1) Derek William Daren Adams must show documentation that behavioral health treatment and anger management was completed, and 2.) commits no other criminal activities within those years.

### **CERTIFICATION**

The foregoing resolution was adopted by the Nunam Iqua Traditional Council at duly called meeting of the tribal council by a vote of 4 in favor, 0 opposed, 0 abstaining, and 1 absent on this 27<sup>th</sup> day of June, 2016.

**RESOLUTION 16-17**

**A Resolution of the Emmonak Tribal Council banishing Derek William Daren Adams  
from the Native Village of Emmonak.**

WHEREAS, the Emmonak Tribal Council is a federally recognized Tribal Governing body for the Native Village of Emmonak, Alaska; and

WHEREAS, the Emmonak Tribal Council represents the tribal members of Emmonak and is responsible for providing for the best interests of all tribal members; and

WHEREAS, the Emmonak Tribal Council is required and empowered to protect the peace, health, safety, and general welfare of the Emmonak Tribal members and to protect the future generations of the people of Emmonak; and

WHEREAS, the Emmonak Tribal Council is responsible for providing law and order and the administration of justice within the Village of Emmonak; and

WHEREAS, the Emmonak Tribal Council has developed serious concerns regarding Mr. Derek William Daren Adams as a result of the serious violent crimes of which he is accused, his threatening and aggressive behavior within the village, and the concerns of many residents who are afraid for their own safety; and

WHEREAS, Mr. Adams has been invited to present his side of the story and argue against the ban to the Tribal Council at this regularly scheduled Tribal Council meeting; and

NOW THEREFORE BE IT RESOLVED, in light of all the information presented to the Council, the Council hereby makes the following findings and conclusion:

1. The Emmonak Tribal Council has determined that Mr. Derek William Daren Adams poses an unacceptably high risk of danger to the people of Emmonak as a result of his past actions and aggressive and threatening behavior.
2. The Council believes the only way to maintain law and order and to protect the residents of Emmonak from harm is to prohibit Mr. Adams from residing in or entering into the village of Emmonak for any reason.
3. The Council hereby resolves that Mr. Adams is banned from the village of Emmonak permanently, unless and until this Resolution is revoked or replaced by a similar action of the Emmonak Tribal Council.
