Count 005

Tampering with Evidence, AS 11.56.610(a)(1)

On or about 12/24/16, at or near Anchorage, in the Third Judicial District, State of Alaska, Jaylyn Deonte Franklin (DOB: 10-24-1996), removed physical evidence with the intent to impair its verity or availability in an official proceeding or a criminal investigation.

All of which is a Class C felony offense being contrary to and in violation of AS 11.56.610(a)(1) and against the peace and dignity of the State of Alaska.

AFFIDAVIT OF DETECTIVE JAMES ESTES

I, James Estes, being first duly sworn on oath, hereby depose and state:

- A) I am a Detective employed by the Municipality of Anchorage Police Department (APD) and am presently assigned to the Homicide Unit. I am one of seven detectives assigned to the unit.
- B) I have been a Police Officer with the Anchorage Police Department since June 1999.
- C) In January 2000 I attended 43 hours of Crime Scene Investigation presented by the Anchorage Police Department.
- D) In May 2004 I attended 8 hours of training pertaining to vehicle processing, presented by the State of Alaska Scientific Crime Detection Laboratory.
- E) In August 2004 I attended 24 hours of Criminal Street Gangs presented by the Multijurisdictional Counterdrug Task Force.
- F) In March 2007 I attended 40 hours of Advance Crime Scene Investigations, presented by the Anchorage Police Department.
- G) In January 2008 I attended 8 hours of training pertaining to Documenting and Collecting Snow Impressions, presented by the State of Alaska Scientific Crime Detection Laboratory.
- H) In June 2012 I attended a 38 hour Cellebrite cell phone certification course taught by Sumuri Forensics Simplified.

- I) In August 2012 I took a 21 hour online Access Data, Bootcamp training course that covered the forensic software suite, Forensic Tool Kit (FTK).
- J) In October 2012 I took a 8 hour online Access Data, Android Examination course.
- K) In November 2012 I took a 21 hour online Access Data, Bootcamp training course that covered the forensic software suite, Forensic Tool Kit (FTK).
- L) In January 2013 I took a 21 hour online Access Data, MAC forensic training course.
- M) In April/May 2014 I attended PATCtech Digital Forensics (35 hours) Cell phone Technology & Forensic Data Recovery class and received a certification.
 - N) In July 2014 I attended a three day Social Media class, presented by the Drug and Enforcement Agency (DEA).
- 1. I make this affidavit in support of an application of an arrest warrant to establish the participation of Jaylyn Deonte Franklin (DOB: 10-24-1996). The reasons set forth in this affidavit.

INVESTIGATION OF APD CASE 16-53628

- 2. On 12/24/16 at approximately 1554 hours APD Emergency Communication Center (Dispatch) received a 911 phone call of a passerby reporting a subject that was on the ground that had just been shot. Patrol officer responded to the area and located a black male on the ground just outside of the apartment bldg. located at 4130 Peterkin Avenue. The male was suffering from what appeared to be several gunshot wounds to the body and one shot to the head. AFD medic transported the male to the Hospital. The male was pronounced dead at the Hospital a short time later.
- 3. As additional Officers responded into the area a second victim was located in the doorway of 4130 Peterkin Ave. #4. The second victim a white female was pronounced dead at the scene. The female was covered in so much blood that officers were not able to determine cause or manner of death. Officers cleared the

apartment and observed several spent casing's in the apartment.

- 4. This created APD case number 16-53628, a double homicide investigation. Officers believe the victim's to be Christopher and Danielle Brooks, husband and wife. Positive identifications have not been confirmed at this time.
- 5. Officer's on scene observed a small black male child, approximately 6-7 year male wandering close by in the parking lot. The child made a statement to officers to the effect, that "ninjas" had come into his house, told him to go into his room, and killed his family. Officers believe the child is the son of the deceased female in the door way. The child was transported to Alaska Cares for treatment and a possible interview.
- 6. Officers interviewed a witness who came forward who lives in the 200 block of N.Park, adjacent to the scene. The witness told officers that he heard shots fired. He looked out and observed 3 black males who appeared to be young running from 4130 Peterkin. The males were dressed in black. The witness stated they ran and got into what appeared to be a green Honda 4 door type vehicle that may have been a Pilot.
- 7. At approximately 1622 hours Providence Hospital called 911 reporting a male was just dropped off at the hospital with a gunshot wound. Hospital staff advised APD Dispatch that someone just dropped him off and left.
- 8. Officers responded to Providence Hospital to contact the gunshot victim. Officer CARPENTER made contact with a black male adult, DEANTHONY HARRIS (date of birth 3/31/1997). DEANTHONY stated that he was walking in Mt. View going to a relative's house. He heard an argument and looked to see a male being chased. He heard shots and then stated he (DEANTHONY) was shot in the leg. He was vague in details of the events. He was not able to describe any detail of suspect(s) or who shot him. He stated he was with his friend JAYLYN FRANKLIN. Medical staff stepped in for treatment and the interview stopped.
- 9. Officer HOOYER made contact with JAYLIN. JAYLIN stated he was with

DEANTHONY, they were in Mt. View going to the Holiday station. He heard a guy yelling for help. He observed the subject crawling up stairs being followed. That the suspect shot the victim several times. JAYLIN said that DEANTHONY went to the ground and he picked up DEANTHONY and carried him about a block to an unknown location. JAYLIN told OFC. HOOYER that an unknown light skinned black male stopped and gave them a ride to the hospital in a dark colored Suburban.

- 10. OFC. HERNANDEZ made contact with Providence Hospital security to view the security video footage that covers the drive way to the emergency room and the front of the Hospital. The video showed DEANTHONY and JAYLYN entering the parking lot on the far east side of the parking lot near the traffic light.
- 11. Officers noted that JAYLYN had blood on his hands, on his person and about his body. JAYLYN was dressed in a short sleeve white t-shirt and black sports pants bearing large white stripes down each leg. This manner of dress would not be appropriate for the current weather of 16 degrees and his statement provided to the Police. 4130 Peterkin is approximately 10 city blocks from the nearest Holiday station at Mt. View and Pine.
- 12. DET. THOMAS conducted an interview with JAYLYN FRANKLIN at the Anchorage Police Department main station. JAYLYN gave several versions of the events at 4130 Peterkin #4. He eventually settled on the following account of what occurred: JAYLYN said that he picked DEANTHONY up at work at 1300 or 1400 hours and drove (in his grandmother Ridgeline) to JANE MIRALES'S house. JAYLYN stated that when they arrived he met a male named MARCUS and another male whose name he did not know. According to JAYLYN, MARCUS asked JAYLYN and DEANTHONY if they wanted to make money, and introduced to them a plan to steal drugs and money from the victim (whose name JAYLYN did not seem to know).
- 13. JAYLYN told DET. THOMAS that they acquired t-shirts to cover their faces and gloves to wear while conducting the robbery. JAYLYN said MARCUS told them that CHRISTOPHER was expecting him to come over. JAYLYN stated that the unknown male drove them to an alleyway near the victim's house and JAYLYN, DEANTHONY, and MARUCS approached the residence on foot. JAYLYN said they stopped on the

south side of the apartment complex to cover their faces with t-shirts. JAYLYN said they went into the apartment and JAYLYN and DEANTHONY waited with DANIELLE in the living room while MARCUS took CHRISTOHPER to a back bedroom. JAYLYN said MARCUS emerged with CHRISTOPHER from the bedroom and began demanding drugs and money. JAYLYN told DET. THOMAS that CHRISTOPHER plead with MARCUS to take what he wanted while DANIELLE sat on the couch and screamed "Oh my god, oh my god..."

- 14. JAYLYN stated that CHRISTOPHER began wrestling with MARCUS and DEANTHONY appeared to try and help MARCUS in the melee. JAYLYN indicated that MARCUS was waiving the gun around and he thought MARCUS shot DEANTHONY at this point in error. JAYLYN said MARCUS shot CHRISTOPHER several times and he then shot DANIELLE from a distance of about 5 feet. JAYLYN agreed with DET. THOMAS that MARCUS probably shot DANIELLE because she was a witness. JAYLYN said they all ran out of the apartment, got into JAYLYN'S grandmother's Honda Ridgeline, and drove to the hospital, where JAYLYN helped DEANTHONY seek medical care. JAYLYN originally stated that only MARCUS had a gun. However, he modified his statement and said that DEANTHONY also had a handgun during the robbery. JAYLYN maintained that he (JAYLYN) did not have a gun during the robbery, and that MARUCS was the only person to shoot.
- 15. JAYLYN agreed to use social media in an attempt to identify MARUCS. JAYLYN used his Facebook account to look at other Facebook profiles. JAYLYN identified the profile of LAMARKUS MANN as being the person he knew as "MARCUS." OFC. WOLNIK presented a photo array to JAYLYN and JAYLYN picked LAMARKUS MANN (date of birth 7/1/1994) out of the photos. JAYLYN admitted that he deleted text messages from his cell phone related to the homicide out of fear they would be discovered.
- 16. Prior to interviewing JAYLYN, DET. THOMAS and DET. COTTLE responded to the scene to conduct a canvas of the area. DET. THOMAS and DET. COTTLE spoke with a residence who lived near the crime scene. That individual allowed DET. THOMAS and DET. COTTLE to review surveillance footage from his personal camera

system. The footage showed what appeared to be 3 black males walk north through the alley to the west of 4130 Peterkin then south and out of view behind the apartment building. The footage shows the three males then enter the victim's apartment and emerge running several minutes later out of the apartment, back to the alleyway where they came from, and then north into an alley, where they got into a Honda Ridgeline vehicle, which then drove north and out of view of the camera. The footage also showed the Honda driving around the area following a dark colored Nissan Rogue. APD databases show that LAMARKUS was cited in a black colored 2013 Nissan Rogue bearing Alaska license plates KAA337.
