THE DISTRICT ATTORNEY CHARGES:

COUNT I

That in the Third Judicial District, State of Alaska, on or about January 26, 2018, at or near Anchorage, JEREMY JORDAN TAZRUK recklessly caused physical injury to another person.

1 All of which is a class A misdemeanor offense being contrary to and in violation  
2 of AS 11.41.230(a)(1) and against the peace and dignity of the State of Alaska.

4 **COUNT II**

5 That in the Third Judicial District, State of Alaska, on or about January 26, 2018,  
6 at or near Anchorage, JEREMY JORDAN TAZRUK recklessly engaged in conduct  
7 which created a substantial risk of serious physical injury to another person.

8 All of which is a class A misdemeanor offense being contrary to and in violation  
9 of AS 11.41.250 and against the peace and dignity of the State of Alaska.

10 The undersigned swears under oath this Information is based upon a review of  
11 police report 18-3750 submitted to date.

12 On January 26, 2018 at approximately 0030 hours, APD officers were  
13 dispatched to Residential Drive. Officers found T.P. stabbed, laying down on the bike  
14 trail. Prior to finding T.P. on the bike trail, APD was dispatched to 3531 E. 42<sup>nd</sup> Ave for  
15 a physical disturbance between multiple roommates. T.P. was a roommate of JEREMY  
16 TAZRUK and multiple other people. When officers arrived, there was a bent sword on  
17 the floor next to the door and a knife on the table next to the door. There was also a  
18 broken tv on the floor next to the door and a blood napkin next to it.

19 According to witnesses and TAZRUK, T.P. began to push another roommate, D.  
20 Maupin, flipping her onto the armrest of a chair. C. Sheldon stepped in and tried to push  
21 T.P. away. T.P. then punched Sheldon. TAZRUK stepped in and his fiancé, A.  
22 Ahngsuk, who was holding their infant child. T.P. punched Ahngsuk and TAZRUK.  
23 Ahngsuk gave her child to another roommate, D. Booth, and asked Booth to call the  
24 police. TAZRUK then grabbed a Legends of Zelda replica sword from the wall and tried  
25 using the sheath to hit T.P. TAZRUK then began to use the sword on T.P. after T.P. ran  
26 at him, hitting T.P. multiple times. The edges of the sword were not sharp, but the tip  
27 was sharp. The fight escalated with Maupin, Sheldon, and T.P. TAZRUK ran to the

1 kitchen and grabbed a kitchen knife, T.P. again came at TAZRUK and TAZRUK struck  
2 out at T.P. at least twice, hitting T.P. with the knife.

3 T.P. was transported to ANMC for a puncture wound on the left side of his ribs.
