



I, Todd Moehring, an Investigator for the Alaska State Troopers attest to the following and state:

On 04/24/2018, AST was notified that Coy Bryan was found murdered at his residence in Mt. Village, AK. John Hunter, a Village Police Officer (VPO) in Mt. Village arrived at the residence to secure the scene until the Alaska State Troopers could arrive to investigate.

During the investigation, AST determined that firearms, money and a cellular phone belonging to Coy Bryan was stolen. Raymond Landlord was ultimately indicted for and admitted to murdering Coy, stealing the firearms and money; however, Raymond denied stealing Coy's cellular phone. Through electronic means, Troopers were able to determine the phone was active for a portion of the murder investigation. With the assistance of a cellular service, Troopers learned that a registered component from the cellular phone was switched from the original component that belonged to the phone under Coy's name. Records obtained from the service provider revealed the new component was associated with John Hunter.

John Hunter, while acting in the official capacity as a Village Police Officer, admitted to stealing Coy's cellular phone valued at approximately \$300 from Coy's pocket. VPO Hunter then attempted to bypass the phones security features, but was unable to defeat them. VPO Hunter then took the registered component from Coy's phone and disposed of it to keep Troopers from being able to track

the phone.

In another attempt to by-pass the security features, VPO Hunter loaded the contents from the phone onto his home computer. When he was not able to by-pass the security feature, VPO Hunter deleted the computer's contents to keep Troopers from locating any trace of the phone.

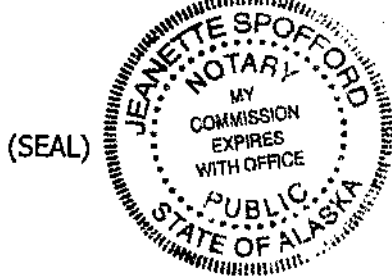
