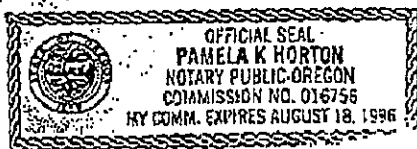

NARRATIVE:

I WAS DISPATCHED TO SACRED HEART HOSPITAL ER CONCERNING AN ASSAULT THAT HAD OCCURRED EARLIER. UPON ARRIVAL, I CONTACTED THE VICTIM [REDACTED] ALONG WITH THE WITNESS, KLEEN.

[REDACTED] SAID SHE HAD BEEN AT A PARTY EARLIER WHERE SHE AND THE SUSPECT HAD HAD A DISAGREEMENT. SHE SAID THE SUSPECT, SMITH, HAD BEEN "BOUNING ON" TO HER "ALL EVENING" AND THAT SHE HAD REBUFFED HIS ADVANCES. AS THE EVENING WORE ON, SHE SAID, SHE WENT WITH OTHERS TO 1414 ALDER #1 WHERE SMITH ALSO WENT. AT ABOUT 0200 [REDACTED] TOLD ME SHE HAD FALLEN ASLEEP ON A COUCH. SHE SAID SOMEONE SHOOK THE COUCH, WAKING HER. SHE SAW SMITH AND BELIEVING HE HAD DONE IT, SHE APPROACHED HIM AND BEGAN TO ACCUSE HIM. DURING THE ALTERCATION SHE HAD TOUCHED HIS CHEST WHICH CAUSED HIM TO GRAB HER ARMS. SHE SAID HE SUDDENLY DREW BACK AND STRUCK HER ONCE ("HE RETILY POPPED ME") IN THE LEFT EYE WITH HIS CLOSED FIST. THIS ENDED THE CONFRONTATION.

AS WE SPEAK, DR DEFRANK CLOSED THE WOUND WITH 5-6 STITCHES. SOME SWELLING WAS APPARENT. THE OTHER PERSON PRESENT, KLEEN, SAID HE SAW "THE WHOLE THING". HE CONFIRMED [REDACTED] VERSION, SAYING THAT SMITH WAS "WAY OUT OF LINE". HE SAID HE HAD GONE TO HIGH SCHOOL IN PORTLAND.

NARRATIVE:

STRIKING HER WITH HIS FIST. "WHAT WAS I SUPPOSED TO DO?" HE SAID. "I WAS WRONG. I ADMIT THAT." "I DIDN'T KNOW HOW ELSE TO HANDLE IT", SMITH SAID. HE SAID HE DIDN'T MEAN TO INJURE HER, JUST TO STOP HER.

ANOTHER PERSON IN THE ROOM, RUDICH, CLAIMED THAT HE WAS THE ONLY ONE WHO SAW THE INCIDENT BESIDES THE COMBATANTS. HE SAID HE WAS STAYING TEMPORARILY AT THE LOCATION AND NORMALLY SLEPT ON THE COUCH WHILE [REDACTED] HAD BEEN LAYING WITH THE CONSIGNMENT BEGAN. HE DENIED SHAKING THE COUCH. HE CONFIRMED SMITH'S VERSION, (WHICH WAS BASICALLY THE SAME AS EVERYONE ELSE'S) ADDING THAT HE WAS SURPRISED THAT THE BLOW DREW BLOOD.

ARREST/ISSUING: I TOLD SMITH HE WAS BEING CLEA'D. I EXPLAINED THE CITATION TO HIM, RELEASING HIM WITH A COPY. I CONTACTED [REDACTED] IN APT #4, GIVING HER A CITIZEN COMPLAINT CARD AND ADVISING HER TO CONTACT THE CITY PROSECUTOR.
