

The below news brief that was taken from today's ICE clips refers to the subject in this email string. It is too bad the clip does not talk about how ICE worked with the Multnomah County DA's office to make sure the subject received a conviction.

[OR] Man convicted of throwing semen on women set to be deported, faces more charges KATU [11/7/2017 10:55 PM, Joe Douglass, 175K, OR] reports that the man convicted of throwing semen at two Portland women is scheduled for deportation, and he faces more criminal charges. Milwaukie police said they've linked the man, (b)(6);(b)(7)(C) 48, to a case from more than two years ago. Officers said in March of 2015 (b)(6);(b)(7)(C) threw semen on a woman at the Safeway store on King Road in Milwaukie. Police said they tested its DNA but didn't get back a positive identification until after officers in Portland arrested the suspect earlier this year. In April, Portland police said (b)(6);(b)(7)(C) threw semen on a woman in the parking lot of the Safeway store on Barbur Boulevard. They said
