[OR] Man convicted of throwing semen on women set to be deported, faces more charges KATU [11/7/2017 10:55 PM, Joe Douglass, 175K, OR] reports that the man convicted of throwing semen at two Portland women is scheduled for deportation, and he faces more criminal charges. Milwaukie police said they've linked the man, (b)(6):(b)(7)(C)

48, to a case from more than two years ago. Officers said in March of 2015 [ (b)(6):(b)(7)(C) threw semen on a woman at the Safeway store on King Road in Milwaukie. Police said they tested its DNA but didn't get back a positive identification until after officers in Portland arrested the suspect earlier this year.
