This compromise agreement is made between the Defendant, Islam Rafaey Elmasry, and the injured party, Carlotta Washington, in the above-captioned matter.

The Defendant and the injured party agree as follows:

1. The Defendant was arrested for Assault in the IV Degree, and Harassment on or about the 6th day of June, 2018 in Multnomah County, Oregon.
3. The Defendant and the injured party have reached a civil compromise agreement wherein the Defendant will pay to the injured party the total sum of \$1000.00 dollars.
4. The injured party acknowledges that the injured party has received satisfaction for the injury incurred.
5. The Defendant has executed a release relieving the injured party and representatives of the State from any and all causes of action arising out of the Defendant's arrest in this case. The release is effective upon the dismissal of the Defendant's criminal charges pursuant to the Civil Compromise Agreement.

1 6. The injured party and the Defendant understand that the dismissal of
2 the criminal charges pursuant to the Civil Compromise Agreement will bar further prosecution for
3 the same crimes.

4 7. The injured party and the Defendant understand that only the Court has the power to
5 dismiss the case pursuant to the Civil Compromise Agreement

6 8. The injured party acknowledges that the injured party consents to a
7 dismissal of the Defendant's criminal charges pursuant to the Civil Compromise Agreement.

8 9. The Defendant acknowledges that the investigator for Defendant has
9 explained this Agreement to the Defendant's satisfaction.

10 10. The injured party and the Defendant acknowledge that the Civil
11 Compromise Agreement of three pages is freely, voluntarily and intelligently adopted.

12 11. Neither the Defendant nor the injured party acknowledge any liability
13 by entering into this Agreement. The Defendant and the injured party acknowledge that this Civil
14 Compromise Agreement is intended to compromise a disputed matter.

15 12. The Multnomah County District Attorney Rachna Hajari has been contacted and her
16 office has a standing objection to all Civil Compromises.

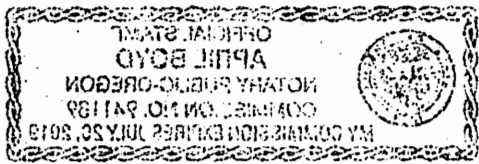

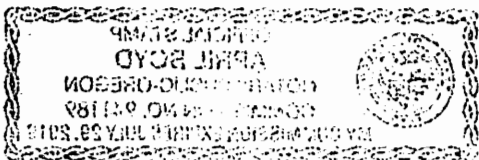
