I am aware that I have accepted unpopular clients and accepted advocacy of unpopular ideas. I have also accepted advocacy of positions that I did not personally hold as true. I did so, like most lawyers, because that is what our profession asks of us and I believe that it is through the crucible of civil debate and the forge of litigation that truth and fairness prevails. I believe in our judicial system.

Each time those conversations have sharpened my argument, improved my skills as a litigator and assisted in my representation of my client. To those of you who made those calls, I thank you for engaging in the debate and civil discourse.

To the nameless and faceless persons and their cowardly actions who attempted to harm me and my property, I say this: If your intent was to scare me, then you failed. If you knew anything about me, then you would know why. If your intent was to harm me financially, then you failed. If you knew anything about property ownership, then you would know why. If your intent was to harm strengthen my belief in our system and the honor of my profession, then you succeeded. In the past couple of days my email, voice mail and doorbell have been quite busy. Lawyers and advocates from across the country have communicated to express their support, sympathy and offer financial assistance. They have offered to clean my office, donate conference room space, office supplies and money. Attorneys I have had the most heated exchanges with have reached out to offer any and all assistance. I now, more than ever, believe in our system of dispute resolution and the professionalism of my peers.
