Joint Statement Issued by ACLU of Oregon, Basic Rights Oregon, Compassion & Choices, Forward Together, NARAL Pro-Choice Oregon Planned Parenthood Advocates of Oregon and SEIU Local 49

Portland, OR. – This week, Oregon's U.S. Senators Jeff Merkley and Ron Wyden, along with Representatives Suzanne Bonamici (D-OR-1) and Earl Blumenauer (D-OR-3), weighed in on a proposed affiliation that was recently announced between Providence Plan Partners and CareOregon.

As the state's leading advocates of affirming, quality care for women, transgender and gender-nonconforming people, and end-of life care. ACLU of Oregon, Basic Rights Oregon, Compassion & Choices, Forward Together, NARAL Pro-Choice Oregon, Planned Parenthood Advocates of Oregon, and SEIU Local 49 have issued the following statement:

"Oregon has long been a leader in ensuring that everyone has access to the full range of medical services they need to stay healthy no matter who we are, where we live, or how much money we make. We're proud to be a state where quality, affirming care for women, transgender and gender-nonconforming people is safeguarded, and where access to all end of life medical care is available.

Yet for years, Providence has been allowed to put religious views ahead of patient health, limiting access to the full range of care and impacting our ability to make personal decisions with providers that is best for our health. It's clear that this corporation is at odds with Oregon values and we are deeply concerned that a merger with CareOregon will only hurt Medicaid patients who already face barriers to healthcare.

We applaud our elected leaders for doing the right thing and standing up for our communities at a time when we need it the most. We are facing the greatest health and economic crisis of our time when no Oregonian should have to worry about whether they will be denied or restricted care.

As leading organizations who serve Oregonians at the heart of this deal, we are unified in our opposition to

this deal. We will not rest until access to care is guaranteed for all of us at risk."
