## 2021 Enrollment Form

ARVC has negotiated a one-of-a-kind combined music licensing agreement as an exclusive ARVC member benefit. It will protect your park from music copyright liability for all artists covered by ASCAP and BMI at **drastically reduced rates**. The **discounted rates** under the ARVC combined member licensing agreement are:

### 2021 ASCAP/BMI Combined Annual Licensing\*

Under 50 sites:	\$305 per year
51 – 200 Sites:	\$546 per year
201 – 400 Sites:	\$786 per year
401 – 750 Sites:	\$1,028 per year
Over 751 Sites:	\$1,477 per year

### 2021 SESAC Monthly Licensing\*

*3 month minimum required*

Under 100 sites:	\$54 per month
100 – 200 Sites:	\$78 per month
Over 201 Sites:	\$116 per month

\*Licensing fees are subject to change based on actual site count. Refunds are not given after purchase. To qualify for ARVC's discounted rates, parks must be in good standing every year with both ARVC and the licensing PRO throughout the tenure of the licensing period. Additional licensing fees may apply for events for which a hard ticket from an outside source is required for admission, any event which requires a separate admission fee of \$25 or higher, or if your park incurs annual live entertainment expenses in excess of \$5,000. If your park incurs such expenses for live entertainment, you are required to self-report and this will increase the cost of your annual license.

If you incur expenses in excess of \$5,000 for live entertainment, check this box and we will provide you with more information on additional licensing requirements.

\*\*To qualify for ARVC's discounted rates, parks must enroll in the ARVC Music License program and hold a license each year. Parks must also be in good standing with both ARVC (and state association, if applicable) and the licensing PRO throughout the tenure of the licensing period. Failure of such good standing will result in a revoked license and no refund, lapsed licenses must be paid in full prior to purchase of new license.
