Sunday and Monday - Feb. 9th, 10th & 11th.
 These spent in Burlington Iowa, in company with Rev. J. H. Culler of Newton, Ia. who has been named as a suitable missionary for this growing city. I also spent Sunday Feb. 24th in Burlington, and Bro. Culler Feb. 27th, 28th and 29th. He was joined by Rev. O. C. Miller of Cedar Rapids Ia. Chairman Adv. Board of Iowa Synod. Feb. 29th.

These visits only confirmed former convictions, that we should open a mission in Burlington, without any delay, and for the following reasons.

1. It is a growing city - the second in the great state of Iowa, with a population of 24000. largely German and Swedish. Scarcely one half of this population now attend any church.

Burlington

2. There is much of what may rightly be called Sutheran Material (though I believe any material outside the Church of Christ is as much Sutheran Material, as is Methodist or Presbyterian or anything else.)

Here are found three (3) German Churches of the United Synod of the West, or Prussian Union with Schools having in them nearly one thousand (1000) English speaking children and young people. By the admission or confession of one of the teachers they can scarcely hold them after they reach the age of fourteen.

Burlington has also a Swedish Church of seven hundred (700) members, with a very large Sunday School, every member of which understands the English language.

I preached in this Church on the 10th of Feb. to 500 people, and the pastor told me that every one present understood me as well, as they understood the Swedish sermon in the morning. He also told me that the audience was much larger than the ordinary evening audiences when he preaches in Swedish, the young people preferring the English language. In addition to these Churches, there are two (2) German Methodist, one (1) Swedish Methodist, and one (1) German Baptist Churches in Burlington, joining the efforts of other denominations to secure the people rightfully belonging to us. The middle class of people, i. e. noble mechanics and workmen of all kinds, are scarcely reached by the other Churches in Burlington.

3. The Board of Church Extension, with the aid of the Iowa Synod's special effort of One Thousand Dollars, authorize the purchase of lots at corner of 10th and Ave. St.

I enclose letter on this subject from Secy. Richards, marked A. The lots are held at \$2100.00, of which sum the Iowa Synod promise \$1000. I secured a subscription of \$300. in Burlington, and have partial promise of another \$100. Should I secure this additional \$100, the Board of Church Extension will be asked to invest only \$800. for the lots, though the deed will be made to them in full. Should I not be able to secure the additional \$100.00, in B. the B. C. S. will be asked to pay \$900.00, as \$100.00 of the \$1000.00 promised by the Iowa Synod, was paid upon me, and I want credit for it on my subscription of \$300.00 from Mr. Sauman. I did not buy the lots, as the letter

of Bro. N. asked me to do, as I wanted the endorsement of our own Board first, and feel that as he was in Ohio, he might have come on to Burlington according to arrangement, and assumed part of the responsibility. I sometimes feel that I am asked to do a good many things that rightfully belong to D. B. P. If Board of Home Missions say "Go ahead and do as Board of Home Missions request" I will buy the lots. I have written Secy D. B. H. my views of the matter, and will write him to-night, that Mr. Geo. C. Stumans (one of the owners of the lots) will be in your next week, and that they better close the bargain with him ^{then} there.

4. Mr. J. H. Culler of Newton Ga. the man selected by Adv. Board of Iowa Synod, will be ready to go to Burlington by April 15th. The amt. of appropriation required will be \$1000.00 less the sum which may be raised on the field. I believe \$200.00 can be raised in D. the first year but the Board shined above a salary of \$1000.00 and deduct amt. raised on the field. This salary will scarcely be equal to what Mr. Culler is now getting, but believing it will give them a comfortable living, he is ready to enter upon the work.

5. A Hall can be secured for the cost of fitting up - about \$100.00 - until Jan 1st 1885. This is pretty well located. A good Chapel and well located may also come into market - to be rented. I tried to see the owner - a Mrs. Scott - but she was out of the city. Main Hall - owned by the city - can probably be secured for temporary services. Work can be commenced at once, therefore. 6. We can organize with light (5) members.

In addition to these quite a number have promised to attend services, send their children, and contribute. Prominent German Merchants have manifested considerable interest, and the pastors of the Congregational and Presbyterian Churches, say "the field for the Lutheran Church is great." We must go into it however, not expecting too much - i.e. not looking for an immediate "boom". It will be slow

work perhaps, but sure. The Missionary must patiently but vigorously work and wait, and success is sure. There may be obstacles on the part of one or two of the German pastors, and opposition from the General Council, but a prudent Missionary will gain advantage from these very things. After my visit to Burlington, in August 1882, an account of which was very impudently - published in the Missy Journal. Elsevier and Crampelitz, Prof. Nelson of Louisiana College immediately spent a Sunday there, tried to alienate the Swedish pastor and people, promised to send an English minister at once &c. &c.

Up to my visit of Feb. 9th, however, he did nothing, but the Week Following again made promise of English services in the Swedish

Church. They tried to secure Rev. Petre of Philadelphia Pa. (he to preach English and Swedish Church of the Swedish emigration) but have failed. They will hinder us if they can, whether they do anything or not.

The Swedish pastor - Rev. Mr. Olander - a noble and goodly man, was very kind to me on the 10th of Feb. - offering his Church &c. &c. So also his consistory and many of his members. On the 27th however, he thought it best not to give the Church &c. &c. He was no doubt, fearful of being "admonished".

He said an "English Lutheran Church is a necessity. I so reported to the General Council Committee and they sent Prof. Weidner here, but the promise made has not been carried out. I have therefore done my part, and must now bid you "God-Speed!"

After the sermon in the German Church of Pastor John Zimmerman on the evening of Feb. 24th, he put himself upon record by commending me as the representative of the Board of the General Synod. He translated the sermon, and said many things which he will be obliged to recall, if he manifests any disposition to oppose the English Mission.

He said a Lutheran Church of the General Council he could not encourage, as their papers continually abuse the "Evangelical Synod of the West".

I presumed the thing to do, therefore is to open a Mission at Burlington Iowa - Rev. J. H. Coulter Missionary - at once, and so announce, as soon as the action is taken. This will settle the question as to the ownership of the English Lutheran Mission at Burlington, Iowa.

I rejoice to report that by the goodness of God, notwithstanding the severe winter, and, for a time, an alarming condition of health, no time whatever has been lost from the work. Since meeting with the Board in December, I have been home but two (2) Sundays. All the others having been occupied for Home Mission work, directly or indirectly. Omaha, it is true, has occupied much of the time and attention, and given me great anxiety. On the proper supplying of Omaha will depend much of our future in Nebraska.

It is the most important city to us west of Chicago. January 13, 20, 27, Feb. 3 & 17 were given to Omaha. Feb. 10th and 24th to Burlington Ia. March 2nd to Omaha. Next Sunday - March 9th - I expect to give to my own family, previous to the long

trip to Ellsworth, Bangs-city, etc.

On the 15th of Feb. Mr. Augustus Countze of N. York, telegraphed me to meet him in Omaha concerning our work there.

After an hour's talk with him, he agreed that I might not leave the present position, and promised to give me all the influence and help he can command.

He was not, however, quite ready to assume the giving of the Denver lots, as he wanted his brothers to give their share and thus be interested in the work.

He gives the Omaha Church and parsonage \$20,000.00, or one half the entire cost. I expect yet greater things, if God spare his life. He is a noble man, and seems intensely interested in our Lutheran Home Mission work. He says "Western

Head-Quarters must be at Omaha, and that a suitable house must be built or bought and presented to Board of Home Missions, as a residence for Western Secy, no matter who he may be." The Bros. Charles of Denver, Luther of New-York, and Herman of Omaha, put in the Organ - \$2500.00 to \$3000.00, and two windows (one to memory of Dr. Stebbins) costing \$500.00 each. Of course the visits to O. have been without any expense to the Board.

Correspondence has also been attended to, working parts of each day myself, and at other times dictating letters or answers to letters. Thus no time has been lost.
