II. Iowa. A. Action of Synod.

The following is the full text of the action of the Synod of Iowa, with reference to State Missionary or Superintendent: "Your committee recommend that the Advisory Board be authorized to secure, subject to the approval of the Board of Home Missions, a State Missionary, who shall work under their supervision. His duties shall be as follows: Minutes, Page 15 & 16.

1. Visiting vacant congregations, holding special services for awakening new life, and co-operating with the President in securing pastors, and of time should permit, aiding pastors in holding special services.

2. Visiting new fields organizing congregations, seeing that they are supplied with preaching, and aiding them to secure a pastor. Support.

1. He shall be allowed an annual salary of not less than \$500.00, and traveling expenses.

2. The Advisory Board shall be authorized to canvass: (A) the vacant congregations, to see how much they will give per service to the State Missionary; (B) to also canvass the Synod in general to see how much they can raise there for the support of said Missionary. 3. As soon as an amount is raised sufficient to insure a competent salary, the Advisory Board shall endeavor to secure a suitable person for said State Missionary."

If this plan can be carried out, and a suitable man be secured, it will be a great help and blessing to the work in Iowa.

The deficit on apportionment in this Synod occurs in the vacant or pastorless congregations, with but two exceptions, and there is no just cause or reason for these exceptions. I most heartily wish that, in some way or other, in the line of the Board's policy with reference to District Missionaries, we could help this state. Our present action will depend so much of our future in Iowa, that I am inclined to favor a "District Missionary" appointment and appropriation to help the above mentioned plan.

This is a noble Synod, as shown by its splendid contributions, having given an excess of \$862.16, on apportionment, and completed, in addition, its gift of \$1000.00 for Sioux City. Some Mission Contributions fell off somewhat, which is accounted for by the "Special Appeal" of 1886 having brought them up for that year, while the special visit of Bro. W.H. and Appeal of Board of Church-Extension; have brought up the contributions for Foreign Missions & Church-Extension this year.

I have no word from the Advisory Board, up to this time, as to their efforts or success in securing funds for Synodical Missionary, but presume they are making the effort, and will report in due season.

## B. Cedar Rapids.

As Bro. Robt. Hildensall was instrumental in having pastor Sipe elected, having given him a splendid reputation, and as he <sup>now</sup> wants a State Y. M. C. A. Secy. for Nebraska, I have written to a friend to suggest to him that probably Rev. A. W. Sipe, would be "just the man". It would be a great relief to Cedar Rapids to have a change. With reference to a new S. S. enterprise, I urged them to "go ahead".

Jobs will be given them, and they will need some aid, for guidance, from Board of Church Extension. In the S. School before the congregation, I held up the Suther Sunday envelopes, and urged a hearty response to our call. Also took first collection, for new Synodical year, for Home Missions, and urged faith-

III. Nebraska. A. Omaha. 1. "Kuntze Memorial". As the standing and efficiency of the Parent Church at Omaha must have an important bearing on our Sutheran work throughout the State of Nebraska, it will be gratifying to the Board of Home Missions to learn that the financial difficulties of the "Kuntze Memorial Church" have been settled, and that the building is fully completed and dedicated at an early day. Mr. Kuntze has just spent two weeks in Omaha, chiefly in the interests of our Sutheran work, and has effected a settlement of all difficulties. He has added to his already liberal gift, \$650.00. His presence, patience and Christian spirit under great import and trial, have gained a great victory for the earnest and spiritual part of the congregation, and, indeed, have added force to our entire work. Letters marked C & D, give some account of the visit, and of the great meeting on Sunday, May 6<sup>th</sup>. These results call for praise and thanksgiving.

## VIII. Indiana, A. Olive Branch Synod.

The week beginning October 23<sup>rd</sup> was a week of mishaps, accidents and delays, such as I have very seldom experienced.

The calculation for "close connections" and certain hours at certain places, was all upset by wrecked freight trains and delayed passenger trains. From Monday at 4 A.M. to Friday at 4 A.M., I was not in a bed, and had sleeping-car but part of one night. Being thus delayed I had but five hours with the brethren of the Olive Branch Synod. The convention was held in the beautiful new church of our English Mission at Richmond Ind. and, of my experience, during five hours, was any indication of the hospitality of our Lutheran people in the two congregations in that city, the clerical and lay delegates were most royally entertained.

Opportunity was given to address the synod in the afternoon, and the congregation at night, one of the members having arranged for "a fast horse" to take me to the station in ten minutes, after speaking up to 8 o'clock. I have no report of any action of the synod, as I was not present long enough to ascertain what had been done at first session, and have not learned of what was done after my leaving.

When I reached the church they were discussing a resolution to appoint "a synodical missionary". Such an appointment was earnestly advocated

I gave every opportunity to ask questions, and tried to answer them, and regretted being obliged to leave the synod at so early a stage in the proceedings.
