3. Nominee must be between the ages of 15 - 25
4. Nominee can not self nominate
5. Nominee can only be nominated for one category
6. Nominee has not previously received a RISE Award in this category
7. Nominee agrees to the nomination
8. Nominee must not be a current employee of EMCN
9. Nominee demonstrates understanding and passion towards addressing one or more social issue(s)
10. Nominee can provide examples of their work. *Supporting documents are highly encouraged. Such as portfolio of work, pictures, articles, video etc.*
11. Nominee can identify the significant impacts of their social contributions, with clear and measurable outcomes
