## **Official Rules Login to Win Giveaway**

**No purchase or transaction necessary to enter or win. A purchase or transaction will not improve your chances of winning.**

This Giveaway starts at 12:00 a.m. on June 1, 2019 and ends at 11:59 p.m. on August 31, 2019 ("Entry Period"). The sponsor of this Giveaway is Community Choice Credit Union, 31155 Northwestern Hwy, Suite 294, Farmington Hills, MI 48334 ("Sponsor"). The Giveaway shall be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor.

1) **How to enter:** You must be a member of Community Choice Credit Union to enter. Membership is subject to the Community Choice Membership Agreement, which is incorporated herein by reference. Contest entry is free of charge. All entries must be received during the applicable Entry Period. Limit three entries per primary member per Entry Period. Your contact information must be accurate in order for your entry to be eligible. Incomplete entries will be disqualified, and the Released Parties (defined below) are not responsible for entries that are lost, late, deleted, garbled, misdelivered, or misdirected as a result of technical, internet or other online difficulties. To enter by mail, mail your name, last four digits of your member number, address, and phone number to: Login to Win, Community Choice Credit Union, 31155 Northwestern Hwy, Suite 294, Farmington Hills, MI 48334. Entries must be received no later than August 31, 2019, by 11:59 p.m. EST. All received entries become the property of Sponsor and will not be returned. Sponsor will treat entry information in accordance with its privacy policy. Any attempt by any entrant to obtain more than the stated number of entries using multiple/different e-mail addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified.

2) **Eligibility:** This Giveaway is open to legal U.S. residents who are members of Community Choice Credit Union ("Members") who are 18 years of age or older as of the first day of the Entry Period. Employees and directors (and members of their immediate

household (whether or not related) of the Sponsor are not eligible to win a prize. A potential winner may be requested to provide the Sponsor with proof that the potential winner is the member associated with the winning entry and that all eligibility requirements are met.
