Reports:

Executive Director:

Tom reported the following to the board:

Kelley Elliott, our Local Foods Community Educator, who was hired to carry out the
objectives and goals of our Farmer's Market Promotion Grant has accepted another
position and her resignation is effective February 12, 2016. Tom is going to work with
the Ag staff in developing a plan going forward so that we are able to deliver the
outcomes specified in the grant. This could include a staff sharing arrangement with a
neighboring county.

- Tom attended the AMG FLSBN meeting in Penn Yan earlier this month. The FLSBN has generated over 10K in Program Generated Income for 2015 as a result of some of the lead's time have been purchased by counties that are outside of the scope of the SBN functions. Tom suggested that a threshold be established for the amount of reserves that could be carried over by the SBN. His thought is that the SBN should be operated in the most cost effective manner to the associations and once a certain level of reserves is achieved that the excess surplus past this threshold should be returned back to the associations in the form of reduced cost shares. The committee agreed and established a maximum reserve threshold of 10K per year.
- The Center for Government Research has been contracted to perform an analysis and evaluation of the SBN's across the state. This was the result of a survey that was conducted by CCE administration, in which 1/3 of the Executive Directors across the state felt that they were not getting an appropriate return on investment from their respective SBN. This was after board members expressed their concern to Director Watkins at the annual board members leadership conference that the SBN's were not worth the investment that their associations were putting into them. The belief is that the SBN's are here to stay and the CGR is going to suggest recommendations to improve the performance and efficiencies of the SBN's.
- The new Executive Director search has concluded with candidate's public presentation and interviews being conducted yesterday. A candidate was chosen by the search committee, which will be discussed in greater detail in executive session.

Public Affairs Coordinator Report:

Carla reported the following to the board:

- CCE-Steuben Board Handbook is online. To access it go to PutKnowledgeToWork.org, then About Us, then Board Member Toolbox. User name is your email and password is steubencounty2016. You can find all the general paperwork there as well as CCE information and orientation, and an archive of board minutes.
- The 2015 CCE-Steuben Annual Report was printed in the January 3 Courier, Tribune and Leader. This provided circulation to over 30,000 readers about our programming.
- For the new board members, we have a monthly E-news that goes out once a month. The February edition will be out on Monday and update our readers on the upcoming programs for February as well as topical links and resources. We have had great success with the Enews it is sent to over 2,000 people and generally has a 30% open rate, which is well above the average. In January we began a Facebook campaign with the Enews to boost awareness of the newsletter to additional people in the region. The two week

campaign results were: 8,795 people saw the ad, 209 people clicked on it, and 189 people liked, shared or commented on it.

- Our Facebook engagement has been doing very well also. During the week of December 14-20, the weekly total reach was 11.4% and people engaged were 139.1%. Our page visits for the Outdoor Show that same week were up 228%, the weekly total reach was 1,568% and people engaged were 4,440%.
- Our staff is currently working on preparing articles for the 4-H/FFA insert in the Courier and Leader. They come to us each year asking for material and print most of the 20+ stories and photos that we supply all free of charge!
- It has been three years since we began our background check program on volunteers. CCE protocol requires that we renew the checks every three years. So we are starting the campaign to renew nearly 300 volunteers. This includes board members, so an application and background screening form have been included in your materials.
- Our next big event is the Locally Grown Foods Festival to be held in Corning on February 12. A flyer has been included in the materials and we welcome board members to come attend. We have TV appearances on both WETM and WENY planned to promote the event. We are researching a topic for this year's Gala possibly under the nutrition heading with some chefs preparing local foods. We are also beginning to look ahead to our 100th anniversary celebration in February 2018. This could mean some special programming all through 2017, and we are starting to prepare a timeline for those events.
- The Southern Tier Outdoor Show finished off a successful year in 2015 with an Annual Meeting in late October. We have completed the transition to a 501 c 6 organization and held election of officers, with Tom as current President, Robert as treasurer and Carla as secretary. We are moving the finances from an account at CCE to its own bank account with Steuben Trust. An Annual Report covering last year's event is included in your materials.
- The 2016 show will be special because it is our 10th anniversary. We developed a new logo for the celebration. A mockup of the new rack card is included in your materials. We held our first planning meeting this week, and are moving forward on planning a special concert to celebrate the anniversary on the Saturday night of the event. We already have several large sponsors confirmed including Field & Stream, Tioga Downs, Steuben Trust, Hickory Hill Camping Resort, the Sausage Maker, Fins & Feathers Taxidermy and GT Hydrographics.

Program Area Reports:

- Ag & NR Program Advisory Committee the committee met last week. Tom reported the following to the board:
 - The committee conducted its annual elections as reported in the summary earlier.
 - The committee talked about Governor Cuomo announcing the release of program criteria for the \$25 million Southern Tier Agricultural Industry Enhancement Program. The eligibility requirements are now available online at www.agriculture.ny.gov. The program will provide crucial funding for projects designed to help farms and agribusinesses expand and grow their operations, as well as increase environmental enhancements in Allegany, Broome, Cattaraugus, Chautauqua, Chemung, Chenango, Delaware, Schuyler, Steuben, Tompkins and Tioga counties. Applications will be available beginning January 19, 2016.
 - The committee discussed Governor Cuomo announcing that through the Upstate Revitalization Initiative and Regional Economic Development Competition the Finger Lakes, Southern Tier and Central New York Regions were awarded \$500 Million each to help transform local economies.

• 4-H Youth Development Committee – the program committee met last week. Donna Walker reported the following:

- The committee conducted its annual elections as reported in the summary earlier.

- The committee welcomed its new members, Nicole Luckenbach and Julie Lawson.

- There was a discussion about the conflicts with the 2016 fair scheduling that was prepared by the fair board.

- The committee adopted the state leasing policy for 4-H livestock.

- The 4-H paper clover campaign organized by Tractor Supply Co. brought \$1,600 in donations to the 4-H program here in Steuben.
- Robert explained the problems they had with the 4-H van breaking down in Weedsport on the way back from Utica. He is hesitant to send 4-H kids on long trips with the van again and recommends a rental van for this type of trip. He feels comfortable with trips 1 or 2 hours away now that the van has been repaired.
- The 4-H staff updated the committee on how their after school programs were going.
- Human Ecology Committee the committee met last week. Pam Colomaio reported the following.
