**OVERNIGHT PERMISSION
YATES COUNTY FAIR 2020 - JUNIOR DEPARTMENT ANIMAL EXHIBITORS**

Yates County Junior Department rules state: Facilities are not provided for Junior Department exhibitors to stay overnight. Animal exhibitors will be allowed to stay on the grounds overnight with permission and suitable supervision. Those wishing to stay overnight with dairy, beef, horse, sheep, swine, or goat entries may do so at their own risk by registering with the 4-H Office and completing the necessary forms. Please note the additional rules below:

- ☉ The 4-H Program will not provide chaperones.
- ☉ A chaperone may only supervise up to 5 youth. Additional youth require an additional chaperone.
- ☉ All chaperones **MUST** be a registered volunteer with the Yates County 4-H Program.
- ☉ Curfew is at 11pm and chaperones are responsible for youth starting at 10pm. If youth will be out between 10 and 11pm, chaperones must be aware of their whereabouts.
- ☉ All youth staying overnight at the fair **must** have a code of conduct and medical release form on file at the 4-H office, even if your chaperone is a parent.
- ☉ 4-H members with overnight permission forms and chaperones are the only ones allowed in the 4-H animal barn between the hours of 11pm and 6am.
- ☉ **The Overnight Permission Form is due to the 4-H Office by June 5th.**
