Steuben County Fair Premiums will be withheld for the following reasons:



- 1. Failure to turn in one complete record per species shown by deadline.
- 2. Removing exhibits, including animals, from fairgrounds before release time or without written consent.
- 3. Adults preparing 4-H exhibits that the youth will be exhibiting. This includes any preparation of animal exhibits excluding: "Parents or supervising adults may assist only to the extent necessary to insure the safety of the exhibitor or the exhibit."
- 4. Not adhering to the "Code of Conduct" and "Overnight Policy" which includes sleeping in 4-H appropriate, adult supervised areas only.

Please Note 4-H Office Policy!!!!

Any items, Achievement Night items, Banquet items, Fair items, etc., left in the 4-H Office over 60 days from the date you are notified will be disposed of as the 4-H Staff deems reasonable. You will receive one phone call or email notification. It will be noted on each item the date that you were notified. Please make sure items are picked up, for you or your club, in a timely manner.

When/Where: Animal Crackers 2021 "All Creatures Great and Small" to take place virtually via Zoom on Tuesday and Thursday evenings during the month of May. There will be 8 sessions. Each session will begin at 6 pm and will last approximately 45-60 minutes. 

- Dogs must be AT LEAST six months old to be exhibited at the Steuben County Fair or the NYS Dog show

Other Information:

- Youth 5-7 years old must have an experienced adult on the lead at all times
- Participants should be prepared to clean up after their dog as necessary
- A dog in season must not be brought to 4-H events including Dog Obedience classes, the Steuben County Fair or the NYS Dog Show
- This is a great opportunity to have fun with your dog and learn about being a responsible dog owner!

Bake Sale Fundraiser Info:

The NYS Health Department office will no longer be issuing food permits for bake sales when the baked goods are prepared in private homes.

They recommend that the baked goods be prepared in a regulated kitchen.

However, you may still hold a bake sale with baked goods prepared in private homes providing that:

- The bake sale is held by a religious, fraternal or charitable organization.
- You sell only non-potentially hazardous baked goods such as cookies, cakes and pies that do not require refrigeration.

In addition, they recommend that you post a clearly visible placard at your bake sale informing consumers that food has been prepared in a kitchen that is not subject to regulation and inspection by the Health Department. For a sample placard contact the CCE Office.

They also recommend that the members of your organization avoid bare hand contact with the baked goods. This can be accomplished by using utensils, napkins, plastic gloves or similar methods.

2021 Free Fishing Days June 26-27, September 25, November 11



In an effort to connect more people to the sport of fishing, each year, there are several opportunities to fish free in New York State! During those these days, anyone can fish New York State waters, and no fishing license is required

(normally required for anyone 16 years and older). The general public can tap into the fun and relaxation of fishing, especially those who might not otherwise get the chance. All anglers are encouraged to take a friend fishing. With all that the sport has to offer, some are bound to get hooked. Since no license is

required, it is the perfect time to take a friend or relative fishing.

In addition to the June Free Fishing Days weekend, there are a number of "Free Fishing Events/Clinics" held in various locations across the state. Free Fishing Events are DEC sponsored events (such as family fishing clinics) where participants can learn about fish identification, fishing equipment and techniques, fisheries management, angling ethics and aquatic ecology. Each of DEC's nine regions can sponsor up to four free fishing events per year. Most free fishing events occur during the period from April through October. When: Tuesday, June 29th at 4 p.m.

Where: County Fairgrounds – Sale Pavilion, behind Sheep/Swine barn, Bath NY Who: 4-H members, leaders and parents are encouraged to attend. Instruction will be given on Showmanship and there will be an opportunity to practice showmanship. Information will also be given about anatomy and the NYS Fair 4-H Poultry Science and Avian Bowl Contests.

Poultry (except waterfowl, doves and pigeons) from a NY origin must test negative for Pullorum within 90 days of the county fair or originate from a US Pullorum typhoid clean flock. This includes Cloverbud members who will be bringing their poultry to the fair. Pullorum testing will start at 4:00 p.m. and is **free**.

4-H Animal Science entries for county fair including the poultry entries are due by Monday, July 26th. If you are unsure which class to enter your poultry in please call the office or plan on attending this clinic.

Rabbit and Cavy Clinic

4-H members must own their rabbits by June 15 to be eligible to show them at the Steuben County Fair. Rabbits must be at least 3 months of age to be exhibited. Rabbits' ages are computed as of the opening day of the fair, Tuesday, August 17, 2021.

When: Tuesday, June 29th at 4 p.m.

Where: County Fairgrounds – Sale Pavilion, behind the Sheep/Swine barn, Bath, NY

Why: Instruction will be given on Showmanship and there will be an opportunity to practice showmanship contest. Rabbits must have a permanent tattoo in their left ear to be able to show at the Steuben County Fair. 4-H members may bring their rabbits to the clinic where they can be total for five. The tattee number must be on the County Fair Entry. Covide do not need a narrow part tattee.

tattooed for free. The tattoo number must be on the County Fair Entry. Cavies do not need a permanent tattoo but do need an ear clip which will also be available at the clinic. There will also be information available on the parts of the rabbit and cavies, how to determine the gender of your rabbit, clipping your rabbits nails and teeth, record keeping, and information about the NYS Fair 4-H Rabbit Science and Cavy Decathlon. Regional Hippology Contest April 10 & 11 Virtual

About the contest: is a slightly slower paced, horse knowledge competition where youth complete various stations. These stations include: slides, written test, horse judging, tack ID, breeds, nutrition, parasites, confirmation, and team problem (JR/SR only)- omitted in 2021 due to virtual format. The levels for this competition are: Novice – 8 & 9 years old OR 1st year up to 14; Junior – 10-13 years of age; Senior – 14 and up. Juniors and Seniors are eligible for the State Competition if they receive qualifying scores at the Regional level.

Riding Evaluations



Any 4-H horse members who did not exhibit at Steuben County 4-H Horse Shows, riders who will be moving up from their last level exhibited (Cloverbud to walk/trot, walk/trot to novice, novice to Jr/Sr/Pony), first year drivers, and new horse/driver combinations will be required to have a riding/driving evaluation before they exhibit at the Steuben County June or July Qualifying Shows. Riding Evaluations can be done at ANY of the Open Ring Nights at the Fairgrounds (TBD). If you are unable to attend "ring nights" you will need to be evaluated PRIOR to your arrival at the Qualifying Shows with your approved riding evaluation - must be completed by 3

knowledgeable horse people who are not a parent/guardian. Your parent or legal guardian needs to be present for the evaluation and you need to bring the completed evaluation form, including your parent/guardian signature with you.

Horse Reminders:

Your project equine(s) must be registered with the county by **Friday**, **May 28**th. All the appropriate forms were included in the horse packet available online. Horses cannot participate at the shows unless this form has been submitted!

The Qualifying Horse shows are June 12, pre-entries are due Friday, May 28. The July show is July 18 and preentries are due Monday July 5th. Mark these on your calendar!

ALL County Fair entries will be due on Monday, July 26, 2021. If you show your equine at the County

Fair, you MUST turn your completed project record in by Monday, September 21, 2021 to receive your 2021 County Fair Premiums for your horse project. If you wish to exhibit your record for fair please remember to enter it by July 26th and bring your record on Sunday, August 15th to the Youth Building with the rest of your Youth Building Entries. - ALL 4-H YOUTH BUILDING EXHIBITS MUST ARRIVE AT THE FAIRGROUNDS ON SUNDAY, AUGUST 15th BETWEEN 10:00 A.M. AND 4:00 P.M.
- CLOVERBUDS: JUDGING OF YOUR YOUTH BUILDING EXHIBITS (no animals) WILL BE AUGUST 15TH FROM 1:00 P.M. TO 3:00 P.M. ON SUNDAY.
- Each Cloverbud Member is allowed to exhibit 5, 6 or 7 exhibits in the 4-H Youth Building (corresponds with age 5 year-old can bring 5 exhibits, 6 year-old 6 exhibits, etc.)

2021 Steuben County Fair Cloverbud Animal Science Projects

- Animals: Dog, Dairy Goats, Meat Goats, Poultry, Rabbit, Cavy, Swine, Sheep, Dairy Cattle, Beef Cattle, Horse
- Cloverbud Members ages 5 & 6 can exhibit <u>1 animal</u>.
- NEW FOR 2021: Cloverbud members that are 7 years old (as of January 1, 2021) can exhibit 1 large (hooved) and 1 small (non-hooved) animal at the county fair.
- Cloverbuds do not have to personally own their animal they can make arrangements to borrow one.

Entries are due to the CCE office by Monday, July 26. There needs to be someone designated on the entry form who is at least 16 years of age or older to be

with the Cloverbud at all times while at the fair and while caring for the animal or whenever an animal is being removed from its pen or stall. A parent or guardian must accompany a Cloverbud during the show.

Animals must conform to the NYS Department of Agriculture and Markets Health Requirements!

Cloverbuds will show in ONE class and receive a Cloverbud ribbon. Cloverbuds are not eligible for premiums.

Saturday, August 14, 4-H Dog Show-The cloverbud member and dog must have participated in the 4-H Dog Obedience classes. Dogs can be purebred or mixed and must be at least 6 months old. There must be an experienced adult on the lead

Tuesday, August 17, Dairy Goat Show-

with them at all times

Cloverbuds dairy goats must be purebred or recorded grade Does. Wethers, bucks and non-recorded grade Does are not eligible. Cloverbud Dairy Goats must be born on January 1, 2021 - June 15, 2021. Dairy Goats must be dehorned - Dairy Goats with horns will not be permitted to show

<u>Tuesday, August 17, Meat Goat Show – </u>

Cloverbud Meat Goats can be does or wethers and must be born January 1, 2021 – June 1, 2021. Bucks are not eligible to be shown by Cloverbuds. Meat goats can be either registered or crossbred

Animal

<u>Tuesday</u>, <u>August 17</u>, <u>Cavy Show - Cavies can be any breed and must be at least 4 months old as of opening day of the fair</u>

<u>Tuesday, August 17, Swine Show</u> – Cloverbud pigs can be either registered or crossbred gilts or barrows born between May 1st and July 1st of the current year and must be weaned

Wednesday, August 18, Dairy Showmanship – Cloverbud dairy cattle must be a junior heifer calf born March 1, 2021 - June 15, 2021

Wednesday, August 18, Sheep Show- Cloverbud lambs can be either registered or commercial ewe lambs. Cloverbud ewe lambs must be born on January 1, 2021 – June 1, 2021

<u>Wednesday</u>, <u>August 18th</u>, <u>Poultry Show</u> – Poultry or Waterfowl can be any breed and should have mature plumage and feathering.

<u>Thursday</u>, <u>August 19</u>, <u>Beef Show</u>- Beef Calves must be Junior heifer calves, feeder steers, or feeder heifer calves calved on or after January 1, 2021 –

June 1, 2021. Calves cannot be part of a cow calf pair and cannot be bull calves. Calves can be either registered or commercial

<u>Friday</u>, <u>August 20</u>, <u>Rabbit Showmanship</u>-Rabbits can be any breed and must be at least 3 months old as of opening day of the fair

<u>Friday, August 20, Horse Show</u>- Exhibitors must have shown at one of the Qualifying Shows to be eligible to show at county fair. Leadline and Walk/Jog-Walk/Trot

Please stay tuned for a Cloverbud Fairbook. It will contain valuable information to help your Cloverbud have a positive experience at the Steuben County Fair.

Cloverbuds that show animals must complete the Cloverbud animal project record and turn it in to the CCE Office by Monday, September 20 to be eligible for project completion.

Project Animal Ownership Requirements & ID Form Due Dates

- ➤ 4-H members who plan to exhibit animals at the 2021 County Fair are reminded to plan ahead to satisfy the ownership requirements.
- ➤ All animals MUST be owned or leased by the 4-H member.

June 15 – Ownership deadline for dairy goat, dairy cattle, rabbit, cavy, poultry

June 21 – Market hog, market lamb, and market goat identification & 2021 Quality Assurance Pledge for ALL Market Animals & Beef Breeding, Market Beef Jr. Prospect, Dairy Feeder – Class 1, Sheep, Swine and Meat Goats Beef Identification entries & leasing forms for Livestock Breeding animals are DUE. (Registration papers must accompany registered animals) & Grade Dairy Identification Form, Dairy Cattle leasing form, and Dairy Goat leasing forms are DUE

July 26- ALL animal entries MUST be entered in the Online County Fair Entry System

2021 Animal Identification

- ➤ It is very important that each animal is properly identified as individual identification is necessary under New York State Animal Health Requirements.
- > All animals must carry positive individual identification by USDA approved Official Identification
- ➤ All cattle and swine must be identified by official USDA 540 RFID ear tag
- > All sheep and goats must be identified by official scrapie identification
- > LIVESTOCK MARKET ANIMALS: Will need both the Steuben County 4-H tag & the RFID or scrapie tag

Leasing Show Animals for County Fair *** Leasing forms do not enter your animal in the fair.***

The non-ownership policy allows 4-H members to designate as their 4-H project animal one (beef, sheep, swine), or two (dairy cattle, goat) non-owned breeding animals. **Market animals are not eligible to be leased.** This allows the 4-H member to show the non-owned/leased animal(s) in its corresponding conformation class.

- The philosophy of Non-Ownership is to give a youngster the opportunity to experience the responsibility of caring for, and showing an animal (that he/she may not otherwise have.)
- Non-Ownership is **not** available to youth already owning an animal of that species. Youth are limited to one (beef breeding, sheep breeding, swine breeding,) and 2 (dairy cattle, goat,) non-owned animal(s) per species. The leasing agreements are between the owner of the animal and the 4-H member. Please note: For beef breeding A leased cow/calf pair is considered to be one animal. Dual designation of one animal is not permitted for dairy cattle and dairy goat. It is also recommended that for dairy and goat leased animals that they are not in the same age class so that the 4-H member can show both of them. Youth who do not own any goats are permitted two non-owned goats. Non-ownership is also available to youth already owning meat or dairy goats but is limited to one (1) leased animal of the other type. E.g. If you own a dairy goat, you

- may lease one (1) meat goat. If you own a meat goat, you may lease one (1) dairy goat.
- These non-owned animals <u>must</u> meet all regulations (i.e. registration, health, etc.) pertinent to that species. In addition, exhibitors must supply a non-ownership certificate that is available at the Cornell Cooperative Extension Office.

This certificate must be filled out, have all the proper signatures and be on file at the CCE Office by June 21 for beef, sheep, swine, meat goat, dairy cattle and dairy goat.

<u>Leasing forms do not enter your animal in the fair.</u>

To obtain the leasing form visit the forms page at www.putknowledgetowork.org or contact the CCE office.

For the 4-H member to receive county fair premiums, project completion and to be eligible to for project champion, the 4-H member must fill out a complete project record and return it to the CCE Office by Monday, September 20, 2021

Attention Goat and Sheep Members

If you are purchasing sheep and goats to use as projects, they must be purchased with the scrapie identification already in the ear. All Goats and Sheep must be identified with a USDA approved scrapie tag OR by a legible registration tattoo for goats OR a legible USDA approved flock tattoo and individual animal ID number for sheep OR a legible USDA approved herd tattoo and individual animal ID number for goats OR electronic ID for sheep and goats if the animal is enrolled in the Scrapie Flock Certification Program and/or the electronic ID is recorded on the goat's


2021 Animal Health Requirements for Admission to NYS and County Fairs

A link to the 2021 Animal Health Requirements and interstate health requirements for Admission to NYS and County Fairs can be found at https://agriculture.ny.gov/system/files/documents/2021/02/fairhealthrequirements.pdf or contact NYS Department of Ag and Markets at 518-457-3502 or contact your local veterinarian.

Please make sure you know the 2021 Health Requirements. Read the Health Requirements on the CCE website or read the County Fair Book for health regulations for each species. It is your responsibility to meet the health regulations. The regulations will be enforced for the protection of all exhibitors. If you have questions, contact the CCE Office.

All cattle, sheep, swine, and goats exhibited at County Fair must have a valid Certificate of Veterinary Inspection (CVI). For New York State Animals the CVI must be issued by an Accredited Veterinarian on or after May 1 of the current year. Each animal must be individually and positively identified on the CVI. There are no exceptions. Contact

your veterinarian to arrange for your CVI.



All sheep or goats exhibited at the Steuben County Fair, must be identified with USDA approved individual scrapie program identification.

All animals consigned to the <u>Market Animal Sale</u> must comply with all drug withdrawal requirements. If your market animal does not adhere to the proper withdrawal time when the market animal arrives to be weighed in then the market animal will not be allowed to be exhibited in its 4-H market class. *Notify your veterinarian that your animal is consigned to the sale <u>before</u> starting any drug treatment.*

State Veterinarians are responsible for reviewing all "certificates of veterinary inspection" (CVI) for compliance with state regulations and for verifying individual identification of exhibited animals presented on a valid CVI. A CVI is required for cattle (beef and dairy), goats, sheep, and swine.

Your CVI <u>must accompany</u> the animal upon arrival to the Steuben County Fairgrounds. Do not drop your animal off at the fairgrounds without the CVI with the animal. Send your CVI with your trucker if you are arriving after your animals. <u>Also it would be extremely appreciated if the 4-H member was available to present your animal to the person inspecting your CVI.</u> The person inspecting your animal must match your animal's identification to the CVI.

Soremouth in Sheep and Goats

Sheep and goats with lesions characteristic of Soremouth are not allowed to be exhibited. If evidence of soremouth is found on any sheep or goat, the entire exhibit including the affected animals shall immediately be removed from the fair premises with the holding pens cleaned and disinfected immediately after removal.

Project Record Requirement

All 4-H members who exhibit a project in the 4-H Division at the 2021 Steuben County Fair are required to turn into the CCE Office at least one record on their project by 4:30 p.m. on Monday, September 20, 2021 to be eligible to receive 2021 Fair Premiums for that project. If you fail to meet the September 20th deadline or the record is incomplete, fair premiums will NOT be awarded for that project. For example: If you are showing a market lamb and a breeding ewe then you must complete the market lamb record AND breeding ewe record to be eligible to receive your Fair Premium for each project. If you show 2 dogs you will be required to turn in 1 dog record. This is the same for all project, animal and non-animal. Note: To obtain your 4-H Project Record visit the web, or contact your 4-H leader, or stop at the CCE Office. **LATE RECORDS WILL NOT BE ACCEPTED**

Steuben County 4-H Members Participate in First Ever Ice Fishing Workshop!



Steuben 4-H's first ever ice fishing clinic took place on a blustery afternoon, on February 14 on Loon Lake in Wayland. The ice was 15+ inches thick! Ten 4-H/parent teams braved the weather and learned some basics about ice fishing. Our volunteer ice fishing experts taught the participants about ice safety and the equipment needed. Next, the whole group traveled out onto the ice and learned how to drill holes with a hand auger. Everyone was given a pole (even adults if they wanted) and some bait to put on their hooks. The introductory workshop was a huge success, with everyone interested in trying



it again! Plans were tentative to hold another workshop, but the drastic raise

in temps and change in weather has those plans postponed until next winter.

Steuben County 4-H Shooting Sports Classes Resume

4-H Shooting Sports is a comprehensive non-formal education, recreation, and competitive program focused on Positive Youth Development. 4-H Shooting Sports programing utilizes the safe and responsible use of firearms to address youth social issues related to STEM, health living, and civic engagement. In doing so, the 4-H shooting sports program provides opportunities for youth to gain valuable skills, practice leadership, and build relationships with non-parent adults. These three critical factors are the building blocks that enable youth to achieve mastery, feel a sense of belonging, explore independence, and act generously. When youth are engaged as resources worthy and capable of development, rather



than objects to be fixed, they become competent, confident, connected, caring, character driven, and contributing members of society.

Steuben County 4-H's first shooting sports class of 2021 was held in February through March at the Bath Rod & Gun Club. Eight children ranging from 8-16 took completed

the Archery 1 class. While adhering to the NYS 4-H COVID precautions, youth learned safety, how to properly handle the bows and arrows, and successfully completed the class.

Air Rifle was also offered in March at the Bath Rod & Gun Club. Seven children learned about the air rifles including how to hold them, the parts of the guns, the importance of watching your target and beyond, and so much more. All seven completed the class, and most are looking forward to other classes.



Dairy Judging Practice Session

In dairy judging, youth evaluate classes of dairy cows and heifers and then defend their placings through oral reasoning. Youth learn the dairy cow unified scorecard and major breakdowns, anatomy of the dairy cow, along with dairy judging terminology. A dairy judging practice session was held in February at Heaven Scent Farm in Bath. A total of 19 4-H'ers participated and were able to judge 3 different classes of Jersey cattle.
