The Steubenite mailing option will remain at \$15 and the Fairbook mailing option will remain at \$5 additional to the cost for those who enroll with the individual enrollment fee (\$10).

**Steuben County Fair Premiums will be withheld for the following reasons:**



- 1. Failure to turn in one complete record per species shown by deadline.**
- 2. Removing exhibits, including animals, from fairgrounds before release time or without written consent.**
- 3. Adults preparing 4-H exhibits that the youth will be exhibiting. This includes any preparation of animal exhibits excluding: “Parents or supervising adults may assist only to the extent necessary to ensure the safety of the exhibitor or the exhibit.”**
- 4. Not adhering to the “Code of Conduct” and “Overnight Policy” which includes sleeping in 4-H appropriate, adult supervised areas only.**

### **Please Note 4-H Office Policy!!!!**

Any items, Achievement Night items, Banquet items, Fair items, etc., left in the 4-H Office over 60 days from the date you are notified will be disposed of as the 4-H Staff deems reasonable. You will receive one phone call or email notification. It will be noted on each item the date that you were notified. Please make sure items are picked up, for you or your club, in a timely manner.

#### **All Creatures Great & Small**

**When/Where:** Animal Crackers 2022 “All Creatures Great and Small” to take place in-person on the Cornell Campus on Saturday, May 7, 2022. ## **2022 4-H Career Explorations Back @ Cornell**

Hosted annually by the NY State 4-H Office, nearly 500 NYS 4-H youth and chaperones attend the action-packed, three-day event, **June 28-30**, to immerse themselves in exploring their future education, career opportunities, and to experience Cornell University and campus life! The purpose of this program is to provide youth with exposure to various academic fields and potential career options, develop leadership skills, provide hands-on experience in a college setting and introduce youth to Cornell University.

Cornell faculty and graduate students conduct engaged-learning workshops in two age-specific tracks:

- UNIVERSITY U (8<sup>th</sup> grade and up as of fall of 2022)
- FOCUS FOR TEENS (10<sup>th</sup> – 12<sup>th</sup> grade as of fall of 2022)

Workshop choices for Focus for Teens participants and additional program information (event schedule) will be available soon (April 18) on the event website: <https://nys4-h.org/career-explorations>.

A limited number of youth scholarships (full and partial) are available through the NYS 4-H Office.

Registration is due to Jenny by **April 30** if you are applying for a scholarship or **May 30** if you are not applying for a scholarship. Programs fill extremely fast, be sure to register ASAP!

Steuben County 4-H members can participate for a reduced rate based on his/her 2021 completion of their Sr. Summary Report Form. If the 4-H member completed and submitted a Sr. Summary Report by the deadline and sold \$75 during the Fall Fundraiser or paid the \$75 Family Enrollment, CCE Steuben will pay \$350 for their registration. If the 4-H member did not sell \$75 during the Fall Fundraiser or pay the \$75 family enrollment, they will need to pay \$75 of their registration unless they apply and are selected for a NYS 4-H scholarship.

If a 4-H member is interested in attending, but did not complete a 2021 Sr. Summary, but did sell \$75 during the Fall Fundraiser or pay the \$75 family enrollment, Steuben 4-H will pay \$125 towards your registration fee. Youth in this case should also apply for a full or partial scholarship through the NYS 4-H Office.

If a 4-H member is interested in attending, did not complete a 2021 Sr. Summary, did not sell \$75 during the Fall Fundraiser or pay the \$75 family enrollment, Steuben 4-H will pay \$50 towards the registration fee. Youth in this case should also



apply for a full or partial scholarship through the NYS 4-H Office.

**Please note: In the event a 4-H member registers for a trip but then decides after the registration deadline not to attend, the 4-H family will be responsible for reimbursing Cornell Cooperative Extension of Steuben County any money that CCE has paid toward the trip. A documented emergency would receive consideration for excuse from this rule. Cancellations by June 10 will not be charged. Cancellations after June 10 are still responsible for a cancellation fee. **No shows are charged the \$350 in full and will not be refunded.****

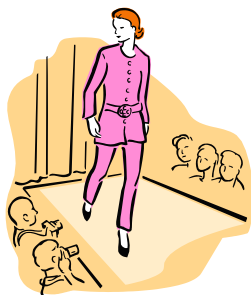

## 2022 Dairy Festival

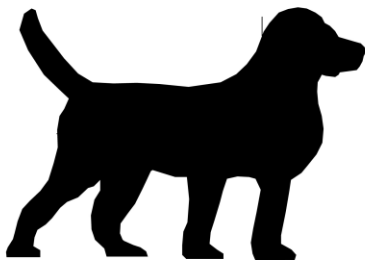

## **4-H Families Help is Requested Tractor Supply Spring Paper Clover Fundraiser April 27 – May 8**

4-H families are needed to help sell Paper Clovers. Customers at local Tractor Supply can support 4-H by purchasing paper clovers for \$1. Funds raised during this event help support various activities in Steuben's 4-H Program such as: 4-H Camp Scholarships, Capital Days trip, Career Exploration trip, curriculum, etc. Having more 4-Hers in stores during the event helps raise more money for the Steuben County 4-H Program and/or your 4-H Club. Remember, pair it up with a bake sale, petting zoo, or other activity to help get donations for your club too! As an added incentive this year, Steuben County 4-H program will give \$50 to the club that

If there are other times 4-H Clubs would like to set up a display at their store you can also contact them. Clubs would receive 4-H on Display credit if they set up a display and complete the display record.

## Bake Sale Fundraiser Info:

The NYS Health Department office will no longer be issuing food permits for bake sales when the baked goods are prepared in private homes.

They recommend that the baked goods be prepared in a regulated kitchen.

However, you may still hold a bake sale with baked goods prepared in private homes providing that:

- The bake sale is held by a religious, fraternal or charitable organization.
- You sell only non-potentially hazardous baked goods such as cookies, cakes and pies that do not require refrigeration.

In addition, they recommend that you post a clearly visible placard at your bake sale informing consumers that food has been prepared in a kitchen that is not subject to regulation and inspection by the Health Department. For a sample placard contact the CCE Office.

They also recommend that the members of your organization avoid bare hand contact with the baked goods. This can be accomplished by using utensils, napkins, plastic gloves or similar methods.

## 2022 Free Fishing Days June 25-26, September 24, November 11



In an effort to connect more people to the sport of fishing, each year, there are several opportunities to fish free in New York State! During those four days, anyone can fish New York State waters, and no fishing license is required (normally required for anyone 16 years and older). The general public can tap into the fun and relaxation of fishing, especially those who might not otherwise get the chance. All anglers are encouraged to take a friend fishing. With all that the sport has to offer, some are bound to get hooked. Since no license is and aquatic ecology. Each of DEC's nine regions can sponsor up to four free fishing events per year. Most free fishing events occur during the period

required, it is the perfect time to take a friend or relative fishing.

In addition to the June Free Fishing Days weekend, there are a number of "Free Fishing Events/Clinics" held in various locations across the state. Free Fishing Events are DEC sponsored events (such as family fishing clinics) where participants can learn about fish identification, fishing equipment and techniques, fisheries management, angling ethics

## Poultry Clinic

**Where:** County Fairgrounds – Sale Pavilion, behind Sheep/Swine barn, Bath NY

**Who:** 4-H members, leaders and parents are encouraged to attend. Instruction will be given on Showmanship and there will be an opportunity to practice showmanship. Information will also be given about anatomy and the NYS Fair 4-H Poultry Science and Avian Bowl Contests.

Poultry (except waterfowl, doves and pigeons) from a NY origin must test negative for Pullorum within 90 days of the county fair or originate from a US Pullorum typhoid clean flock. This includes Cloverbud members who will be bringing their poultry to the fair. Pullorum testing will start at 4:00 p.m. and is **free**.

**4-H Animal Science entries for county fair including the poultry entries are due by Monday, July 18<sup>th</sup>.** If you are unsure which class to enter your poultry in, please call the office or plan on attending this clinic.

## Rabbit and Cavy Clinic

**4-H members must own their rabbits by June 15 to be eligible to show them at the Steuben County Fair.** Rabbits must be at least 3 months of age to be exhibited. Rabbits' ages are computed as of the opening day of the fair, Tuesday, August 16, 2022.

**When:** TBA

**Where:** County Fairgrounds – Sale Pavilion, behind the Sheep/Swine barn, Bath, NY

**Why:** Instruction will be given on Showmanship and there will be an opportunity to practice showmanship contest. Rabbits must have a permanent tattoo in their left ear to be able to show at the Steuben County Fair. 4-H members may bring their rabbits to the clinic where they can be tattooed for free. The tattoo number must be on the County Fair Entry. Cavies do not need a permanent tattoo but do need an ear clip which will also be available at the clinic. There will also be information available on the parts of the rabbit and cavies, how to determine the gender of your rabbit, clipping your rabbits nails and teeth, record keeping, and information about the NYS Fair 4-H Rabbit Science and Cavy Decathlon. About the contest: is a slightly slower paced, horse knowledge competition where youth complete various stations. These stations include: slides, written test, horse judging, tack ID, breeds, nutrition, parasites, confirmation, and team problem (JR/SR only)- omitted in 2021 due to virtual format. The levels for this competition are: Novice – 8 & 9 years old OR 1st year up to 14; Junior – 10-13 years of age; Senior – 14 and up. Juniors and Seniors are eligible for the State Competition if they receive qualifying scores at the Regional level.

## Riding Evaluations

Any 4-H horse members who did not exhibit at Steuben County 4-H Horse Shows, riders who will be moving up from their last level exhibited (Cloverbud to walk/trot, walk/trot to novice, novice to Jr/Sr/Pony), first year drivers, and new horse/driver combinations will be required to have a riding/driving evaluation before they exhibit at the Steuben County June or July Qualifying Shows. **Riding Evaluations can be done at ANY of the Open Ring Nights at the Fairgrounds (TBD). If you are unable to attend "ring nights" you will need to be evaluated PRIOR to your arrival at the Qualifying Shows with your approved riding evaluation - must be completed by 3**

**knowledgeable horse people who are not a parent/guardian. Your parent or legal guardian needs to be present for the evaluation and you need to bring the completed evaluation form, including your parent/guardian signature with you.**

## Horse Reminders:

Your project equine(s) must be registered with the county by **Friday, May 27<sup>th</sup>**. All the appropriate forms were included in the horse packet available online. Horses cannot participate at the shows unless this form has been submitted!

The Qualifying Horse shows are **June 12**, pre-entries are due Friday, May 27. The July show is **July 17** and pre-entries are due Monday July 8<sup>th</sup>. **Mark these on your calendar!**

**ALL County Fair entries will be due on Monday, July 18, 2022.** If you show your equine at the County

Fair, you ***MUST*** turn your completed project record in by Monday, September 19, 2022 to receive your 2022 County Fair Premiums for your horse project. If you wish to exhibit your record for fair, please remember to enter it by July 18<sup>th</sup> and bring your record on Sunday, August 14<sup>th</sup> to the Youth Building with the rest of your Youth Building Entries. **One (1) 4-H Life Skills Wheel must be completed by each 4-H member to receive record completion credit – record is available online or by contacting the 4-H Office!**

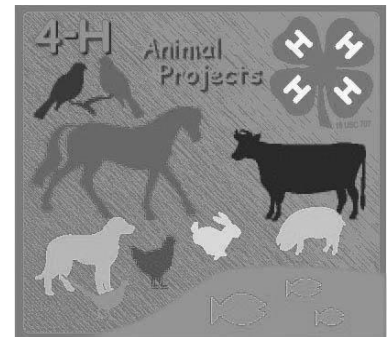

### YOUTH BUILDING

- **ALL 4-H YOUTH BUILDING EXHIBITS MUST ARRIVE AT THE FAIRGROUNDS ON SUNDAY, AUGUST 14<sup>th</sup> BETWEEN 10:00 A.M. AND 4:00 P.M.**
- **CLOVERBUDS: JUDGING OF YOUR YOUTH BUILDING EXHIBITS (no animals) WILL BE AUGUST 14<sup>TH</sup> FROM 1:00 P.M. TO 3:00 P.M. ON SUNDAY.**
- **Each Cloverbud Member is allowed to exhibit 5, 6 or 7 exhibits in the 4-H Youth Building (corresponds with age 5 year-old can bring 5 exhibits, 6 year-old 6 exhibits, etc.)**

### 2022 Steuben County Fair Cloverbud Animal Science Projects

- Animals: Dog, Dairy Goats, Meat Goats, Poultry, Rabbit, Cavy, Swine, Sheep, Dairy Cattle, Beef Cattle, Horse
- Cloverbud Members ages 5 & 6 can exhibit 1 animal.
- **Cloverbud members that are 7 years old (as of January 1, 2022) can exhibit 1 large (hooved) and 1 small (non-hooved) animal at the county fair.**
- Cloverbuds do not have to personally own their animal they can make arrangements to borrow one.



**Entries are due to the CCE office by Monday, July 18th.** There needs to be someone designated on the entry form who is at least 16 years of age or older to be with the Cloverbud at all times while at the fair and while caring for the animal or whenever an animal is being removed from its pen or stall. A parent or guardian must accompany a Cloverbud during the show.

Animals must conform to the NYS Department of Agriculture and Markets Health Requirements!

Cloverbuds will show in ONE class and receive a Cloverbud ribbon. Cloverbuds are not eligible for premiums.

**4-H Dog Show, TBA-** The Cloverbud member and dog must have participated in the 4-H Dog Obedience classes. Dogs can be purebred or mixed and must be at least 6 months old. There must be an experienced adult on the lead with them at all times

**Tuesday, August 16, Dairy Goat Show-** Cloverbuds dairy goats must be purebred or recorded grade Does. Wethers, bucks and non-recorded grade Does are not eligible. Cloverbud Dairy Goats must be born on January 1, 2022 - June 15, 2022. Dairy Goats must be dehorned - Dairy Goats with horns will not be permitted to show

**Tuesday, August 16, Meat Goat Show –** Cloverbud Meat Goats can be does or wethers and must be born January 1, 2022 – June 1, 2022. Bucks are not eligible to be shown by Cloverbuds. Meat goats can be either registered or crossbred

**Tuesday, August 16, Cavy Show -** Cavies can be any breed and must be at least 4 months old as of opening day of the fair

**Tuesday, August 16, Swine Show –** Cloverbud pigs can be either registered or crossbred gilts or barrows born between May 1<sup>st</sup> and July 1<sup>st</sup> of the current year and must be weaned



**Wednesday, August 17, Dairy Showmanship** – Cloverbud dairy cattle must be a junior heifer calf born March 1, 2022 - June 15, 2022

**Wednesday, August 17, Sheep Show-** Cloverbud lambs can be either registered or commercial ewe lambs. Cloverbud ewe lambs must be born on January 1, 2022 – June 1, 2022

**Wednesday, August 17<sup>th</sup>, Poultry Show** – Poultry or Waterfowl can be any breed and should have mature plumage and feathering.

**Thursday, August 18, Beef Show-** Beef Calves must be Junior heifer calves, feeder steers, or feeder

heifer calves calved on or after January 1, 2022 – June 1, 2022. Calves cannot be part of a cow calf pair and cannot be bull calves. Calves can be either registered or commercial

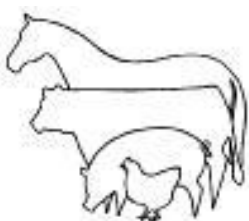
**Friday, August 19, Rabbit Showmanship**-Rabbits can be any breed and must be at least 3 months old as of opening day of the fair

**Friday, August 19, Horse Show-** Exhibitors must have shown at one of the Qualifying Shows to be eligible to show at county fair. Leadline and Walk/Jog-Walk/Trot

**Cloverbuds that show animals must complete the Cloverbud animal project record and turn it in to the CCE Office by Monday, September 19 to be eligible for project completion.**

### **Project Animal Ownership Requirements & ID Form Due Dates**



- 4-H members who plan to exhibit animals at the 2022 County Fair are reminded to plan ahead to satisfy the ownership requirements.
- All animals MUST be owned or leased by the 4-H member.

**June 1** – Ownership deadline for Beef Breeding, Market Beef Jr. Prospect Calves, Feeder Dairy Steers (Class 1), Prospect Beef Calves, Feeder Beef Heifer, Sheep, Swine & Meat Goats

**May 15** – Market Turkey

**June 15** – Ownership deadline for dairy goat, dairy cattle, rabbit, cavy, poultry

**June 20** – Market hog, market lamb, and market goat identification & 2022 Quality Assurance Pledge for ALL Market Animals & Beef Breeding, Market Beef Jr. Prospect, Dairy Feeder – Class 1, Sheep, Swine and Meat Goats Beef Identification entries & leasing forms for Livestock Breeding animals are DUE. (Registration papers must accompany registered animals) & Grade Dairy Identification Form, Dairy Cattle leasing form, and Dairy Goat leasing forms are DUE

**July 18-** ALL animal entries MUST be entered in the Online County Fair Entry System

### **2022 Animal Identification**

- It is very important that each animal is properly identified as individual identification is necessary under New York State Animal Health Requirements.

- All animals must carry positive individual identification by USDA approved Official Identification
- All cattle and swine must be identified by official USDA 540 RFID ear tag
- All sheep and goats must be identified by official scrapie identification
- **LIVESTOCK MARKET ANIMALS:** Will need both the Steuben County 4-H tag & the RFID or scrapie tag
- All forms of animal ID should be included on the CVI (Certificate of Veterinary Inspection) form

### Leasing Show Animals for County Fair

**\*\*\* Leasing forms do not enter your animal in the fair.\*\*\***



The non-ownership policy allows 4-H members to designate as their 4-H project animal one (beef, sheep, swine), or two (dairy cattle, goat) non-owned breeding animals. **Market animals are not eligible to be leased.** This allows the 4-H member to show the non-owned/leased animal(s) in its corresponding conformation class.

- The philosophy of Non-Ownership is to give a youngster the opportunity to experience the responsibility of caring for, and showing an animal (that he/she may not otherwise have.)
- Non-Ownership is **not** available to youth already owning an animal of that species. Youth are limited to **one (beef breeding, sheep breeding, swine breeding,) and 2 (dairy cattle, goat,)** non-owned animal(s) per species. The leasing agreements are between the owner of the animal and the 4-H member. *Please note: For beef breeding A leased cow/calf pair is considered to be one animal. Dual designation of one animal is not permitted for dairy cattle and dairy goat. It is also recommended that for dairy and goat leased animals that they are not in the same age class so that the 4-H member can show both of them. Youth who do not own any goats are permitted two non-owned goats. Non-ownership is also available to youth already owning meat or dairy goats but is limited to one (1) leased animal of the*

*other type. E.g. If you own a dairy goat, you may lease one (1) meat goat. If you own a meat goat, you may lease one (1) dairy goat.*

- These non-owned animals **must** meet all regulations (i.e. registration, health, etc.) pertinent to that species. In addition, exhibitors must supply a non-ownership certificate that is available at the Cornell Cooperative Extension Office.

**This certificate must be filled out, have all the proper signatures and be on file at the CCE Office by June 20 for beef, sheep, swine, meat goat, dairy cattle and dairy goat.**

**Leasing forms do not enter your animal in the fair.**

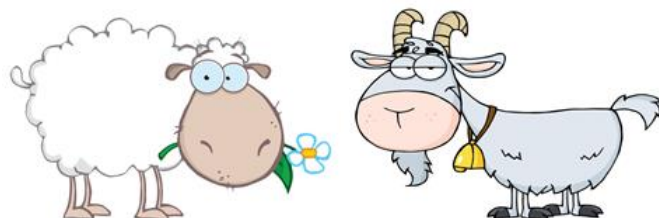

For the 4-H member to receive county fair premiums, project completion and to be eligible to for project champion, the 4-H member must fill out a complete project record and return it to the CCE Office by Monday, September 19, 2021

### Attention Goat and Sheep Members

**If you are purchasing sheep and goats to use as projects, they must be purchased with the scrapie identification already in the ear.** All Goats and Sheep must be identified with a USDA approved scrapie tag OR by a legible registration tattoo for goats OR a legible USDA approved flock tattoo and individual animal ID number for sheep OR a legible USDA approved herd tattoo and individual animal ID number for goats OR electronic ID for sheep and goats if the animal is enrolled in the Scrapie Flock Certification Program and/or the electronic ID is recorded on the goat's

## **2022 Animal Health Requirements for Admission to NYS and County Fairs**

Please make sure you know the 2022 Health Requirements. **Read the Health Requirements on the CCE website or read the County Fair Book for health regulations for each species. It is your responsibility to meet the health regulations. The regulations will be enforced for the protection of all exhibitors. If you have questions, contact the CCE Office. All cattle, sheep, swine, and goats exhibited at County Fair must have a valid Certificate of Veterinary Inspection (CVI). For New York State Animals the CVI must be issued by an Accredited Veterinarian on or after May 1 of the current year. Each animal must be individually and positively identified on the CVI. There are no exceptions. Contact your veterinarian to arrange for your CVI.**



**ALL CATTLE (beef and dairy), llamas and alpacas** regardless of age that will be exhibited at New York State County Fairs or State Fair **must be negative to an approved test appropriate to detect BVD-PI (Bovine Viral Diarrhea persistent infection).** The testing veterinarian is responsible to make sure the proper test is conducted. This is a once in a lifetime test that must be reported on the required certificate of veterinary inspection. The issuing veterinarian is responsible for verifying the validity of the test, the identification of the animal and recording the test date on the CVI. If a previous test is not verifiable the test must be repeated.

**All sheep or goats exhibited at the Steuben County Fair, must be identified with USDA approved individual scrapie program identification.**

**All animals consigned to the Market Animal Sale must comply with all drug withdrawal requirements. If your market animal does not adhere to the proper withdrawal time when the market animal arrives to be weighed in then the market animal will not be allowed to be exhibited in its 4-H market class. *Notify your veterinarian that your animal is consigned to the sale before starting any drug treatment.***

State Veterinarians are responsible for reviewing all “certificates of veterinary inspection” (CVI) for compliance with state regulations and for verifying individual identification of exhibited animals presented on a valid CVI. A CVI is required for cattle (beef and dairy), goats, sheep, and swine.

Your **CVI must accompany the animal upon arrival to the Steuben County Fairgrounds.** Do not drop your animal off at the fairgrounds without the CVI with the animal. Send your CVI with your trucker if you are arriving after your animals. **Also it would be extremely appreciated if the 4-H member was available to present your animal to the person inspecting your CVI.** The person inspecting your animal must match your animal's identification to the CVI.

### **Soremouth in Sheep and Goats**

Sheep and goats with lesions characteristic of Soremouth are not allowed to be exhibited. If evidence of soremouth is found on any sheep or goat, the entire exhibit including the affected animals shall immediately be removed from the fair premises with the holding pens cleaned and disinfected immediately after removal.

## **Project Record Requirement**

**All 4-H members who exhibit a project in the 4-H Division at the 2022 Steuben County Fair are required to turn into the CCE Office at least one record on their project by 4:30 p.m. on Monday, September 19, 2022 to be eligible to receive 2022 Fair Premiums for that project. If you fail to meet the September 19<sup>th</sup> deadline or the record is incomplete, fair premiums will NOT be awarded for that project. For example: If you are showing a market lamb and a breeding ewe then you must complete the market lamb record AND breeding ewe record to be eligible to receive your Fair Premium for each project. If you show 2 dogs you will be required to turn in 1 dog record. This is the same for all project, animal and non-animal. **Note: To obtain your 4-H Project Record visit the web, or contact your 4-H leader, or stop at the CCE Office. **\*\*LATE RECORDS WILL NOT BE ACCEPTED\*\*** MARKET ANIMAL EXHIBITORS: If you sell your animal through the 2022 4-H & FFA Market Animal Sale you are required to turn in a record for that project to be able to ID a market animal the following year.****

The ABC trip is held in the Cobleskill, New York area and is jointly sponsored by New York State 4-H and New York State Farm Bureau and includes 4-H members from throughout the state. 4-H youth explore the great diversity of agri-business related careers available in New York. Award winners may visit such businesses as a veterinary hospital, carrot farm, tree nursery, dairy farm and border collie operation. This trip also features insights into opportunities in natural resources and the academic requirements for professional positions in the agri-business world.

This year, the ABC trip was on October 22 at the Cobleskill SUNY college. During the trip I had great time learning about Cobleskill and the types of Agriculture opportunities the college has to offer to a student.
