Getting started for 2022

Throughout the year 4-H is going to offer you many opportunities to learn new things, explore new concepts, travel to new places. Some of you may do these within your clubs, others may work on things independently. To help keep you on track you may find it helpful to review the *Awards and Recognition* section of the website https://bit.ly/3G4QZOI



Project Medals, Awards and Recognition

4-H wants to recognize your accomplishments. Youth wishing to earn Project Medals need to complete specific criteria and apply for the award. The criteria should be reviewed at the start of the club year. This will give you the opportunity to work on meeting the criteria in a timely manner instead of scrambling to pull things together at the last minute. All projects, activities must be done within the <u>current 4-H year</u>. Think of showing at the Fairs as your final project. In most cases you should know if you qualify for a medal at the close of the Boonville Fair. <u>Applying for a medal should demonstrate that you have gained knowledge within that topic/subject area and shared that knowledge with others</u>. <u>Project Medals are topic/subject specific</u>. If you don't want to apply for a Project Medal consider a Personal Growth Certificate

Community Service, Creative Communications

Community Service is one of the requirements for earning a Project Medal. In some cases it may be required that your Community Service coordinates with the Project you are applying for. Example: Natural Resources wants you to do Community Service related to the environment. Click on the Green Clover to log in your Faces of 4-H Community Service projects at: http://cceoneida.com/4-h-youth-development

Creative Communications is another item that may be topic specific and is defined below. Keep in mind that if you are applying for multiple medals you cannot double dip. Example: if you taught a recycled craft project to youth, you could use that as a creative communication for Arts and Crafts or possibly Natural Resources but not for both.

CREATIVE COMMUNICATIONS EXPLAINED: 4-H understands that doing a formal Public Presentation may be overwhelming for some youth. That is why we provide alternate communication opportunities for those youth to apply and earn County Medals. The key point to remember is that the youth should be sharing their knowledge and skills with others. We would accept youth writing an article for On the Move. Creating an information poster (Must be shown and judged at the Boonville Fair) teaching others how to do a craft such as at Handmade Holidays. Fair Evaluation and Medal Interviews

Just like in the show ring, a judge may ask you questions about your animal. We have volunteers to meet with youth to evaluate/discuss your **Fair** submissions in Arts and Crafts, Food or STEM projects. We call this Face to Face Judging. Judging takes place here at CCE Oneida prior to the actual Fair. For those who have never done the Face-to-Face evaluations it may be helpful to volunteer as a runner that day. This will allow new members an opportunity to see how the process works before actually sitting down with an evaluator.

All **Medals** will require that youth meet with a volunteer to discuss the projects that they have worked on over the past year. These "interviews" are held on Columbus Day here at CCE.



The winning senior (14-19 years of age) WHEP team from each state earns the right to attend the annual National WHEP Contest, typically held the last full week of July. The national contest moves to a different state each year.

WHEP is a <u>4-H</u> and <u>FFA</u> youth natural resource program dedicated to teaching wildlife and fisheries habitat management to junior and senior level (ages 8-19) youth in the United States. 


Tracking migrations and seasons



The purpose of the 4-H Project Recognition Awards are to recognize youth for their hard work, dedication and personal development that they have achieved through their involvement in their 4-H club, projects and activities. Because youth develop and achieve in different ways, there are different levels of recognition that they can receive.

The Personal Growth Certificate Criteria

https://reg.cce.cornell.edu/4-HPGrowth2022_230

(Originally designed for Cloverbud participants but anybody can apply for a Personal Growth Certificate.)

1. Must be currently enrolled in 4-H

2. Must have completed at least 2 activities in at least one project area that the member is enrolled in.

3. Submit a reflection on what the 4-H Member learned or individual accomplishments that they achieved through their 4-H involvement. This reflection can be in written essay or story form, a picture story along with captions and descriptions of each picture or any other means that the 4-Her would like to tell their "4-H Story" maximum 4 pages. Must be received in the office by October 1st

The Outstanding Achievement Award

https://reg.cce.cornell.edu/4-Houtstanding2022_230

recognizes up to 4 youth – one from each of the following project groups (highlighted below) For outstanding work and accomplishments in their project(s).

Applicants should be applying for and earning several Project Medals to be considered for these awards.

Emphasis is placed on growth and advancement in their project area(s), as well as personal growth in terms of leadership, community service and sharing 4-H experiences with others.

Example: An Outstanding candidate should be earning several medals within the 4 different project areas.

Creative Science Environmental Science Personal Development Animal Science Or

The youth may earn an award because of outstanding accomplishments within one category.

Application due by October 1st. Face to Face Columbus Day interview required.

1. Outstanding Personal Development: Awarded 4-H Capital Days in Albany for youth 14 and older

- 2. Outstanding Creative and Environmental Science
- 3. Outstanding Animal Science

Below are examples of awards typically offered.

(2,3,4 choose one of the following): 4-H Career Explorations at Cornell University - "University U" for youth entering 8th & 9th grades, "Focus for Teens" for youth entering 10th to 12th grades. Teen Winter Weekend ages 13+, ABC Trip ages 14+, STARR ages 13+, NY State Forestry Program ages 10+). Additional youth will earn prizes and gift certificates.



APPLYING FOR PROJECT MEDALS & CERTIFICATES

The first step in applying for Recognition Awards is to verify that you have met the requirements for the awards you are applying for.

Remember: It is your responsibility to be sure that you have met the criteria for the awards you are applying for. Failure to meet the requirement may result in denial of an award. If you have any questions please contact the office. You must bring to the interview a completed copy of the criteria form. Once you have printed off and completed the criteria form you should register for the award. **DO NOT APPLY UNTIL YOU ARE SURE YOU QUALIFY**

The Project Medal Award (See list of project areas listed at right)

Recognizes 4-Hers and Cloverbuds for more concentrated effort and accomplishments in their project area(s). Specific criteria vary, but in general youth are expected to provide evidence of their achievements and growth in 4-H.

- 1. Must be currently enrolled,
- 2. Must complete a minimum number of years in a 4-H project area.

3. Must bring completed criteria forms to the interview and discuss goals, new things learned or tried, highlights of the year. Animal applicants should have knowledge on animal care, management, health records, breeding/calving, diet, income and expenses.

4. Must have completed the specified number of activities for that specific project.

5. Must have a Creative Communication and or logged in 6 hours of Community Service to Faces of 4-H (Cloverbuds do not need to complete the Community Service requirement.)

6. Project Medal recipients must complete an interview to receive an award. Application due October 1st. Interviews are held on Columbus Day.

Project Certificate

For those youth who do not want to participate in the interview process or are not available for the interview on Columbus Day, we offer a Project Certificate. The requirements are the same as the Medal except the youth must submit their accomplishments in writing to the office prior to October 1st.

PART 1: YOUTH CODE OF CONDUCT

4-H members and volunteers participating in or attending club, county, regional, district, state and national programs, activities, events, shows and contests sponsored for youth by the 4-H Youth Development Program of Cornell Cooperative Extension Oneida County are required to conduct themselves according to the following Code of Conduct.

The following are not permitted at 4-H sponsored programs, activities or events:

- Clothing promoting alcohol and other intoxicants, or displaying messages that are racist, sexist, homophobic, or any other degrading message that detrimentally impacts the dignity and respect of members of our community are never acceptable.
- Revealing clothing such as short skirts or shorts, midriff-baring tops, and sagging pants. If you are unsure about what is appropriate, contact the local CCE 4-H Educator in charge in advance.
- Illegal acts: Do not possess or use illegal drugs, tobacco products, firearms, weapons, or any harmful object with the intent to hurt others at any time. (Firearms are allowed only as part of supervised 4-H Shooting Sports programming.) Do not attend CCE or 4-H activities under the influence of alcohol or controlled substances.
- Romantic displays and sexual activities either in public or private situations
- Boys in girls' dormitory or lodging areas and girls in boys' dormitory or lodging areas
- Cheating or misrepresenting project work
- Theft, destruction or abuse of property
- Violation of an established curfew
- Unauthorized absence from program site
- Insult or put down other participants. Harassment, bullying, and other exclusionary behavior aren't acceptable.
- Carelessly or intentionally harm youth or adults in any way (verbally, mentally, physically, or emotionally)
- Other conduct deemed inappropriate for the youth development program by Cornell Cooperative Extension Oneida County staff or a 4-H volunteer leader.

If this code is violated, the following steps may be taken:

- The adult chaperone for the youth involved in the violation (extension staff or 4-H leader) will be made aware of the situation
- The parent (s) may be called, and arrangements made for transportation home at the parent's expense
- ♦ The 4-H'er may be barred from participating in 4-H
- When a violation occurs at a competitive event, 4-H members may be disqualified from the contest and may be ineligible for any awards.
 Competition in later contest may also be barred
- ♦ If any laws are violated, the case may be referred to the police

- Respect and uphold the rights and dignity of all staff, other volunteers, and all individuals who participate in CCE programs recognizing that people's values, beliefs, customs, and strengths differ
- Encourage participation of and respect for individuals of diverse backgrounds, cultures, and perspectives
- Refrain from the use of alcohol, tobacco and inappropriate language during all 4-H club meetings events and activities
- ◆ Commit no illegal or abusive act
- Report all unsafe conditions and accidents to professional Extension staff as soon as possible
- Dress in a manner that reflects a positive image of 4-H and CCE of Oneida County

PART 2: VOLUNTEER AGREEMENT

- I am aware of the terms and conditions of this agreement and agree that the provisions of this agreement do not constitute a contract, either expressed or implied, for employment between CCE and myself.
- This agreement is valid until it is terminated by CCE or by me.
