Executive Director's Report:

- SARE Grant CCE OC received a grant for \$123,449 for "tag-team educating" to include statewide educational training to assist AG producers with a variety of topics including finance, marketing, succession planning, business planning, etc. to start April 1, 2023
- > AFT Grant American Farmland trust reached out to CCE OC for continuing partnership with urban agriculture, \$10,000
- Community Foundation Grant \$10,000.00 received this will be funding to continue social/emotional educational outreach that was first started under project THRIVE.
- ➤ Herkimer County Cares reached out to CCE OC to again partner with the Herkimer County System Care grant if funding is received. Herkimer County is submitting the application.
- ➤ MVCAA is submitting a grant to provide education to families at risk and wants to partner with CCE. We should hear something in a few months.
- ➤ M&T POP Grant \$5,000.00 received. M&T is excited to support this program, POP tokens for children to purchase vegetables and fruits in the Oneida County Public Market.
- Ag Literacy Week is this week, and we will enter 140 classrooms, all the elementary schools in Oneida County, and reach 2,516 students. Volunteers will enter the classroom read the book and complete an activity.
- Farm Fest registration for schools is filled and has a waiting list. We have 530 students registered, and with the stations that is all that we can manage. Farm Fest will be held at DiNitto Farms, Marcy, NY on June 2nd.
- Delaware County Update our finance staff has been excellent in assisting Delaware County with their transition. Lori North assisting with HR. Mary Beth, Bonnie, Shelby, and Troy travel to Delaware County once a week. We reviewed the accounts receivable and payables, the grants, especially the Watershed review. We have had discussions with the new Executive Director and their Board President. The Board of Directors were not receiving the right financial information only excel or word documents. Next week we will start accounts payable and CCE OC will be paid for their time. We are the SBN lead. Acumatica, the software finance package is more transparent than the previous financial software package named ACCPAC.
- ➤ Staffing Update we have filled several new staff positions; however, we have six open positions. So, if you know of anyone, please direct them to our website. SNAP Ed resource educator, SNAP Ed administrative assistant, SBN HR lead, Social / Emotional educator, GHHI Broker, and Energy Advisor. Information is all on our website.

The 4-H Foundation, even though this is through Cornell University, we have not received any statements, so we had to close our books for 2022 without any statement from the 4H Foundation. Mary Beth will send an email requesting statement, then, secondly, we will have our auditor send a letter. If this fails and we will have to consider withdrawing the funds from the account.
