George Haffenden moved to transfer \$200,000 from liquid accounts to Northwest Bank to an 8 month CD option presented by Northwest Bank. Louis seconded the motion, 7 ayes, 0 nays.

There was discussion of the need to look at Key Bank CD rates at the July 17<sup>th</sup> meeting.

<u>Legislative Report</u> given by John Hemmer – did not discuss CCE since our last meeting. Ron Altmeter and Emily Reynolds have been interviewing county legislators to fill the spot that will be vacated by Dan Pavlock.

#### **Program Committee Reports**

- 4-H (reported by Lewis Smith & Jan Schauman)- reported that it is pre-fair prep time.
   They are findingways to connect with kids post-COVID, raised \$3,000 for projects and working to recognize all aging-out members.
- Agriculture (Ron Almeter and Jeff Miller) reported that the ag literacy program
  reacched over 3,000 students in the county, the vineyard preservation program has been
  extended, the Open Barn Door program is September 6, CDL trainings are coming up,
  CHQ Grown Farmer's Market Trail being developed, the Farmer Neighbor dinner is
  August 22.
- Master Gardeners (Dinah Hovey) 18 apprentices completed the course work, growing
  exponentially. They piloted the hybrid online/in person approach this year. They had a
  table at Earthfest at JCC, soil test reports are coming in, there are beekeeping programs in
  schools and additional programs at Southwestern Schools.
