- Recent application that were not funded include Congressionally Directed Spending (CDS) proposal for the rehabilitation of 123 Lake St; Office of Child & Family Services LEAPS RFP 4-H ASP expand coverage; and CFOC Pilot Seed to Supper (nutrition/horticulture programming)
