**Two notable updates to the animal health requirements for the 2025 fair season include:**

1. **Radio frequency identification, commonly referred to as “840 RFID tags,” for all cattle.**
2. **HPAI test for each lactating dairy heifer/cow entering any New York fair or exhibition.**

New for 2025 is emergency animal disease regulations for state and county fairs.

These regulations apply to both in state and out of state exhibitors.

This document is to help exhibitors clearly understand the additional regulations that must be met due to the ongoing Highly Pathogenic Avian Influenza (HPAI) situation occurring in both poultry and cattle.

### **NYS 4-H Horse Art Contest – Due by August 8<sup>th</sup>**

Welcome to the NYS 4-H Horse Art Contest, a celebration of creativity, passion, and the enduring spirit of 4-H youth! As an integral part of the New York State 4-H Horse program, this art contest aims to showcase the diverse talents within our community and encourage the fusion of equestrian enthusiasm with the world of art. These art pieces will be on display like static exhibits in the 4-H Youth Building, but they will be in our 4-H for Horses Barn. These pieces displayed in the building will be “judged” by the fairgoers that travel throughout the building! They will have a chance to vote for their favorites and put their votes in our ballot box! They will be voting for their favorite pieces. The top 12 pieces will be announced at the end of the fair. ### **NYS 4-H Horse Writing Contest – Due by September 1<sup>st</sup>**

#### **Goals or Intentions**

- 1) To provide an opportunity for written expression for NYS 4-H members with Equine interests.
- 2) To encourage youth to communicate their experiences and ideas in a creative manner.
- 3) To recognize youth who have creative writing talent by showcasing their ideas through writing.

#### **Eligibility**

1) Participants - Each participant must be a current 4-H club member. Participants do not need to own their own horse. 2) Divisions: a. The contest will consist of a Junior and Senior Division. i. Seniors: Youth who have reached age 14 but have not reached age 19 as of January 1. ii. Juniors: Individuals who have reached age 8 but have not reached age 14 as of January 1. iii. Cloverbuds: Are not eligible to compete in creative writing events. 3) **Note:** State winners in the **Junior Division** are ineligible for future competition in the Junior Division in the same event. Junior state creative writing winners are eligible to compete in other Junior Division creative writing events in which they have not won. State winners in a **Senior Division** competitive writing event are ineligible to compete in that same creative writing event in future years. Senior state creative writing winners are eligible to compete in other Senior Division creative writing events in which they have not won.

#### **Regulations**

- 1) Creative writing will be divided into three contest areas: Poetry, Short Stories and Essays.
- 2) Creative writing entries must be related to horses or the horse industry.
- 3) A new topic must have been developed since the previous year's contest. Any horse-related topic is acceptable.
- 4) All creative writing entries must include:
  - a. A title page with the following information: Title of work, 4-H members name, address, phone number, email address, county, and division. i. The title page will be removed before the entries are judged so that no names or identifying information will appear on the entries.
  - b. The title of the entry must also appear on the body of the paper without the participant's name, address, phone number, email address or county.
  - c. We encourage youth to submit their entries via email to Jessica Tyson so they can be saved in a box folder and shared for judging that way. But typed and printed entries will be accepted via mail if needed.

- d. An entry that is determined to have plagiarized someone else's work will be disqualified.
  - e. Creative writing entries will be judged by a committee of 2-3 judges.
  - f. Short stories will be limited to 1,000 words maximum and a minimum of 200 words for Junior short stories and 500 words for Senior short stories. A short story contains a beginning, middle, and end using a timeline.
  - g. Papers handwritten will not be accepted.

### ***RFID Tag Mandate***

#### **Notice for New York Cattle Producers**

Beginning November 5, 2024, there will be only one USDA-official tag type approved for cattle. [USDA's final rule](#) for cattle ID requires all official tags applied to cattle after November 5, 2024 to be both RFID and visually readable. [Read frequently asked questions about the final rule here.](#)

New York State will no longer be supplying silver metal National Uniform Eartagging System (NUES or 'brite') tags for use in cattle or swine when our current supply is finished.

New York State Department of Agriculture and Markets received a limited supply of 840 RFID-capable ear tags for distribution to New York Producers, Dealers and Markets through USDA Traceability Funding in Federal Budget year 2024-2025. **We have distributed all of these tags for this federal year in advance of the November 5, 2024 implementation of the new [USDA cattle traceability rule](#). We anticipate additional supply in April 2025 and will update our order forms when we have tags available.**

If they need a PIN, please share this attached document (PIN FAQ tags.pdf) with them. We can also create a PIN for them.**

### ***The Livestock Conservancy Microgrants***

The Livestock Conservancy's mission is to protect endangered livestock and poultry breeds throughout the United States from extinction.

The Conservancy provides support through the following microgrant programs:

- **National Microgrants:** This category is open to residents and organizations of the U.S. who are actively working with livestock and poultry breeds listed on the Conservation Priority List (CPL). Support will be provided through this competitive program for improvements to a variety of farm-related operations, including, but not limited to, livestock, poultry, infrastructure, processing equipment or services, milk, meat, wool and egg production and sales, agritourism, promotions and marketing. Awards typically range from \$500 – \$2,000.
- **Youth Microgrants:** This U.S.-based program provides funding for youth projects for individuals 12-18 years of age who are actively working with breeds listed on the CPL. Support will be provided through this competitive program for a farm-related operations similar to the National microgrants. Awards range from \$500 – \$2,000.
- **Breed Association Microgrants:** This program is open to U.S. based associations and clubs working with breeds listed on The Livestock Conservancy's CPL. Funds are intended to help associations and clubs improve services for their membership and conservation of their breeds. Awards are typically made to organizations in existence for at least three years, meet their state's requirements for operating as a business or corporation (no Sole Proprietors or Partnerships), and have board approval to pursue the project. Suitable expenditures of Breed Association Microgrants include, but are not limited to, marketing materials, website improvements, gene banking, software, educational events, developing strategic plans, DNA studies, flock or herd rescues.
- **Emergency Response Fund/Emergency Response Feed Grant:** Funding for emergency assistance may be available on a case-by-case basis, to rare breed stewards and organizations. Funds may be used for animal transportation, short-term housing, and in some cases short-term feed, veterinary care, and infrastructure. Awards will typically be in the range of \$500 – \$1,000 per application.

Application deadline is August 15, 2025.
