OVERNIGHT POLICY

All individuals, families, or 4-H clubs with a reason to stay overnight MUST COMPLETE THE OVERNIGHT REQUEST FORM AND RETURN IT TO THE 4-H OFFICE BY THE DATE INDICATED ON THE FRONT OF THIS FORM. Names of chaperones and exhibitors staying overnight will be posted in advance by the staff member in charge. All requests must have two signatures - that of the chaperone and the parent (or guardian). 4-H'ers must be at least 12 years of age to stay overnight, unless they are being directly supervised by a parent or guardian. A parent or guardian supervising their own children under 12 cannot act as a chaperone for other unrelated youth. Overnight meetings will be announced, and attendance is required. NO requests will be granted after July 1st.
