By signing this form, I understand and/or affirm that:

- This is my original signature.
- Wristbands and/or tickets that have been issued but lost cannot be replaced.
- Reduced-price tickets must be purchased directly from the DCF Livestock Office and can only be purchased in person by the 4-H family who requests them.
- All members of my family who will be attending the fair have watched and understood the 4-H Fair Safety Video and will abide by the information contained within.
- It is my responsibility to ensure my children are supervised at all times during the fair and have a responsible adult to go to when needed; 4-H strongly recommends that children not be allowed to go onto the main fairgrounds without adult supervision.
- Premiums will be given out on **Sunday starting at 4:00 PM and ending at 7:00 PM, behind the 4-H Exhibit Hall**, in the Café tent. Uncollected premiums can be picked up from CCEDC **by arrangement**. Premiums not collected by **December 31** of the current year will be considered a donation to the 4-H program.

The Fairgrounds has mandated that animal health papers be presented to vets and superintendents to pick up passes.

PLEASE NOTE

For a designated person to collect 4-H wristbands and 4-H tickets, the following applies:

- The form above **must be completed in full**, and signatures are required from both the adult picking up and the adult giving permission.
- It must be presented by the designated person when they collect the wristbands/tickets.
- The 4-H staff does **NOT** sell reduced-price tickets! They must be purchased directly from the DCF Livestock Office, which will only sell them to the family they are intended for. In other words, a designated person collecting 4-H tickets for others cannot purchase additional reduced-price tickets for them.
- CCEDC 4-H is **not responsible for any tickets or wristbands that are lost, misplaced, or fail to reach the intended recipient**. Once the designated person picks up and signs for the tickets or wristbands, they assume full responsibility for them until they are delivered to the family unable to pick them up.
- By signing the form authorizing a delegated person to collect wristbands/tickets on your behalf, you also affirm that all members of your family have watched and understood the 4-H Fair Safety Video and will abide by the information contained within.
