**AGREED ORDER**

This matter comes before the Court on SAINT ANTHONY HOSPITAL’S MOTION FOR TEMPORARY RESTRAINING ORDER AND PRELIMINARY INJUNCTION, the Court having jurisdiction, the parties being in agreement to the below, and the Court being fully advised on the premises, IT IS HEREBY AGREED AS FOLLOWS:

1. The Leapfrog Group will not publish, and has not directed and will not direct anyone to publish, a hospital safety grade for Saint Anthony Hospital that was scheduled to become publicly available on or about October 31, 2017 (“Fall 2017 Hospital Safety Grade”) on its website or in any other format;
2. The Leapfrog Group will not publish, and will not direct anyone to publish, new information regarding computerized physician order entries (“CPOE”) for medications for Saint Anthony Hospital in connection with Leapfrog’s 2017 Hospital Survey unless and until updated CPOE information for medications is submitted by Saint Anthony Hospital;
3. The Leapfrog Group shall provide all entities, including news or media outlets, that the Leapfrog Group previously sent a Fall 2017 Hospital Safety Grade for Saint Anthony Hospital under a “preview” period or otherwise an updated list or otherwise identify updated Fall 2017 Hospital Safety Grades that do not include any grade for Saint Anthony Hospital;
4. If any entity, including news or media outlet, asks or inquires with The Leapfrog Group about the difference generally between the “preview” grades previously sent and the new grades to be sent per Paragraph 3 above or specifically about Saint Anthony Hospital’s lack of a grade, The Leapfrog Group will indicate that there was a “discrepancy” with the data such that a “grade could not be issued”;

5. Saint Anthony's Motion for Temporary Restraining Order and Preliminary Injunction is denied as moot without prejudice to re-file;
6. This matter is set for a status conference on February 27, 2018 at 9:30 a.m. without further notice;
7. Defendant's date to answer or otherwise plead will be set at the status conference on February 27, 2018; and
8. Ropes & Gray LLP's instant motion to appear on behalf of Defendant is hereby granted.
