OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, 21 OR OLDER (EXCLUDING RESIDENTS OF PUERTO RICO, AND ALL OTHER U.S. TERRITORIES AND POSSESSIONS). VOID IN PUERTO RICO AND ALL OTHER U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED.

1) **ELIGIBILITY:** The Cost Plus World Market Australian Open Sweepstakes (the "Promotion") is open to legal residents of the fifty (50) United States and District of Columbia who are 21 years of age or older at the time of entry (excluding residents of Puerto Rico, and all other U.S. territories and possessions). Void in Puerto Rico and all other U.S. territories and possessions and where prohibited. Employees of Cost Plus World Market ("Sponsor"), Haley Miranda Group, Inc. Limit one (1) entry per person per day. You may only use one (1) email address to enter the Promotion. All entries must be received by 11:59 p.m. ET on 01/29/17 to be eligible. For the purposes of this Promotion, a day is understood to begin at 12:00 a.m. ET and end at 11:59 p.m. ET that same day. Entries received from any person or email address in excess of the above stated daily limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process will be void. In the event of a dispute as to who submitted an online entry, the authorized account holder of the email address used to participate will be deemed to be the entrant and he/she must comply with these Official Rules.
