CONTEST RULES

2014 Giftng Back Holiday Contest from Savers and Value Village

OFFICIAL RULES

The Giftng Back Holiday (“Contest”) is open only to legal residents of Canada (not including residents of Quebec), the fifty United States and the District of Columbia and who are aged 18 years or older at time of entry. Employees of Savers, LLC and their subsidiaries, affiliates, advertising and promotion agencies and their immediate family members (defined as spouse, siblings, parents and children) and/or those

living in the same household of each are not eligible to enter. Contest is subject to all applicable federal, state, provincial and local laws and regulations. Void where prohibited by law.

No purchase necessary to participate. All Submissions must be received between 9:00:00 A.M. Pacific Standard Time (PST) on November 25, 2014 and 11:59:59 P.M. PST on January 3, 2015 (“Entry Period”).

LIMIT: One (1) entry per person. Once the entry has been submitted, entrants will not be permitted under any circumstances to submit substitutions and/or new versions of their entries. 1. 1st Place Prize & Approximate Retail Value ("ARV") ("Grand Prize"): One (1) 1st place prize consisting of Visa gift cards totaling \$1,000.00 (awarded per submitter) plus a \$1,000.00 donation to nonprofit partner of winner's choice. Nonprofit must qualify as 501(c) organization in US. Charities in Canada must be registered with the Charities Directorate of the Canada Revenue Agency.
2. 2nd Place Prize & Approximate Retail Value ("ARV") ("Runner Up"): Two (2) 2nd place runner up prizes consisting of Visa gift cards totaling \$500.00 (awarded per person) plus a \$500.00 donation to a nonprofit partner of each winner's choice (awarded per person). Nonprofit must qualify as 501(c) organization in US. Charities in Canada must be registered with the Charities Directorate of the Canada Revenue Agency.

Total ARV for combined prizes: \$4,000. Gift cards are subject to Visa's terms and conditions. If winner is 18 or older as required by these Official Rules, but a minor in his or her state of residence, prize will be awarded in the name of the minor's parent or legal guardian, who must also sign all necessary documents, including releases, consents, assignments/confirmatory assignments, and affidavits. Potential winners (or any potential winner's parents or legal guardians, if winner is a minor in his or her state of residence) may be required to complete and return an Affidavit of Eligibility and, and except where prohibited by law a Liability and a Publicity Release (the "Acceptance Release") before the winning photos are publicized.
