It is with great pleasure and gratitude that I thank you on behalf of Sewa International's Sponsor a Child project. Running in its 7th year, the project has seen tremendous growth in both the geographic reach and the number of children sponsored during 2017.

Growing past 1300 beneficiaries, the project has now expanded beyond India into Nepal. In India, we serve children from Andhra Pradesh, Arunachal Pradesh, Assam, Chattisgarh, Madhya Pradesh, Jammu and Kashmir, Jharkhand, Karnataka, Manipur, and Telangana. In Nepal, we serve children who were orphaned during the 2015 Earthquake.

Sewa International continues to empower the children of the invisible poor through education We provide educational access for their education and provide them with opportunities to excel far beyond academics to develop them into well-rounded future global citizens.

I also extend my gratitude to Gayatri Yoga Center, Keiv, Ukraine, for providing seed funds to expand the SaC program; Pramod Sajja from Georgia for sponsoring 25 tribal children from Karnataka; Ananda Rajagopal who is sponsoring 18 tribal children; Shirim Foundation for sponsoring 12 children; Veerashaiva Samaj of North America, Connecticut Chapter, for sponsoring 10 tribal children; Ravi Chandra Chakinala (SaC Program Director) from New York for sponsoring 25 children and organizing the Sports for Sewa event to support more than 450 children from Telangana and Karnataka; and our 423 donors who are changing 1326 lives from all over India.

Learning Center Categories

An SaC learning center is either a private school for day scholars, a hostel dormitory for tribal children, orphans, or semi-orphans, or an after school tutoring center. All learning centers are run by charities catering to underprivileged children.

DAY SCHOOL

Beneficiaries are children of the invisible poor (subsistence farmers, village artisans, maid servants, taxi drivers, auto rickshaw drivers, construction labor, private security personnel, etc.). Benefits include a subset of tuition fee support, in-class educational equipment, bus passes, uniforms, shoes and school kits (school bag, books, labels, stationery, geometry box etc.). Each school custom tailors needed benefits appropriate for the sponsored child.

HOSTELS

Hostels dormitories housing children from rural and tribal locations are supported by SaC. The hostels are located in towns and cities 30-50 Km of the tribal areas housing children as education facilities are lacking in those communities. Benefits provided are boarding, lodging, and upkeep. Children attend the nearby Government run or private charity schools. Children from Valmikis, Chenchus, Koyas, and Gond tribes benefit through this program, as parents are unable to support them on their own. Some hostels may be part of a residential school.

TUTORING CENTERS


In some communities, such as in urban slums, children attending a Government run school need additional after-school tuition support. Charity run tutoring centers provide a safe environment for an unsupervised child especially if parents are working after the school ends. SaC supports such tutoring center expenses including instructor compensation, rent, bus passes and school kits.




Sponsorship Status

The year 2017 has been significant for the Sponsor a Child (SaC) program in terms of expansion.

A grand total of 1326 children are being supported in the year 2017. Thanks to the generous contribution of the SaC donors with 160 new children added this year. The beneficiaries include 530 tribal children, 464 rural children and 332 children from towns and cities across 10 Indian states and 4 districts of Nepal. The portfolio categorization graphs below indicates a gender balance, and, a urban, rural and tribal balance.




Genderwise Sponsorship

Children Development Activities

The learning centers supported through the SaC program provide holistic education to the sponsored children.

SaC program encourages children to participate in the co-curricular and extracurricular activities such as drawing, painting, performing arts (traditional dances, etc), and sports.

For instance, Vanavasi Kalyana Parishad, Telangana, one of the SaC primary executing partners, organizes national level sports event for the tribal children studying in hostels affiliated to Vanavasi Kalyana Parishad. Similarly, Sri Vidyaranya Avasam¹, in Telangana organizes sports events for all the schools affiliated to them. Sri Vidyaranya Avasam houses 200 tribal children and 150 underprivileged day scholars. Around 70 hostel children are sponsored through the SaC program. This school organized Sports Day on February 4, 2017. Some learning centers especially girls hostels teach jewelry making. The children make beautiful jewelry and use it for raising additional funds for their learning center. The hostel also teaches life skills such as cooking, laundry, grooming, etc. All major festivals, including the regional New Year are celebrated in the learning centers.

Learning centers in Bangalore engage the employees from IT companies to volunteer with the children. These volunteers educate the children on various career options, enrich them by conducting activities together with them, and become role models. Some employees become regular volunteers at the learning centers, which helps in keeping the center costs lower. They also conduct annual cultural fests where children participate and showcase their talent.



State Level Grade 10 Results

SaC supports children from Grade 4 to Grade 10. Children appear for the State level Grade 10 Exams as a basic requirement for further training or studies. From the SaC- supported hostels in Andhra Pradesh, Karnataka and Telangana 91 children appeared for State level Grade 10 Exams.

Of the 91 children who appeared for the Grade 10 exam, 74 children cleared and 17 children failed. Those who failed to clear this important exam often have family challenges and/or undiagnosed and unaddressable learning disabilities that is beyond the scope of the SaC program to address. However, SaC requires the Learning Centers to analyze and provide the reasons for failure in individual cases to gather data to address any systemic causes and to develop potential long-term solutions.



27 boys and 28 girls from Karnataka took the Grade 10 exam and 40 cleared the exam.




Donor - Child Information Exchange

Donor Visits

Sewa's SaC Program encourages US donors to visit the Learning Centers. Visits need to be pre-arranged by contacting the SaC US Donor relations Coordinator three weeks in advance. Our local team in India will assist the donors to ensure interaction under the strict supervision of the Learning Center personnel, in order to ensure privacy and safety of both the children and donors.

In complying with the laws and practices in the United States and India, SaC takes these privacy aspects seriously to avoid unpleasant situations for the donors and children. Sharing of personal information by the Donor to the children or to their parents is prohibited. All communication is routed through SaC Program Personnel. Personal gifts to your sponsored child is not allowed. Gifts to the Learning Centers are ok. Ballpoint pens, chocolates, and notebooks are popular gifts.

NikilisastudentatPattiAdinaranaiah school, Mudugenahalli, Chintamani Taluk, Kolar district, Karnataka, has scored 94% in the 2017 State Level Grade 10 exam. His father Srinivas B.V. and his mother Rathnamma are daily laborers. His 2 sisters - Nalinakshi and Navitha - are married.

Nikil is a very bright student and had scored consistently well throughout his schooling career. In addition, he is a talented sportsman winning the 2nd prize in county level volleyball competition.

He studied diligently for 4 hours each weekday while revising the material on the weekends with determination and perseverance. Recognizing that the family cannot afford to pay for extra out of school tutoring, his teachers arranged for free tutoring which provided the foundation for his success. He secured a total of 587 points out of a possible 625 points (93.92%), an excellent achievement for someone with his background and challenges.

This result has emboldened him to pursue his dream of becoming a doctor one day.



Going forward

With a new website in making and empowered ground staff in place, in the year 2018, Sewa's SaC Program plans to connect more donors to needy children. Regular monthly and quarterly updates through social media, and providing a calendar of events are the major activities planned for the year. Sewa International, desires a world of equality where everyone is happy, enjoying good health, and living in balance with nature.

PROGRAMS

In 2014, Sewa launched the Toilet and Hygiene project in Karnataka. Experimenting with different toilet models, Sewa was able to come up with two models with precast composites bolted on a prepared land for different situations of a sewer line or a pit. Sewa recently built 30 toilets in Varanasi rural district.

The Family Services program is Sewa's flagship program that provides emergency services, workshop series to improve family health and wellness (envelops yoga for diabetes management, acupressure etc.), and, educative seminar series for improved life in the US (living will, finance, College prep, etc.).

Sewa conducts disaster relief/rehabilitation projects such as Hurricane Harvey, Irma and Maria (2017), Tamil Nadu Flood Relief (2016), Nepal Earthquake Recovery (2015), Maharashtra Drought Relief (2013/2016), Superstorm Sandy (2012), and Pakistan Sindh Flood Relief (2012). We undertake development projects in India, Colombia, Sri Lanka, Peru, Guyana,

and Kenya. To promote volunteerism, Sewa's Get Inspired program, and the YFS Summer Internship program introduces youth to the joys of volunteering.

In 2017, across the US, our volunteers served 140,000 hours in community service projects including Family Services, Refugee Empowerment, and, Diwali Food Drive.
