Action Taken: Dr. Bangtson's license is reprimanded and conditioned as follows:

- Shall read the Federation of State Medical Boards' "Model Policy for the Use of Opioid Analgesics in the Treatment of Chronic Pain," July 2017. Respondent shall also read the "CDC Guideline for Prescribing Opioids for Chronic Pain," published by the Centers for Disease Control and Prevention, March 2016.
- Within one year of the date of this Order shall successfully complete the following pre-approved coursework:
 - Chemical dependency awareness; and
 - Medical Records Management.
- Following completion of the above referenced readings and coursework, shall write and submit a paper for review and approval by the Committee, describing what he has learned from the readings and coursework, and how he has implemented the knowledge into his practice.
- Six months following successful completion of the above-referenced coursework, shall submit to a random practice audit of his patient charts to be conducted by a representative of the Board as directed by the Committee.
- Shall maintain patient records, which reflect the patient complaint, examination, diagnosis, treatment plan, response to therapy, and medications prescribed, including refills.
- Shall document a check of the Minnesota Prescription Monitoring Program (PMP) prior to authorizing any prescriptions for controlled substances.
- May petition for reinstatement of an unconditional license no sooner than two years from the date of the Order and upon submission of satisfactory evidence of completion of the terms and conditions of this Order.
