

Response: The Glades County School District, in partnership with the parents of students enrolled in Moore Haven Elementary School and West Glades School (the two Title I schools in Glades County), will develop, implement, and evaluate the LEA Title I Parental Involvement Policy (PIP) and the LEA Plan. Glades County School District will inform parents about the LEA PIP and give instructions on how to access the PIP. Parents will be invited to meetings to provide input on the LEA PIP and LEA Plan. Hard copy dissemination of the LEA PIP and discussion during parent meetings will further educate the parents of the LEA PIP. Participants of the parental involvement committee will consist of parents and grade level teachers recommended by administration. Parents will be asked to provide input and revisions for the development of the LEA PIP during activities, meetings, and school training. Documentation of the input and revisions will be through evaluations, meeting minutes, and surveys. A hard copy format regarding how to access the LEA Title I PIP will be provided to participants. The District will ask the two Title I schools to invite all parents to attend the meetings. The invitations to parents will inform them that translators will be available during the meetings to promote participation. Transportation and childcare will be provided for Migrant parents should these two barriers prevent attendance. Parents will be asked to provide input and suggestions to develop the LEA Policy/Plan. In addition, parents will be asked to provide input and suggestions to develop the TIPA application, use of PI funds and the DIAP. Initial development meetings, focus groups, and surveys will be the basis for the parental input for the PIP. SAC meetings addressing the PIP will be documented via meeting minutes.

Parents will be included in school review and improvement by gathering their communication of the School Improvement Plans (SIPs). Parents will be encouraged to thoroughly review each school's SIP activities and goals regarding parental involvement. Parents will have access to the SIPs, the LEA Plan, and other meaningful documents to assist in creating parental involvement to increase students' academic achievement.

Glades County School District provides each school activities with translators and bilingual materials. An example of this is family literacy night. The LEA will monitor the notification process so that parents of students in both Title I schools receive information regarding parental involvement activities that are translated in a language that parents can understand, if at all feasible. 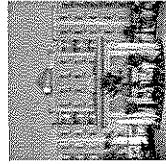
