AS EXPLAINED BELOW, WE ARE INSTRUCTING YOU NOT TO USE THE ENGINE BLOCK HEATER IN YOUR VEHICLE.

IF THE BLOCK HEATER CORD CURRENTLY INSTALLED ON YOUR VEHICLE IS PLUGGED INTO A WALL OUTLET, THIS MAY RESULT IN AN INOPERATIVE ENGINE BLOCK HEATER, TRIPPING OF HOUSEHOLD BREAKERS OR GFCI EQUIPPED OUTLETS, AND/OR A RESISTIVE SHORT.
