



## Plains All American Pipeline, L.P. and Plains GP Holdings Announce Timing of Third-Quarter 2018 Earnings & Quarterly Earnings Timing for 2019

Plains All American Pipeline, L.P. (NYSE: [PAA](#)) and Plains GP Holdings (NYSE: [PAGP](#)) announced they will release third-quarter 2018 earnings after market close on Tuesday, November 6, 2018 and will hold a joint webcast on the same day as follows:
