Expenses consist of the following:

Salary and fringe benefits for a faculty member that took on the new role as Instructional Designer to provide faculty support and curriculum development in transitioning all of our courses to an online environment.

Salary and fringe benefits for faculty member that took on the role of placing students in their supervised fieldwork remotely.

Salary and fringe benefits for 2 IT HelpDesk staff that have spent a portion of their time and effort providing online support to faculty and students since instruction delivery moved to an online environment due to the coronavirus. They support all of the open online sessions and conferences that have moved online because of coronavirus.

A portion of the College's cloud services monthly charges. This service is used to run our website which is the primary source of class information for the faculty and staff since we moved to 100% remote instruction as well as the primary portal for faculty and staff to access online courses.

Payment to vendor for online platform. Because we are 100% remote, this service was purchased to partner with our career center to create a virtual career fair for our students to meet with hiring managers.
